Mr. LINDER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

# RESOLUTION

Providing for consideration of the bill (H.R. 10) to provide for reform of the intelligence community, terrorism prevention and prosecution, border security, and international cooperation and coordination, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 10) to provide for reform of the

1 intelligence community, terrorism prevention and prosecu-  
2 tion, border security, and international cooperation and  
3 coordination, and for other purposes. The first reading of  
4 the bill shall be dispensed with. All points of order against  
5 consideration of the bill are waived. General debate shall  
6 be confined to the bill and shall not exceed three hours  
7 and 40 minutes, with 40 minutes equally divided and con-  
8 trolled by the chairman and ranking minority member of  
9 the Permanent Select Committee on Intelligence; 30 min-  
10 utes equally divided and controlled by the chairman and  
11 ranking minority member of the Committee on Armed  
12 Services; 30 minutes equally divided and controlled by the  
13 chairman and ranking minority member of the Committee  
14 on Financial Services; 30 minutes equally divided and con-  
15 trolled by the chairman and ranking minority member of  
16 the Committee on Government Reform; 30 minutes equal-  
17 ly divided and controlled by the chairman and ranking mi-  
18 nority member of the Committee on the Judiciary; 20 min-  
19 utes equally divided and controlled by the chairman and  
20 ranking minority member of the Committee on Inter-  
21 national Relations; 20 minutes equally divided and con-  
22 trolled by the chairman and ranking minority member of  
23 the Committee on Transportation and Infrastructure; and  
24 20 minutes equally divided and controlled by the chairman  
25 and ranking minority member of the Select Committee on

1 Homeland Security. After general debate the bill shall be  
2 considered for amendment under the five-minute rule. In  
3 lieu of the amendments now printed in the bill, it shall  
4 be in order to consider as an original bill for the purpose  
5 of amendment under the five-minute rule an amendment  
6 in the nature of a substitute consisting of the text of the  
7 Rules Committee Print dated October 4, 2004. That  
8 amendment in the nature of a substitute shall be consid-  
9 ered as read. All points of order against that amendment  
10 in the nature of a substitute are waived. No amendment  
11 to that amendment in the nature of a substitute shall be  
12 in order except those printed in the report of the Com-  
13 mittee on Rules accompanying this resolution. Each such  
14 amendment may be offered only in the order printed in  
15 the report, may be offered only by a Member designated  
16 in the report, shall be considered as read, shall be debat-  
17 able for the time specified in the report equally divided  
18 and controlled by the proponent and an opponent, shall  
19 not be subject to amendment, and shall not be subject to  
20 a demand for division of the question in the House or in  
21 the Committee of the Whole. All points of order against  
22 such amendments are waived. At the conclusion of consid-  
23 eration of the bill for amendment the Committee shall rise  
24 and report the bill to the House with such amendments  
25 as may have been adopted. Any Member may demand a

1 separate vote in the House on any amendment adopted  
2 in the Committee of the Whole to the bill or to the amend-  
3 ment in the nature of a substitute made in order as origi-  
4 nal text. The previous question shall be considered as or-  
5 dered on the bill and amendments thereto to final passage  
6 without intervening motion except one motion to recommit  
7 with or without instructions.

8       SEC. 2. Upon passage of H.R. 10 and receipt of a  
9 message from the Senate transmitting S. 2845: (a) the  
10 House shall be considered to have: taken from the Speak-  
11 er's table S. 2845; stricken all after the enacting clause  
12 of such bill and inserted in lieu thereof the provisions of  
13 H.R. 10, as passed by the House; passed the Senate bill  
14 as so amended; and insisted on its amendment and re-  
15 quested a conference with the Senate thereon; and (b) the  
16 Speaker may appoint conferees on S. 2845 and the House  
17 amendment thereto at any time.

18       SEC. 3. The motion to instruct conferees otherwise  
19 in order pending the appointment of conferees instead  
20 shall be in order only at a time designated by the Speaker  
21 in the legislative schedule within two additional legislative  
22 days after passage of H.R. 10.
