A BILL

To amend the Child Nutrition Act of 1966 to promote better nutrition among school children participating in the school breakfast and lunch programs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Better Nutrition for
- 5 School Children Act of 2003".
- 6 SEC. 2. FOODS OF MINIMAL NUTRITIONAL VALUE.
- 7 (a) IN GENERAL.—Section 10 of the Child Nutrition
- 8 Act of 1966 (42 U.S.C. 1779) is amended—

1	(1) in subsection (a), by inserting "(throughout
2	the entire school, including the school grounds, until
3	the end of the time of service of food under the
4	school lunch program under the Richard B. Russell
5	National School Lunch Act (42 U.S.C. 1751 et
6	seq.))" after "participating schools";
7	(2) by striking subsection (b);
8	(3) by redesignating subsection (c) as sub-
9	section (d); and
10	(4) by inserting after subsection (a) the fol-
11	lowing:
12	"(b) Basis.—The Secretary shall promulgate the
13	regulations required under subsection (a) based on sound
14	nutritional science, as determined by the Secretary.
15	"(c) Factors.—In promulgating the regulations re-
16	quired under subsection (a), the Secretary shall con-
17	sider—
18	(1) the nutritional needs of students in various
19	grade levels;
20	"(2) the proximity of any area where foods of
21	minimal nutritional value may be sold, donated, or
22	served without charge to the food service facilities or
23	areas;
24	"(3) the extent to which students will likely
25	substitute consumption of foods of minimal nutri-

- 2 schools under this Act and the Richard B. Russell
- 3 National School Lunch Act (42 U.S.C. 1751 et
- 4 seq.); and
- 5 "(4) the benefits to a school of permitting the
- 6 sale, donation, or service without charge of foods of
- 7 minimal nutritional value, including the extent to
- 8 which the proceeds of such sales inure to the benefit
- 9 of a school or an organization of students approved
- by a school.".

(b) Regulations.—

- 12 (1) IN GENERAL.—Not later than 1 year after
- the date of enactment of this Act, the Secretary of
- 14 Agriculture shall promulgate such regulations as are
- 15 necessary to implement the amendments made by
- this section.
- 17 (2) Foods of minimal nutritional
- VALUE.—In promulgating the regulations, the Sec-
- retary shall review and (as necessary) revise the def-
- inition of "foods of minimal nutritional value" that
- is used to carry out the Child Nutrition Act of 1966
- 22 (42 U.S.C. 1786) and the Richard B. Russell Na-
- tional School Lunch Act (42 U.S.C. 1751 et seq.).
- 24 (3) Procedure.—The promulgation of the reg-
- 25 ulations and the administration of the amendments

1 made by this section shall be made without regard 2 to chapter 35 of title 44, United States Code (com-3 monly known as the "Paperwork Reduction Act").

> (4) Congressional review of agency rule-Making.—In carrying out this subsection, the Secretary shall use the authority provided under section 808(2) of title 5, United States Code.
