A BILL

To reauthorize the Consumer Product Safety Commission, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Consumer Product
- 5 Safety Commission Reauthorization Act of 2003".
- 6 SEC. 2. AUTHORIZATION OF APPROPRIATIONS.
- 7 Section 32(a) of the Consumer Product Safety Act
- 8 (15 U.S.C. 2081(a)) is amended by striking paragraphs
- 9 (1) and (2) and inserting the following:
- 10 "(1) \$60,000,000 for fiscal year 2004;

- 1 "(2) \$66,800,000 for fiscal year 2005;
- (3) \$70,100,000 for fiscal year 2006; and
- 3 "(4) \$73,600,000 for fiscal year 2007.".

4 SEC. 3. FTE STAFFING LEVELS.

- 5 Section 4(g) of the Consumer Product Safety Act (15
- 6 U.S.C. 2053(g)) is amended by adding at the end the fol-
- 7 lowing:
- 8 "(5) The Commission is authorized to hire and
- 9 maintain a full time equivalent staff of 471 persons
- in each of fiscal years 2004 through 2007.".

11 SEC. 4. EXECUTIVE DIRECTOR AND OFFICERS.

- So much of section 4(g) of the Consumer Product
- 13 Safety Act (15 U.S.C. 2053(g) as precedes paragraph (2)
- 14 is amended to read as follows:
- 15 "(g) Executive Director; Officers and Em-
- 16 PLOYEES.—(1)(A) The Chairman, subject to the approval
- 17 of the Commission, shall appoint as officers of the Com-
- 18 mission an Executive Director, a General Counsel, an As-
- 19 sociate Executive Director for Engineering Sciences, an
- 20 Associate Executive Director for Laboratory Sciences, an
- 21 Associate Executive Director for Epidemiology, an Asso-
- 22 ciate Executive Director for Health Sciences, an Assistant
- 23 Executive Director for Compliance, an Associate Executive
- 24 Director for Economic Analysis, an Associate Executive
- 25 Director for Administration, an Associate Executive Di-

- 1 rector for Field Operations, an Assistant Executive Direc-
- 2 tor for Office of Hazard Identification and Reduction, an
- 3 Assistant Executive Director for Information Services,
- 4 and a Director for Office of Information and Public Af-
- 5 fairs. Any other individual appointed to a position des-
- 6 ignated as an Assistant or Associate Executive Director
- 7 shall be appointed by the Chairman, subject to the ap-
- 8 proval of the Commission. The Chairman may only ap-
- 9 point an attorney to the position of Assistant Executive
- 10 Director for Compliance, but this restriction does not
- 11 apply to the position of Acting Assistant Executive Direc-
- 12 tor for Compliance.".
