Ms. LANDRIEU introduced the following bill; which was read twice and referred to the Committee on Small Business and Entrepreneurship

A BILL

To preserve the political independence of the National Women’s Business Council.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Women’s
5 Business Council Independence Preservation Act of
6 2003”.

7 **SEC. 2. FINDINGS.**

8 Congress finds the following:

9 (1) The National Women’s Business Council
10 provides an independent source of advice and policy

1 recommendations regarding women’s business devel-
2 opment and the needs of women entrepreneurs in
3 the United States to—

4 (A) the President;

5 (B) Congress;

6 (C) the Interagency Committee on Wom-
7 en’s Business Enterprise; and

8 (D) the Administrator of the Small Busi-
9 ness Administration.

10 (2) The members of the National Women’s
11 Business Council are small business owners, rep-
12 resentatives of business organizations, and rep-
13 resentatives of women’s business centers.

14 (3) The chair and ranking member of the Com-
15 mittee on Small Business and Entrepreneurship of
16 the Senate and the Committee on Small Business of
17 the House of Representatives make recommenda-
18 tions to the Administrator to fill 8 of the positions
19 on the National Women’s Business Council. Four of
20 the positions are reserved for small business owners
21 who are affiliated with the political party of the
22 President and four of the positions are reserved for
23 small business owners who are not affiliated with the
24 political party of the President. This method of ap-
25 pointment ensures that the National Women’s Busi-

1 ness Council will provide Congress with non-par-
2 tisan, balanced, and independent advice.

3 (4) In order to maintain the independence of
4 the National Women’s Business Council and to en-
5 sure that the Council continues to provide Congress
6 with advice on a non-partisan basis, it is essential
7 that the Council maintain the bipartisan balance es-
8 tablished under section 407 of the Women’s Busi-
9 ness Ownership Act of 1988 (15 U.S.C. 7107).

10 **SEC. 3. MAINTAINING THE POLITICAL INDEPENDENCE OF**
11 **THE NATIONAL WOMEN’S BUSINESS COUN-**
12 **CIL.**

13 Section 407(f) of the Women’s Business Ownership
14 Act of 1988 (15 U.S.C. 7107(f)) is amended—

15 (1) by striking “A vacancy” and inserting the
16 following:

17 “(1) IN GENERAL.—A vacancy”; and

18 (2) by adding at the end the following:

19 “(2) PARTISAN BALANCE.—When filling vacan-
20 cies under paragraph (1), the Administrator shall, to
21 the extent practicable, ensure that there are an
22 equal number of members on the Council from each
23 of the 2 major political parties.

24 “(3) ACCOUNTABILITY.—If a vacancy is not
25 filled within the 30-day period required under para-

1 graph (1) or if there exists an imbalance of party-
2 affiliated members on the Council for a period ex-
3 ceeding 30 days, the Administrator shall submit a
4 report, not later than 10 days after the respective
5 30-day deadline, to the Committee on Small Busi-
6 ness and Entrepreneurship of the Senate and the
7 Committee on Small Business of the House of Rep-
8 resentatives, that explains why the respective dead-
9 line was not met and provides an estimated date on
10 which any vacancies will be filled.”.
