1	SECTION 1. MODIFICATION OF BEND PINE NURSERY LAND
2	CONVEYANCE.
3	(a) Designation of Recipients and Consider-
4	ATION.—Section 3 of the Bend Pine Nursery Land Con-
5	veyance Act (Public Law 106–526; 114 Stat. 2512) is
6	amended—
7	(1) in subsection (a), by striking paragraph (1)
8	and redesignating paragraphs (2) through (7) as
9	paragraphs (1) through (6), respectively;
10	(2) in subsection (e)—
11	(A) by striking "this section" both places
12	it appears and inserting "subsection (a)";
13	(B) in paragraph (1), by striking "Subject
14	to paragraph (3), the" and inserting "The";
15	and
16	(C) by striking paragraph (3); and
17	(3) by adding at the end the following:
18	"(g) Bend Pine Nursery Conveyance.—
19	"(1) Conveyance to park and recreation
20	DISTRICT.—Upon receipt of consideration in the
21	amount of \$3,503,676 from the Bend Metro Park
22	and Recreation District in Deschutes County, Or-
23	egon, the Secretary shall convey to the Bend Metro
24	Park and Recreation District all right, title, and in-
25	terest of the United States in and to a parcel of real
26	property consisting of approximately 185 acres and

1 containing the Bend Pine Nursery, as depicted on 2 the site plan map entitled 'Bend Pine Nursery Administrative Site, May 13, 2004'. Subject to para-3 4 graph (2), the real property conveyed to the Bend 5 Metro Park and Recreation District shall be used 6 only for public recreation purposes and may be de-7 veloped for those purposes. If the Secretary deter-8 mines that the real property subject to this condition 9 is converted, in whole or in part, to a use other than 10 public recreation, the Secretary shall require the 11 Bend Metro Park and Recreation District to pay to the United States an amount equal to the fair mar-12 13 ket value of the property at the time of conversion, 14 less the consideration paid under this paragraph.

15 "(2) Reconveyance of portion to school 16 DISTRICT.—As soon as practicable after the receipt 17 by the Bend Metro Park and Recreation District of 18 the real property described in paragraph (1), the 19 Bend Metro Park and Recreation District shall con-20 vey to the Administrative School District No. 1, 21 Deschutes County, Oregon, without consideration, a 22 parcel of real property located in the northwest cor-23 ner of the real property described in paragraph (1)24 and consisting of approximately 15 acres. The deed 25 of conveyance shall contain a covenant requiring that the real property conveyed to the School Dis trict be used only for public education purposes.".
