A BILL

To amend the Bend Pine Nursery Land Conveyance Act to direct the Secretary of Agriculture to sell the Bend Pine Nursery Administrative Site in the State of Oregon.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SALE OF BEND PINE NURSERY ADMINISTRATIVE SITE.

The Bend Pine Nursery Land Conveyance Act (114
Stat. 2512) is amended—

(1) in section 3—

(A) in subsection (a)—

(i) by striking paragraph (1);

1	(ii) by redesignating paragraphs (2)
2	through (7) as subparagraphs (A) through
3	(F), respectively, and adjusting the mar-
4	gins appropriately; and
5	(iii) by striking "(a) In General.—
6	The Secretary may' and inserting the fol-
7	lowing:
8	"(a) In General.—The Secretary—
9	"(1) shall offer to sell to the Bend Metro Park
10	and Recreation District in Deschutes County, Or-
11	egon, for consideration in the amount of \$3,505,676,
12	all right, title, and interest of the United States in
13	and to approximately 170 acres of the parcel of land
14	identified as Tract A, Bend Pine Nursery, as de-
15	picted on the site plan map entitled 'Bend Pine
16	Nursery Administrative Site, May 13, 1999'; and
17	"(2) may";
18	(B) by striking subsection (e)(3); and
19	(C) by inserting after subsection (f) the
20	following:
21	"(g) Bend Pine Nursery Administrative
22	SITE.—The land conveyed to the Bend Metro Park and
23	Recreation District under section 3(a)(1)—
24	"(1) shall be used only for recreation purposes;
25	and

1	"(2) may be developed for those purposes.".
2	(2) by redesignating section 6 as section 7; and
3	(3) by inserting after section 5 the following:
4	"SEC. 6. CONVEYANCE TO BEND-LA PINE SCHOOL DIS-
5	TRICT.
6	"The Secretary, in accordance with section 202 of the
7	Education Land Grant Act (16 U.S.C. 479a), shall convey
8	to Administrative School District No. 1, Deschutes Coun-
9	ty, Oregon, for no consideration, 15 acres of land located
10	in the northwest corner of the tract described in section
11	3(a)(1), to be used for educational purposes.".
