# A BILL

## To provide extended unemployment benefits to displaced workers.

- 1 Be it enacted by the Senate and House of Representa-

#### 12 SEC. 102. EXTENSION OF THE TEMPORARY EXTENDED UN-

13 EMPLOYMENT COMPENSATION ACT OF 2002.

14 (a) SIX-MONTH EXTENSION OF PROGRAM.—Section15 208 is amended to read as follows:

#### 16 "SEC. 208. APPLICABILITY.

17 "(a) IN GENERAL.—Subject to subsection (b), an
18 agreement entered into under this title shall apply to
19 weeks of unemployment—

1 "(1) beginning after the date on which such 2 agreement is entered into; and "(2) ending before July 1, 2004. 3 4 "(b) TRANSITION.—In the case of an individual who 5 is receiving temporary extended unemployment compensation for the week which immediately precedes the first day 6 7 of the week that includes July 1, 2004, temporary ex-8 tended unemployment compensation shall continue to be 9 payable to such individual for any week thereafter from 10 the account from which such individual received compensation for the week immediately preceding that termi-11 12 nation date. No compensation shall be payable by reason 13 of the preceding sentence for any week beginning after December 31, 2004.". 14

(b) EFFECTIVE DATE.—The amendment made by
this section shall take effect as if included in the enactment of the Temporary Extended Unemployment Compensation Act of 2002 (Public Law 107–147; 26 U.S.C.
3304 note).

20SEC. 103. ENTITLEMENT TO ADDITIONAL WEEKS OF TEM-21PORARY EXTENDED UNEMPLOYMENT COM-22PENSATION.

23 (a) WEEKS OF TEUC AMOUNTS.—Paragraph (1) of
24 section 203(b) is amended to read as follows:

"(1) IN GENERAL.—The amount established in
 an account under subsection (a) shall be equal to 26
 times the individual's weekly benefit amount for the
 benefit year.".

5 (b) WEEKS OF TEUC-X AMOUNTS.—Section 6 203(c)(1) is amended by striking "an amount equal to the 7 amount originally established in such account (as deter-8 mined under subsection (b)(1))" and inserting "7 times 9 the individual's weekly benefit amount for the benefit 10 year".

11 (c) EFFECTIVE DATE.—

12 (1) IN GENERAL.—The amendments made by13 this section—

14 (A) shall take effect as if included in the
15 enactment of the Temporary Extended Unem16 ployment Compensation Act of 2002 (Public
17 Law 107–147; 26 U.S.C. 3304 note); but

(B) shall apply only with respect to weeks
of unemployment beginning on or after the date
of enactment of this Act, subject to paragraph
(2).

(2) SPECIAL RULES.—In the case of an individual for whom a temporary extended unemployment compensation account was established before
the date of enactment of this Act, the Temporary

8	SEC. 201. TEMPORARY INCREASE IN EXTENDED UNEM-
9	PLOYMENT BENEFITS UNDER THE RAILROAD
10	UNEMPLOYMENT INSURANCE ACT.
11	Section 2(c)(2) of the Railroad Unemployment Insur-
12	ance Act (45 U.S.C. $352(c)(2)$ ) is amended by adding at
13	the end the following:
14	"(D) TEMPORARY INCREASE IN EXTENDED
15	UNEMPLOYMENT BENEFITS.—
16	"(i) Employees with 10 or more
17	YEARS OF SERVICE.—Subject to clause
18	(iii), in the case of an employee who has
19	10 or more years of service (as so defined),
20	with respect to extended unemployment
21	benefits—
22	"(I) subparagraph (A) shall be
23	applied by substituting "130 days of
24	unemployment" for "65 days of un-
25	employment"; and

1	"(II) subparagraph (B) shall be
2	applied by inserting "(or, in the case
3	of unemployment benefits, 13 con-
4	secutive 14-day periods" after "7 con-
5	secutive 14-day periods".
6	"(ii) Employees with less than 10
7	YEARS OF SERVICE.—Subject to clause
8	(iii), in the case of an employee who has
9	less than 10 years of service (as so de-
10	fined), with respect to extended unemploy-
11	ment benefits, this paragraph shall apply
12	to such an employee in the same manner
13	as this paragraph would apply to an em-
14	ployee described in clause (i) if such clause
15	had not been enacted.
16	"(iii) Application.—The provisions
17	of clauses (i) and (ii) shall apply to an em-
18	ployee who received normal benefits for
19	days of unemployment under this Act dur-
20	ing the period beginning on July 1, 2002,
21	and ending before July 1, 2004.".
