A BILL

To direct the Secretary of Agriculture to carry out an inventory and management program for forests derived from public domain land.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. FOREST INVENTORY AND MANAGEMENT.

- 4 Section 17 of the Cooperative Forestry Assistance
- 5 Act of 1978 (16 U.S.C. 2101 note; Public Law 95–313)
- 6 is amended to read as follows:

7 "SEC. 17. FOREST INVENTORY AND MANAGEMENT.

8 "(a) IN GENERAL.—The Secretary shall carry out a
9 program using geospatial and information management
10 technologies (including remote sensing imaging and deci-

sion support systems) to inventory, monitor, characterize,

2 assess, and identify forest stands and potential forest 3 stands on-"(1) units of the National Forest System de-4 5 rived from public domain land; and 6 "(2) private forest land, with the consent of the 7 owner of the land. "(b) MEANS.—The Secretary shall carry out the pro-8 gram through the use of— 9 "(1) remote sensing technology of the National 10 Aeronautics and Space Administration and the 11 12 United States Geological Survey; "(2) emerging geospatial capabilities in re-13 14 search activities; "(3) validating techniques, including coordina-15 16 tion and reconciliation with existing data through 17 field verification, using application demonstrations; 18 and 19 "(4) integration of results into pilot operational 20 systems. "(c) ISSUES TO BE ADDRESSED.—In carrying out 21 22 the program, the Secretary shall address issues includ-23 ing-

24 "(1) early detection, identification, and assess-25 ment of environmental threats (including insect, dis-

1	ease, invasive species, fire, acid deposition, and
2	weather-related risks and other episodic events);
3	"(2) loss or degradation of forests;
4	"(3) degradation of the quality forest stands
5	caused by inadequate forest regeneration practices;
6	"(4) quantification of carbon uptake rates;
7	"(5) management practices that focus on pre-
8	venting further forest degradation; and
9	"(6) characterization of vegetation types, den-
10	sity, fire regimes, post-fire effects, and condition
11	class.
12	"(d) Early Warning System.—In carrying out the
13	program, the Secretary shall develop a comprehensive
14	early warning system for potential catastrophic environ-
15	mental threats to forests to increase the likelihood that
16	forest managers will be able to—
17	"(1) isolate and treat a threat before the threat
18	gets out of control; and
19	((2)) prevent epidemics, such as the American
20	chestnut blight in the first half of the twentieth cen-
21	tury, that could be environmentally and economically
22	devastating to forests.
23	"(e) Administration.—To carry out this section,
24	the Secretary shall designate and maintain a facility in
25	the Ochoco National Forest headquarters in Prineville,

Oregon, that will address the issues described in sub section (c), with a particular emphasis on coniferous forest
 stands in the Western United States.

4 "(f) AUTHORIZATION OF APPROPRIATIONS.—There
5 are authorized to be appropriated such sums as are nec6 essary to carry out this section.".
