A BILL

To direct the Secretary of Agriculture to carry out an inventory and management program for forests derived from public domain land.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FOREST INVENTORY AND MANAGEMENT.**

4 Section 17 of the Cooperative Forestry Assistance
5 Act of 1978 (16 U.S.C. 2101 note; Public Law 95–313)
6 is amended to read as follows:

1 **“SEC. 17. FOREST INVENTORY AND MANAGEMENT.**

2 “(a) IN GENERAL.—The Secretary shall carry out a
3 program using geospatial and information management
4 technologies (including remote sensing imaging and deci-
5 sion support systems) to inventory, monitor, characterize,
6 assess, and identify forest stands and potential forest
7 stands on—

8 “(1) units of the National Forest System de-
9 rived from public domain land; and

10 “(2) private forest land, with the consent of the
11 owner of the land.

12 “(b) MEANS.—The Secretary shall carry out the pro-
13 gram through the use of—

14 “(1) remote sensing technology of the National
15 Aeronautics and Space Administration and the
16 United States Geological Survey;

17 “(2) emerging geospatial capabilities in re-
18 search activities;

19 “(3) validating techniques, including coordina-
20 tion and reconciliation with existing data through
21 field verification, using application demonstrations;
22 and

23 “(4) integration of results into pilot operational
24 systems.

1 “(c) ISSUES TO BE ADDRESSED.—In carrying out
2 the program, the Secretary shall address issues includ-
3 ing—

4 “(1) early detection, identification, and assess-
5 ment of environmental threats (including insect, dis-
6 ease, invasive species, fire, acid deposition, and
7 weather-related risks and other episodic events);

8 “(2) loss or degradation of forests;

9 “(3) degradation of the quality forest stands
10 caused by inadequate forest regeneration practices;

11 “(4) quantification of carbon uptake rates;

12 “(5) management practices that focus on pre-
13 venting further forest degradation; and

14 “(6) characterization of vegetation types, den-
15 sity, fire regimes, post-fire effects, and condition
16 class.

17 “(d) EARLY WARNING SYSTEM.—In carrying out the
18 program, the Secretary shall develop a comprehensive
19 early warning system for potential catastrophic environ-
20 mental threats to forests to increase the likelihood that
21 forest managers will be able to—

22 “(1) isolate and treat a threat before the threat
23 gets out of control; and

24 “(2) prevent epidemics, such as the American
25 chestnut blight in the first half of the twentieth cen-

1 tury, that could be environmentally and economically
2 devastating to forests.

3 “(e) ADMINISTRATION.—To carry out this section,
4 the Secretary shall designate and maintain a facility in
5 the Ochoco National Forest headquarters in Prineville,
6 Oregon, that will address the issues described in sub-
7 section (c), with a particular emphasis on coniferous forest
8 stands in the Western United States.

9 “(f) AUTHORIZATION OF APPROPRIATIONS.—There
10 are authorized to be appropriated such sums as are nec-
11 essary to carry out this section.”.
