A BILL

To amend the Violence Against Women Act of 2000 by expanding the legal assistance for victims of violence grant program to include legal assistance for victims of dating violence.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. LEGAL ASSISTANCE FOR VICTIMS OF DATING**
4 **VIOLENCE.**

5 Section 1201 of the Violence Against Women Act of
6 2000 (42 U.S.C. 3796gg-6) is amended—

7 (1) in subsection (a), by inserting “dating vio-
8 lence,” after “domestic violence,”;

1 (2) in subsection (b)—

2 (A) by redesignating paragraphs (1), (2),
3 and (3) as paragraphs (2), (3), and (4) respec-
4 tively;

5 (B) by inserting before paragraph (2), as
6 redesignated, the following:

7 “(1) DATING VIOLENCE.—The term ‘dating vio-
8 lence’ means violence committed by a person—

9 “(A) who is or has been in a social rela-
10 tionship of a romantic or intimate nature with
11 the victim; and

12 “(B) where the existence of such a rela-
13 tionship shall be determined based on a consid-
14 eration of—

15 “(i) the length of the relationship;

16 “(ii) the type of relationship; and

17 “(iii) the frequency of interaction be-
18 tween the persons involved in the relation-
19 ship.”; and

20 (C) in paragraph (3), as redesignated, by
21 inserting “dating violence,” after “domestic vio-
22 lence,”;

23 (3) in subsection (c)—

24 (A) in paragraph (1)—

1 (i) by inserting “, dating violence,”
2 after “domestic violence”; and

3 (ii) by inserting “dating violence,”
4 after “domestic violence,”;

5 (B) in paragraph (2), by inserting “dating
6 violence,” after “domestic violence,”; and

7 (C) in paragraph (3), by inserting “dating
8 violence,” after “domestic violence,”;

9 (4) in subsection (d)—

10 (A) in each of paragraphs (1), (2), and
11 (3), by inserting “, dating violence,” after “do-
12 mestic violence,”; and

13 (B) in paragraph (4), by inserting “dating
14 violence,” after “domestic violence,”;

15 (5) in subsection (e), by inserting “dating vio-
16 lence,” after “domestic violence,”; and

17 (6) in subsection (f)(2)(A), by inserting “dating
18 violence,” after “domestic violence,”.
