For the relief of Luay Lufti Hadad.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PERMANENT RESIDENT STATUS FOR LUAY
- 4 LUFTI HADAD.
- 5 (a) In General.—Notwithstanding subsections (a)
- 6 and (b) of section 201 of the Immigration and Nationality
- 7 Act, Luay Lufti Hadad shall be eligible for issuance of
- 8 an immigrant visa or for adjustment of status to that of
- 9 an alien lawfully admitted for permanent residence upon

- 1 filing an application for issuance of an immigrant visa
- 2 under section 204 of that Act or for adjustment of status
- 3 to lawful permanent resident.
- 4 (b) Adjustment of Status.—If Luay Lufti Hadad
- 5 enters the United States before the filing deadline speci-
- 6 fied in subsection (c), Luay Lufti Hadad shall be consid-
- 7 ered to have entered and remained lawfully and shall be
- 8 eligible for adjustment of status under section 245 of the
- 9 Immigration and Nationality Act as of the date of enact-
- 10 ment of this Act.
- 11 (c) Deadline for Application and Payment of
- 12 Fees.—Subsections (a) and (b) shall apply only if the ap-
- 13 plication for issuance of an immigrant visa or the applica-
- 14 tion for adjustment of status is filed with appropriate fees
- 15 within 2 years after the date of enactment of this Act.
- 16 (d) Reduction of Immigrant Visa Numbers.—
- 17 Upon the granting of an immigrant visa or permanent res-
- 18 idence to Luay Lufti Hadad, the Secretary of State shall
- 19 instruct the proper officer to reduce by 1, during the cur-
- 20 rent or next following fiscal year, the total number of im-
- 21 migrant visas that are made available to natives of the
- 22 country of birth of Luay Lufti Hadad under section
- 23 203(a) of the Immigration and Nationality Act or, if appli-
- 24 cable, the total number of immigrant visas that are made

- 1 available to natives of the country of birth of Luay Lufti
- $2\,\,$  Hadad under section 202(e) of that Act.
