A BILL

To amend title 10 United States Code, to increase the amounts of educational assistance for members of the Selected Reserve, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. INCREASE IN AMOUNTS OF EDUCATIONAL AS-**
4 **SISTANCE UNDER MONTGOMERY GI BILL FOR**
5 **MEMBERS OF THE SELECTED RESERVE.**

6 (a) INCREASE IN RATES FOR FISCAL YEARS 2005
7 THROUGH 2007.—Section 16131(b)(1) of title 10, United
8 States Code, is amended by striking subparagraphs (A),
9 (B), and (C) and inserting the following new subpara-
10 graphs:

1 “(A) for each month of full-time pursuit of a
2 program of education—

3 “(i) for months occurring during fiscal
4 year 2004, \$282;

5 “(ii) for months occurring during fiscal
6 year 2005, \$332;

7 “(iii) for months occurring during fiscal
8 year 2006, \$397; and

9 “(iv) for months occurring during fiscal
10 year 2007, \$467;

11 “(B) for each month of three-quarter-time pur-
12 suit of a program of education—

13 “(i) for months occurring during fiscal
14 year 2004, \$212;

15 “(ii) for months occurring during fiscal
16 year 2005, \$242;

17 “(iii) for months occurring during fiscal
18 year 2006, \$283; and

19 “(iv) for months occurring during fiscal
20 year 2007, \$325;

21 “(C) for each month of half-time pursuit of a
22 program of education—

23 “(i) for months occurring during fiscal
24 year 2004, \$140;

1 “(ii) for months occurring during fiscal
2 year 2005, \$160;

3 “(iii) for months occurring during fiscal
4 year 2006, \$187; and

5 “(iv) for months occurring during fiscal
6 year 2007, \$215; and”.

7 (b) SUSPENSION OF COST-OF-LIVING ADJUST-
8 MENT.—Notwithstanding paragraph (2) of section
9 16131(b) of title 10, United States Code, no adjustment
10 in the rates of educational assistance payable under such
11 section, as amended by subsection (a) of this section, shall
12 be made for fiscal year 2005, 2006, or 2007.
