A BILL

To extend the final report date and termination date of the National Commission on Terrorist Attacks Upon the United States, to provide additional funding for the Commission, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF NATIONAL COMMISSION ON**
4 **TERRORIST ATTACKS UPON THE UNITED**
5 **STATES.**

6 (a) FINAL REPORT DATE.—Subsection (b) of section
7 610 of the Intelligence Authorization Act for Fiscal Year

1 2003 (Public Law 107–306; 6 U.S.C. 101 note; 116 Stat.
2 2413) is amended by striking “18 months” and inserting
3 “20 months”.

4 (b) TERMINATION DATE.—Subsection (c) of that sec-
5 tion is amended—

6 (1) in paragraph (1), by striking “60 days” and
7 inserting “30 days”; and

8 (2) in paragraph (2), by striking “60-day pe-
9 riod” and inserting “30-day period”.

10 (c) ADDITIONAL FUNDING.—Section 611 of that Act
11 (6 U.S.C. 101 note; 116 Stat. 2413) is amended—

12 (1) by redesignating subsection (b) as sub-
13 section (c);

14 (2) by inserting after subsection (a) the fol-
15 lowing new subsection (b):

16 “(b) ADDITIONAL FUNDING.—In addition to the
17 amounts made available to the Commission under sub-
18 section (a) and under chapter 2 of title II of the Emer-
19 gency Wartime Supplemental Appropriations Act, 2003
20 (Public Law 108–11; 117 Stat. 591), of the amounts ap-
21 propriated for the programs and activities of the Federal
22 Government for fiscal year 2004 that remain available for
23 obligation, not more than \$1,000,000 shall be available for
24 transfer to the Commission for purposes of the activities
25 of the Commission under this title.”; and

1 (3) in subsection (c), as so redesignated, by
2 striking “subsection (a)” and inserting “this sec-
3 tion”.
