Mr. LAUTENBERG introduced the following bill; which was read twice and referred to the Committee on Armed Services

A BILL

To amend title 37, United States Code, to require the payment of monthly special pay for members of the uniformed services whose service on active duty is extended by a stop-loss order or similar mechanism, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. MONTHLY SPECIAL PAY FOR ACTIVE DUTY**

4 **SERVICE EXTENDED BY STOP-LOSS ORDERS.**

5 (a) IN GENERAL.—(1) Chapter 5 of title 37, United
6 States Code, is amended by adding at the end the fol-
7 lowing new section:

1 **“§ 327. Special pay: active duty service extended by**
2 **stop-loss order**

3 “(a) SPECIAL PAY.—A member of the uniformed
4 services entitled to basic pay whose enlistment or period
5 of obligated service is extended, or whose eligibility for re-
6 tirement is suspended, pursuant to the exercise of an au-
7 thority referred to in subsection (b) is entitled while on
8 active duty during the period of such extension or suspen-
9 sion to special pay in the amount specified in subsection
10 (c).

11 “(b) EXTENSION AUTHORITIES.—An authority re-
12 ferred to in this section is an authority for the extension
13 of an enlistment or period of obligated service, or for sus-
14 pension of eligibility for retirement, of a member of the
15 uniformed services under a provision of law as follows:

16 “(1) Section 123 of title 10.

17 “(2) Section 12305 of title 10.

18 “(3) Any other provision of law (commonly re-
19 ferred to as ‘stop-loss authority’) authorizing the
20 President to extend an enlistment or period of obli-
21 gated service, or suspend an eligibility for retire-
22 ment, of a member of the uniformed services in time
23 of war or of national emergency declared by Con-
24 gress or the President.

25 “(c) MONTHLY AMOUNT.—The amount of special pay
26 specified in this subsection is \$2,000 per month.

1 “(d) CONSTRUCTION WITH OTHER PAYS.—Special
2 pay payable under this section is in addition to any other
3 pay payable to members of the uniformed services by
4 law.”.

5 (2) The table of sections at the beginning of such
6 chapter is amended by adding at the end the following
7 new item:

“327. Special pay: active duty service extended by stop-loss order.”.

8 (b) EFFECTIVE DATE.—The amendments made by
9 subsection (a) shall take effect as of March 20, 2003.

10 (c) FUNDING.—Amounts appropriated or otherwise
11 made available for the Department of Defense for oper-
12 ation and maintenance for fiscal year 2005 shall be avail-
13 able for the payment of special pay under section 327 of
14 title 37, United States Code (as added by subsection
15 (a))—

16 (1) during fiscal year 2005; and

17 (2) for the period beginning on the effective
18 date specified in subsection (b) and ending on Sep-
19 tember 30, 2004.
