A BILL

To authorize the Secretary of Agriculture to sell or exchange certain National Forest System land in the State of Vermont.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Green Mountain Na-
- 5 tional Forest Land Adjustment Act of 2004".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act:
- 8 (1) Bromley.—The term "Bromley" means
- 9 Bromley Mountain Ski Resort, Inc.

| 12 | sell or exchange any right, title, and interest of the United |
| 13 | States in and to the parcels of National Forest System |
| 14 | land described in subsection (b). |
| 15 | (b) Description of Land.—The parcels of Na- |
| 16 | tional Forest System land referred to in subsection (a) are |
| 17 | the 5 parcels of land in Bennington County in the State, |
| 18 | as generally depicted on the map. |
| 19 | (c) Map and Legal Descriptions.— |
| 20 | (1) IN GENERAL.—The map shall be on file and |
| 21 | available for public inspection in— |
| 22 | (A) the office of the Chief of the Forest |
| 23 | Service; and |
| 24 | (B) the office of the Supervisor of the |

| 14 | tate the sale or exchange of land under subsection (a) shall |
| 15 | conform with the Uniform Appraisal Standards for Fed- |

| 17 | (f) Methods of Sale.— |
| 18 | (1) Conveyance to Bromley.— |
| 19 | (A) In general.—Before soliciting offers |
| 20 | under paragraph (2), the Secretary shall offer |
| 21 | to convey to Bromley the land described in sub- |
| 22 | section (b). |
| 23 | (B) CONTRACT DEADLINE.—If Bromley |
| 24 | accepts the offer under subparagraph (A), the |
| 25 | Secretary and Bromley shall have not more |

- than 180 days after the date on which any environmental analyses with respect to the land are completed to enter into a contract for the sale or exchange of the land.
 - (2) Public or private sale.—If the Secretary and Bromley do not enter into a contract for the sale or exchange of the land by the date specified in paragraph (1)(B), the Secretary may sell or exchange the land at public or private sale (including auction), in accordance with such terms, conditions, and procedures as the Secretary determines to be in the public interest.
 - (3) REJECTION OF OFFERS.—The Secretary may reject any offer received under this subsection if the Secretary determines that the offer is not adequate or is not in the public interest.
 - (4) Brokers.—In any sale or exchange of land under this section, the Secretary may—
 - (A) use a real estate broker or other third party; and
 - (B) pay the real estate broker or third party a commission in an amount comparable to the amounts of commission generally paid for real estate transactions in the area.

| 7 | (a) In General.—The Secretary shall deposit the |
| 8 | net proceeds from a sale or exchange under this Act in |
| 9 | the fund established under Public Law 90–171 (16 U.S.C. |
| 10 | 484a) (commonly known as the "Sisk Act"). |
| 11 | (b) Use.—Amounts deposited under subsection (a) |
| 12 | shall be available to the Secretary until expended, without |
| 13 | further appropriation, for— |
| 14 | (1) the location and relocation of the Appa- |
| 15 | lachian National Scenic Trail and the Long National |
| 16 | Recreation Trail in the State; |
| 17 | (2) the acquisition of land and interests in land |
| 18 | by the Secretary for National Forest System pur- |
| 19 | poses within the boundary of the Green Mountain |
| 20 | National Forest, including land for and adjacent to |

- 3 SEC. 6. EXEMPTION FROM CERTAIN LAWS.
- 4 The Federal Property and Administrative Services
- 5 Act of 1949 (40 U.S.C. 471 et seq.) shall not apply to
- 6 any sale or exchange of National Forest System lands
- 7 under this Act.
