3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Federal Regulatory

5 Improvement Act of 2004".

6 SEC. 2. PURPOSES.

7 (a) PURPOSES.—Section 591 of title 5, United States

8 Code, is amended to read as follows:

"§ 591 Purposes

2	"The purposes of this subchapter are—
3	((1) to provide suitable arrangements through
4	which Federal agencies, assisted by outside experts,
5	may cooperatively study mutual problems, exchange
6	information, and develop recommendations for action
7	by proper authorities to the end that private rights
8	may be fully protected and regulatory activities and
9	other Federal responsibilities may be carried out ex-
10	peditiously in the public interest;
11	"(2) to promote more effective public participa-
12	tion and efficiency in the rulemaking process;
13	"(3) to reduce unnecessary litigation in the reg-
14	ulatory process;
15	"(4) to improve the use of science in the regu-
16	latory process; and
17	"(5) to improve the effectiveness of laws appli-
18	cable to the regulatory process.".
19	(b) Conforming Amendments.—Title 5 of the
20	United States Code is amended—
21	(1) in section 594 by striking "purpose" and
22	inserting "purposes"; and
23	(2) in the table of sections of chapter 5 of part
24	I by amending the item relating to section 591 to
25	read as follows:
	"591. Purposes".

1 SEC. 3. AUTHORIZATION OF APPROPRIATIONS.

2 Section 596 of title 5, United States Code, is amend-3 ed to read as follows:

4 "§ 596. Authorization of appropriations

5 "There are authorized to be appropriated to carry out 6 this subchapter not more than \$3,000,000 for fiscal year 7 2005, \$3,100,000 for fiscal year 2006, and \$3,200,000 8 for fiscal year 2007. Of any amounts appropriated under 9 this section, not more than \$2,500 may be made available 10 in each fiscal year for official representation and enter-11 tainment expenses for foreign dignitaries.".
