## A BILL

To authorize the Secretary of Agriculture to sell or exchange all or part of certain administrative sites and other land in the Ozark-St. Francis and Ouachita National Forests and to use funds derived from the sale or exchange to acquire, construct, or improve administrative sites.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SALE OR EXCHANGE OF LAND.
- 4 (a) In General.—The Secretary of Agriculture (re-
- 5 ferred to in this Act as the "Secretary") may, under such
- 6 terms and conditions as the Secretary may prescribe, sell
- 7 or exchange any right, title, and interest of the United

1	(b) APPLICABLE AUTHORITIES.—Except as other-
2	wise provided in this Act, any sale or exchange of land
3	described in subsection (a) shall be subject to laws (includ-
4	ing regulations) applicable to the conveyance and acquisi-
5	tion of land for National Forest System purposes.
6	(c) Cash Equalization.—Notwithstanding any
7	other provision of law, the Secretary may accept cash
8	equalization payments in excess of 25 percent of the total
9	value of the land described in subsection (a) from any ex-
10	change under subsection (a).
11	(d) Solicitations of Offers.—
12	(1) In General.—In carrying out this Act, the
13	Secretary may use solicitations of offers for sale or
14	exchange under this Act on such terms and condi-
15	tions as the Secretary may prescribe.
16	(2) REJECTION OF OFFERS.—The Secretary
17	may reject any offer under this Act if the Secretary
18	determines that the offer is not adequate or not in
19	the public interest.
20	SEC. 2. DISPOSITION OF FUNDS.
21	Any funds received by the Secretary through sale or
22	by cash equalization from an exchange—
23	(1) shall be deposited into the fund established

- 1 (2) shall be available for expenditure, without 2 further Act of appropriation, for the acquisition, 3 construction, or improvement of administrative fa-4 cilities, land, or interests in land for the national 5 forests in the States of Arkansas and Oklahoma.
- 6 SEC. 3. AUTHORIZATION OF APPROPRIATIONS.
- 7 There are authorized to be appropriated such sums
- 8 as are necessary to carry out this Act.
