A BILL

To revise the boundary of the Black Canyon of the Gunnison National Park and Gunnison Gorge National Conservation Area in the State of Colorado, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Black Canyon of the
- 5 Gunnison National Park and Gunnison Gorge National
- 6 Conservation Area Boundary Revision Act of 2003".

5	(a) Authority To Acquire Land.—Section 5(a)(1)
6	of the Black Canyon of the Gunnison National Park and
7	Gunnison Gorge National Conservation Area Act of 1999
8	(16 U.S.C. 410fff–3(a)(1)) is amended by inserting "or
9	the map described in section $4(a)(2)$ " after "the Map".
10	(b) METHOD OF ACQUISITION.—
11	(1) In general.—Land or interest in land ac-
12	quired under the amendments made by this Act shall
13	be made in accordance with section 5(a)(2)(A) of the
14	Black Canyon of the Gunnison National Park and
15	Gunnison Gorge National Conservation Area Act of
16	1999 (16 U.S.C. 410fff–3(a)(2)(A)).
17	(2) Consent.—No land or interest in land may
18	be acquired without the consent of the landowner.
19	SEC. 5. GUNNISON GORGE NATIONAL CONSERVATION AREA
20	BOUNDARY REVISION.
21	Section 7(a) of the Black Canyon of the Gunnison
22	National Park and Gunnison Gorge National Conservation
23	Area Act of 1999 (16 U.S.C. 410fff–5(a)) is amended—
24	(1) by striking "(a) IN GENERAL.—There is es-
25	tablished" and inserting the following:

- 3 (2) by adding at the end the following:
- 4 "(2) Boundary Revision.—The boundary of

- 7 the map entitled 'Black Canyon of the Gunnison Na-
- 8 tional Park and Gunnison Gorge NCA Boundary
- 9 Modifications' and dated January 21, 2003.".

10 SEC. 6. ACCESS TO WATER DELIVERY FACILITIES.

- 11 The Commissioner of Reclamation shall retain ad-
- 12 ministrative jurisdiction over, and access to, land, facili-
- 13 ties, and roads of the Bureau of Reclamation in the East
- 14 Portal area and the Crystal Dam area, as depicted on the
- 15 map identified in section 4(a)(2) of the Black Canyon of
- 16 the Gunnison National Park and Gunnison Gorge Na-
- 17 tional Conservation Area Act of 1999 (as added by section
- 18 2(a)(2)) for the maintenance, repair, construction, re-
- 19 placement, and operation of any facilities relating to the
- 20 delivery of water under the jurisdiction of the Bureau to
- 21 users of the water (as of the date of enactment of this
- 22 Act).
