AN ACT

To revise the boundary of the Black Canyon of the Gunnison National Park and Gunnison Gorge National Conservation Area in the State of Colorado, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Black Canyon of the
- 5 Gunnison Boundary Revision Act of 2003".

1 SEC. 2. BLACK CANYON OF THE GUNNISON NATIONAL

- 2 PARK BOUNDARY REVISION.
- 3 (a) BOUNDARY REVISION.—Section 4(a) of the Black
- 4 Canyon of the Gunnison National Park and Gunnison
- 5 Gorge National Conservation Area Act of 1999 (16 U.S.C.
- 6 410fff-2(a)) is amended—
- 7 (1) by striking "There" and inserting "(1)
- 8 There''; and
- 9 (2) by adding at the end the following:
- 10 "(2) The boundary of the Park is revised to include
- 11 the addition of approximately 2,530 acres, as generally de-
- 12 picted on the map entitled 'Black Canyon of the Gunnison
- 13 National Park and Gunnison Gorge NCA Boundary Modi-
- 14 fications' and dated April 2, 2003.".
- 15 (b) Transfer of Administrative Jurisdic-
- 16 Tion.—On the date of enactment of this Act, the Sec-
- 17 retary shall transfer the land under the jurisdiction of the
- 18 Bureau of Land Management identified as "Tract C" on
- 19 the map described in subsection (a)(2) to the administra-
- 20 tive jurisdiction of the National Park Service for inclusion
- 21 in the Black Canyon of the Gunnison National Park.
- 22 (c) Conforming Amendment.—Section 5(a)(1) of
- 23 the Black Canyon of the Gunnison National Park and
- 24 Gunnison Gorge National Conservation Area Act of 1999
- 25 (16 U.S.C. 410fff–3(a)(1)) is amended by striking "Map"

- 1 and inserting "Map or the map described in section
- 2 4(a)(2)".
- 3 SEC. 3. GUNNISON GORGE NATIONAL CONSERVATION AREA
- 4 BOUNDARY REVISION.
- 5 Section 7(a) of the Black Canyon of the Gunnison
- 6 National Park and Gunnison Gorge National Conservation
- 7 Area Act of 1999 (16 U.S.C. 410fff–5(a)) is amended—
- 8 (1) by striking "There" and inserting "(1)
- 9 There"; and
- 10 (2) by adding at the end the following:
- 11 "(2) The boundary of the Conservation Area is re-
- 12 vised to include the addition of approximately 7,100 acres,
- 13 as generally depicted on the map entitled 'Black Canyon
- 14 of the Gunnison National Park and Gunnison Gorge NCA
- 15 Boundary Modifications', and dated April 2, 2003.".
- 16 SEC. 4. GRAZING PRIVILEGES.
- 17 (a) Transfer of Privileges.—Section 4(e)(1) of
- 18 the Black Canyon of the Gunnison National Park and
- 19 Gunnison Gorge National Area Act of 1999 (16 U.S.C.
- 20 410fff-2(e)(1)) is amended by adding at the end the fol-
- 21 lowing:
- 22 "(D) If land within the Park on which the grazing
- 23 of livestock is authorized under permits or leases under
- 24 subparagraph (A) is exchanged for private land under sec-

1	tion 5(a), the Secretary shall transfer any grazing privi-
2	leges to the land acquired in the exchange.".
3	(b) Privileges of Certain Partnerships.—Sec-
4	tion 4(e)(3) of the Black Canyon of the Gunnison National
5	Park and Gunnison Gorge National Area Act of 1999 (16
6	U.S.C. 410fff–2(e)(3)) is amended—
7	(1) by striking "and" at the end of subpara-
8	graph (A);
9	(2) by redesignating subparagraph (B) as sub-
10	paragraph (D);
11	(3) by inserting after subparagraph (A) the fol-
12	lowing:
13	"(B) with respect to the permit or lease issued
14	to LeValley Ranch Ltd., for the lifetime of the last
15	surviving limited partner as of October 21, 1999;
16	"(C) with respect to the permit or lease issued
17	to Sanburg Herefords, L.L.P., for the lifetime of the
18	last surviving general partner as of October 21,
19	1999; and"; and
20	(4) in subparagraph (D) (as redesignated by
21	paragraph (2))—
22	(A) by striking "partnership, corporation,
23	or" each place it appears and inserting "cor-
24	poration or"; and

1	(B) by striking "subparagraph (A)" and
2	inserting "subparagraph (A), (B), or (C)".
3	SEC. 5. ACCESS TO WATER DELIVERY FACILITIES.
4	The Commissioner of Reclamation shall retain ad-
5	ministrative jurisdiction over the Crystal Dam Access
6	Road and land, facilities, and roads of the Bureau of Rec-
7	lamation in the East Portal area, including the Gunnison
8	Tunnel, and the Crystal Dam area, as depicted on the map
9	entitled "Black Canyon of the Gunnison National Park
10	and Gunnison Gorge NCA Boundary Modifications", and
11	dated April 2, 2003, for the maintenance, repair, construc-
12	tion, replacement, and operation of any facilities relating
13	to the delivery of water and power under the jurisdiction
14	of the Bureau of Reclamation.
