Mr. Roberts, from the Select Committee on Intelligence, reported the following original resolution; which was referred to the Committee on Rules and Administration

RESOLUTION

Authorizing expenditures by the Select Committee on Intelligence.

- 1 Resolved, That, in carrying out its powers, duties, and
- 2 functions under the Standing Rules of the Senate, in ac-
- 3 cordance with its jurisdiction under rule XXV of such
- 4 rules, including holding hearings, reporting such hearings,
- 5 and making investigations as authorized by paragraphs 1
- 6 and 8 of rule XXVI of the Standing Rules of the Senate,
- 7 the Select Committee on Intelligence is authorized from
- 8 March 1, 2003, through September 30, 2003; October 1,
- 9 2003, through September 30, 2004; and October 1, 2004,
- 10 through February 28, 2005, in its discretion (1) to make

- 1 expenditures from the contingent fund of the Senate, (2)
- 2 to employ personnel, and (3) with the prior consent of the
- 3 Government department or agency concerned and the
- 4 Committee on Rules and Administration, to use on a reim-
- 5 bursable or non-reimbursable basis the services of per-
- 6 sonnel of any such department or agency.
- 7 Sec. 2. (a) The expenses of the committee for the
- 8 period March 1, 2003, through September 30, 2003,
- 9 under this resolution shall not exceed \$2,117,309, of
- 10 which amount not to exceed \$37,917 may be expended for
- 11 the procurement of the services of individual consultants,
- 12 or organizations thereof (as authorized by section 202(i)
- 13 of the Legislative Reorganization Act of 1946, as amend-
- 14 ed).
- 15 (b) For the period October 1, 2003, through Sep-
- 16 tember 30, 2004, expenses of the committee under this
- 17 resolution shall not exceed \$3,726,412, of which amount
- 18 not to exceed \$65,000 be expended for the procurement
- 19 of the services of individual consultants, or organizations
- 20 thereof (as authorized by section 202(i) of the Legislative
- 21 Reorganization Act of 1946, as amended).
- (c) For the period October 1, 2004, through Feb-
- 23 ruary 28, 2005, expenses of the committee under this res-
- 24 olution shall not exceed \$1,588,401, of which amount not
- 25 to exceed \$27,083 be expended for the procurement of the

- 1 services of individual consultants, or organizations thereof
- 2 (as authorized by section 202(i) of the Legislative Reorga-
- 3 nization Act of 1946, as amended).
- 4 Sec. 3. The committee shall report its findings, to-
- 5 gether with such recommendations for legislation as it
- 6 deems advisable, to the Senate at the earliest practicable
- 7 date, but not later than February 28, 2005, respectively.
- 8 Sec. 4. Expenses of the committee under this resolu-
- 9 tion shall be paid from the contingent fund of the Senate
- 10 upon vouchers approved by the chairman of the com-
- 11 mittee, except that vouchers shall not be required (1) for
- 12 the disbursement of salaries of employees paid at an an-
- 13 nual rate, or (2) for the payment of telecommunications
- 14 provided by the Office of the Sergeant at Arms and Door-
- 15 keeper, United States Senate, or (3) for the payment of
- 16 stationery supplies purchased through the Keeper of the
- 17 Stationery, United States Senate, or (4) for payments to
- 18 the Postmaster, United States Senate, or (5) for the pay-
- 19 ment of metered charges on copying equipment provided
- 20 by the Office of the Sergeant at Arms and Doorkeeper,
- 21 United States Senate, or (6) for the payment of Senate
- 22 Recording and Photographic Services, or (7) for payment
- 23 of franked and mass mail costs by the Sergeant at Arms
- 24 and Doorkeeper, United States Senate.

- 1 Sec. 5. There are authorized such sums as may be
- 2 necessary for agency contributions related to the com-
- 3 pensation of employees of the committee, from March 1,
- 4 2003, through September 30, 2003; October 1, 2003,
- 5 through September 30, 2004; and October 1, 2004,
- 6 through February 28, 2005, to be paid from the Appro-
- 7 priations account for "Expenses of Inquiries and Inves-
