# **CONCURRENT RESOLUTION**

Authorizing the use of the Capitol Grounds for the Greater Washington Soap Box Derby.

- 1 Resolved by the House of Representatives (the Senate
- 2 concurring),
- 3 SECTION 1. AUTHORIZATION OF SOAP BOX DERBY RACES
- 4 ON CAPITOL GROUNDS.
- 5 The Greater Washington Soap Box Derby Associa-
- 6 tion (in this resolution referred to as the "Association")
- 7 shall be permitted to sponsor a public event, soap box
- 8 derby races, on the Capitol Grounds on June 17, 2006,
- 9 or on such other date as the Speaker of the House of Rep-

- 1 resentatives and the Committee on Rules and Administra-
- 2 tion of the Senate may jointly designate.

#### 3 SEC. 2. CONDITIONS.

- 4 The event to be carried out under this resolution shall
- 5 be free of admission charge to the public and arranged
- 6 not to interfere with the needs of Congress, under condi-
- 7 tions to be prescribed by the Architect of the Capitol and
- 8 the Capitol Police Board; except that the Association shall
- 9 assume full responsibility for all expenses and liabilities
- 10 incident to all activities associated with the event.

## 11 SEC. 3. STRUCTURES AND EQUIPMENT.

- 12 For the purposes of this resolution, the Association
- 13 is authorized to erect upon the Capitol Grounds, subject
- 14 to the approval of the Architect of the Capitol, such stage,
- 15 sound amplification devices, and other related structures
- 16 and equipment as may be required for the event to be car-
- 17 ried out under this resolution.

#### 18 SEC. 4. ADDITIONAL ARRANGEMENTS.

- 19 The Architect of the Capitol and the Capitol Police
- 20 Board are authorized to make any such additional ar-
- 21 rangements that may be required to carry out the event
- 22 under this resolution.

#### 23 SEC. 5. ENFORCEMENT OF RESTRICTIONS.

- The Capitol Police Board shall provide for enforce-
- 25 ment of the restrictions contained in section 5104(c) of

- 1 title 40, United States Code, concerning sales, advertise-
- 2 ments, displays, and solicitations on the Capitol Grounds,
- 3 as well as other restrictions applicable to the Capitol
- 4 Grounds, with respect to the event to be carried out under

5 this resolution.
