A BILL

- To authorize the Secretary of the Interior to complete a study of the feasibility of establishing the National Parks Institute in Central California.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "National Parks Insti-

5 tute Study Act".

6 SEC. 2. DEFINITIONS.

7 For the purposes of this Act, the following definitions8 shall apply:

9 (1) SECRETARY.—The term "Secretary" means
10 the Secretary of the Interior.

(2) INSTITUTE.—The term "Institute" means
 the entity to be known as the National Parks Insti tute as described in section 3(a).

4 SEC. 3. NATIONAL PARKS INSTITUTE STUDY.

5 (a) IN GENERAL.—The Secretary is authorized to
6 conduct a study to determine the feasibility of establishing
7 an academic institution, to be called the National Parks
8 Institute and located in Central California, to promote
9 management and stewardship excellence for the National
10 Park System, and to help developing nations manage their
11 natural and cultural resources.

12 (b) ASSESSMENT OF NEED.—In evaluating the need13 for the Institute, the study shall assess—

- (1) the availability of opportunities for academic, governmental, and nongovernmental sectors
 to pursue scientific research and policy analysis on
 issues related to the preservation and enjoyment of
 the natural and cultural resources in the National
 Park System, including opportunities for—
- 20 (A) forecasting emerging issues in manage21 ment of the National Park System and ana22 lyzing alternative responses to those issues;

(B) generating and promoting ideas for
improved practices in the stewardship of the
National Park System, including environ-

1	mentally sustainable resources management
2	practices; and
3	(C) recognizing and responding to evolving
4	interests among the public in natural and cul-
5	tural resource subjects;
6	(2) the capability of existing National Park
7	Service training centers and programs to fulfill edu-
8	cation and training needs identified in the workforce
9	plan developed by the National Park Service on the
10	basis of the Department of the Interior's Strategic
11	Human Capital Management Plan (September
12	2002);
13	(3) the benefits of further promoting the na-
14	tional park concept among developing nations and
15	helping those nations manage their natural and cul-
16	tural resources; and
17	(4) other factors the Secretary considers appro-
18	priate in determining the need for the Institute.
19	(c) FURTHER CONSIDERATIONS.—If the Secretary
20	determines that a need exists for the Institute as described
21	in subsection (a), the study shall evaluate—
22	(1) the costs associated with constructing, oper-
23	ating and maintaining the Institute;

1	(2) the feasibility of entering into a partnership
2	with an academic entity for purposes of establishing
3	and operating the Institute;
4	(3) potential locations for the Institute or proc-
5	esses for determining such locations;
6	(4) the appropriateness and feasibility of broad-
7	ening the purposes of the Institute to include sci-
8	entific research and education relevant to other land
9	management agencies; and
10	(5) any other matters related to the feasibility
11	of establishing and operating the Institute that the
12	Secretary deems appropriate.
13	(d) Recommendations.—Not later than 2 years
14	after funding is made available for the study, the Sec-
15	retary shall transmit the results of the study, including
16	the Secretary's recommendations, if any, for establishing
17	an Institute, to the Committee on Resources of the House
18	of Representatives and the Committee on Energy and
19	Natural Resources of the Senate.
