A BILL

To direct the Secretary of the Interior to conduct a pilot program under which up to 15 States may issue electronic Federal migratory bird hunting stamps.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Electronic Duck Stamp
- 5 Act of 2005".
- 6 SEC. 2. FINDINGS.
- 7 The Congress finds the following:
- 8 (1) On March 16, 1934, the Congress passed
- 9 and President Roosevelt signed the Act popularly

- known as the Duck Stamp Act (16 U.S.C. 718a et seq.), which requires all migratory waterfowl hunters 16 years of age or older to buy a Federal migratory bird hunting and conservation stamp annually.
 - (2) The Federal Duck Stamp program has become one of the most popular and successful conservation programs ever initiated. Because of it, our country again is teeming with migratory waterfowl and other wildlife that benefits from the wetland habitats.
 - (3) Today, 1.7 million migratory bird hunting and conservation stamps are sold each year. As of 2003, such stamps have generated more than \$600,000,000 in revenue that has been used to preserve over 5 million acres of migratory waterfowl habitat in the United States. Many of the more than 540 national wildlife refuges have been paid for all or in part with such revenue.

19 SEC. 3. DEFINITIONS.

- In this section:
- 21 (1) ACTUAL STAMP.—The term "actual stamp"
 22 means a Federal migratory-bird hunting and con23 servation stamp required under the Act of March
 24 16, 1934 (chapter 71; 16 U.S.C. 718a et seq., popu25 larly known as the Duck Stamp Act), that is printed

1	on paper and sold through a means in use imme-
2	diately before the enactment of this section.
3	(2) Automated licensing system.—The
4	term "automated licensing system"—
5	(A) means an electronic, computerized li-
6	censing system used by a State fish and wildlife
7	agency to issue hunting, fishing, and other as-
8	sociated licenses and products; and
9	(B) includes a point-of-sale, Internet, or
10	telephonic system used for such purpose.
11	(3) Electronic stamp.—The term "electronic
12	stamp" means an electronic version of an actual
13	stamp, that—
14	(A) is a unique identifier for the individual
15	to whom it is issued;
16	(B) can be printed on paper;
17	(C) is issued through a State automated li-
18	censing system that is authorized, under State
19	law and by the Secretary under this section, to
20	issue electronic stamps;
21	(D) is compatible with the hunting licens-
22	ing system of the State that issues the elec-
23	tronic stamp; and
24	(E) is described in the State application
25	approved by the Secretary under section 4(b).

SEC. 4. ELECTRONIC DUCK STAMP PILOT PROGRAM.

- 2 (a) REQUIREMENT TO CONDUCT PROGRAM.—The
- 3 Secretary of the Interior shall conduct a 3-year pilot pro-
- 4 gram under which up to 15 States authorized by the Sec-
- 5 retary may issue electronic stamps.
- 6 (b) Commencement and Duration of Pro-
- 7 GRAM.—The Secretary—
- 8 (1) shall use all means necessary to expedi-
- 9 tiously implement this section no later than one year
- after the beginning of the first full Federal migra-
- tory waterfowl hunting seasons after the date of the
- enactment of this Act; and
- 13 (2) shall carry out the pilot program for 3 Fed-
- eral migratory waterfowl hunting seasons.
- (c) Consultation.—The Secretary shall carry out
- 16 the program in consultation with State management agen-
- 17 cies.
- 18 SEC. 5. STATE APPLICATION.
- 19 (a) Approval of Application Required.—A
- 20 State may not participate in the pilot program under this
- 21 Act unless the Secretary has received and approved an ap-
- 22 plication submitted by the State in accordance with this
- 23 section.
- 24 (b) Contents of Application.—The Secretary
- 25 may not approve a State application unless the application
- 26 contains the following:

1	(1) A description of the format of the electronic
2	stamp that the State will issue under the pilot pro-
3	gram, including identifying features of licensee that
4	will be specified on the stamp.
5	(2) A description of any fee the State will
6	charge for issuance of an electronic stamp.
7	(3) A description of the process the State will
8	use to account for and transfer to the Secretary the
9	amounts collected by the State that are required to
10	be transferred to the Secretary under the program.
11	(4) The manner by which the State will trans-
12	mit electronic stamp customer data to the Secretary.
13	(5) The manner by which the State will deliver
14	actual stamps.
15	(6) The policies and procedures under which
16	the State will issue duplicate electronic stamps.
17	(7) Such other policies, procedures, and infor-
18	mation as may be reasonably required by the Sec-
19	retary.
20	(c) Publication of Deadlines, Eligibility Re-
21	QUIREMENTS, AND SELECTION CRITERIA.—The Secretary
22	shall, by not later than 30 days before receiving applica-
23	tions for participation in the pilot program, publish—

(1) deadlines for submission of applications to

participate in the program;

1	(2) eligibility requirements for participation in
2	the program; and
3	(3) criteria for selecting States to participate in
4	the program.
5	SEC. 6. STATE OBLIGATIONS AND AUTHORITIES.
6	(a) Delivery of Actual Stamp.—The Secretary
7	shall require that a State must provide an actual stamp
8	to each individual to whom the State sells an electronic
9	stamp under the pilot program, by not later than the date
10	the electronic stamp expires under section 7(c).
11	(b) Collection and Transfer of Electronic
12	STAMP REVENUE AND CUSTOMER INFORMATION.—
13	(1) REQUIREMENT TO TRANSMIT.—The Sec-
14	retary shall require that each State participating in
15	the pilot program State must collect and transmit to
16	the Secretary in accordance with this section—
17	(A) the first name, last name, and com-
18	plete mailing address of each individual that
19	purchases an electronic stamp from the State;
20	and
21	(B) the face value amount of each elec-
22	tronic stamp sold by the State.
23	(2) Time of transmittal.—The Secretary
24	shall require the transmittal under paragraph (1) to

- 1 be made with respect to sales of electronic stamps
- 2 by a State occurring in a month—
- 3 (A) by not later than the 15th day of the 4 subsequent month; or
- 5 (B) as otherwise specified in the applica-6 tion of the State approved by the Secretary
- 7 under section 5.
- 8 (3) Additional fees not affected.—This
- 9 section shall not apply to any fee collected by a
- State under subsection (c).
- 11 (c) Electronic Stamp Issuance Fee.—A State
- 12 participating in the pilot program may charge a reason-
- 13 able fee to cover costs incurred by the State in issuing
- 14 electronic stamps under the program, including costs of
- 15 delivery of actual stamps.
- 16 (d) Duplicate Electronic Stamps.—A State par-
- 17 ticipating in the pilot program may issue a duplicate elec-
- 18 tronic stamp to replace an electronic stamp issued by the
- 19 State that is lost or damaged.
- 20 (e) Limitation on Authority to Require Pur-
- 21 Chase of State License.—A State may not require
- 22 that an individual purchase a State hunting license as a
- 23 condition of issuing an electronic stamp under the pilot
- 24 program.

1	SEC. 7. ELECTRONIC STAMP REQUIREMENTS; RECOGNI-
2	TION OF ELECTRONIC STAMP.
3	(a) STAMP REQUIREMENTS.—The Secretary shall re-
4	quire that an electronic stamp issued by a State under
5	the pilot program must—
6	(1) have the same format as any other license,
7	validation, or privilege the State issues under its
8	automated licensing system; and
9	(2) specify identifying features of the licensee
10	that are adequate to enable Federal, State, and
11	other law enforcement officers to identify the holder.
12	(b) Recognition of Electronic Stamp.—Any
13	electronic stamp issued by a State under the pilot program
14	shall, during the effective period of the electronic stamp—
15	(1) bestow to the licensee the same privileges as
16	are bestowed by an actual stamp;
17	(2) be recognized nationally as a valid Federal
18	migratory bird hunting and conservation stamp; and
19	(3) authorize the licensee to hunt migratory wa-
20	terfowl in any other State, in accordance with the
21	laws of the other State governing such hunting.
22	(c) Duration.—An electronic stamp issued by a
23	State under the pilot program shall be valid for a period
24	agreed to by the State and the Secretary, which shall not
25	exceed 45 days.

1 SEC. 8. TERMINATION OF STATE PARTICIPATION.

2	Participation by a State in the pilot program may be
3	terminated—
4	(1) by the Secretary, if the Secretary—
5	(A) finds that the State has violated of the
6	terms the application of the State approved by
7	the Secretary under section 5; and
8	(B) provides to the State written notice of
9	such termination by not later than 30 days be-
10	fore the date of termination; or
11	(2) by the State, by providing written notice to
12	the Secretary by not later 30 days before the termi-
13	nation date.
