A BILL

To amend the Fair Labor Standards Act of 1938 to provide for an increase in the Federal minimum wage.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fair Minimum Wage
5 Act of 2005”.

6 **SEC. 2. MINIMUM WAGE.**

7 (a) IN GENERAL.—Section 6(a)(1) of the Fair Labor
8 Standards Act of 1938 (29 U.S.C. 206(a)(1)) is amended
9 to read as follows:

10 “(1) except as otherwise provided in this sec-
11 tion, not less than—

12 “(A) \$5.85 an hour, beginning on the 60th
13 day after the date of enactment of the Fair
14 Minimum Wage Act of 2005;

15 “(B) \$6.55 an hour, beginning 12 months
16 after that 60th day; and

17 “(C) \$7.25 an hour, beginning 24 months
18 after that 60th day;”.

19 (b) EFFECTIVE DATE.—The amendment made by
20 subsection (a) shall take effect 60 days after the date of
21 enactment of this Act.

1 **SEC. 3. APPLICABILITY OF MINIMUM WAGE TO THE COM-**
2 **MONWEALTH OF THE NORTHERN MARIANA**
3 **ISLANDS.**

4 (a) **IN GENERAL.**—Section 6 of the Fair Labor
5 Standards Act of 1938 (29 U.S.C. 206) shall apply to the
6 Commonwealth of the Northern Mariana Islands.

7 (b) **TRANSITION.**—Notwithstanding subsection (a),
8 the minimum wage applicable to the Commonwealth of the
9 Northern Mariana Islands under section 6(a)(1) of the
10 Fair Labor Standards Act of 1938 (29 U.S.C. 206(a)(1))
11 shall be—

12 (1) \$3.55 an hour, beginning on the 60th day
13 after the date of enactment of this Act; and

14 (2) increased by \$0.50 an hour (or such lesser
15 amount as may be necessary to equal the minimum
16 wage under section 6(a)(1) of such Act), beginning
17 6 months after the date of enactment of this Act
18 and every 6 months thereafter until the minimum
19 wage applicable to the Commonwealth of the North-
20 ern Mariana Islands under this subsection is equal
21 to the minimum wage set forth in such section.
