A BILL

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Honesty in Budgeting
5 Act of 2005”.

6 **SEC. 2. SENSE OF HOUSE TO ENCOURAGE HONESTY FOR**
7 **MEMBERS OF CONGRESS AND EXECUTIVE**
8 **BRANCH OFFICIALS.**

9 It is the sense of the House of Representatives that
10 Members of Congress, executive branch officials, and their
11 respective representatives should use on-budget numbers
12 when making public statements regarding the Federal
13 budget.

14 **SEC. 3. OFF-BUDGET STATUS OF OASDI AND HI TRUST**
15 **FUNDS.**

16 Notwithstanding any other provision of law, the re-
17 ceipts and disbursements of the Federal Old-Age and Sur-
18 vivors Insurance Trust Fund, the Federal Disability In-
19 surance Trust Fund, and the Federal Hospital Insurance
20 Trust Fund shall not be counted as new budget authority,
21 outlays, receipts, or deficit or surplus for purposes of—

- 22 (1) the budget of the United States Govern-
23 ment as submitted by the President,
24 (2) the congressional budget, or

1 (3) the Balanced Budget and Emergency Def-
 2 icit Control Act of 1985.

3 **SEC. 4. REMOVING SOCIAL SECURITY AND MEDICARE**
 4 **FROM BUDGET SURPLUS/DEFICIT PRO-**
 5 **NOUNCEMENTS.**

6 (a) REMOVING SOCIAL SECURITY AND MEDICARE
 7 FROM BUDGET SURPLUS/DEFICIT PRONOUNCEMENTS.—
 8 Title III of the Congressional Budget Act of 1974 is
 9 amended by adding at the end the following section:

10 “REMOVING SOCIAL SECURITY AND MEDICARE FROM
 11 BUDGET SURPLUS/DEFICIT PRONOUNCEMENTS

12 “Surplus or Deficit Totals

13 “SEC. 316. (a) Any official statement issued by the
 14 Office of Management and Budget or by the Congressional
 15 Budget Office of surplus or deficit totals of the budget
 16 of the United States Government as submitted by the
 17 President or of the surplus or deficit totals of the congres-
 18 sional budget, and any description of, or reference to, such
 19 totals in any official publication or material issued by ei-
 20 ther of such Offices, shall exclude the receipts and dis-
 21 bursements totals of the old-age survivors, and disability
 22 insurance program under title 2 of the Social Security Act
 23 and of the Federal Hospital Insurance Trust Fund under
 24 part A of title 18 of such Act. The Office of Management
 25 and Budget and the Congressional Budget Office shall
 26 issue separate reports on the outlays and revenues of the

1 Social Security trust funds and of the Federal Hospital
2 Insurance Trust Fund.

3 “Presentation of Budgetary Aggregates

4 “(b) For purposes of chapter 11 of title 31, United
5 States Code, or this Act, tables and other displays of
6 budgetary aggregates for the United States Government
7 of the Director of the Office of Management and Budget
8 or the Director of the Congressional Budget Office shall
9 not include receipts or disbursements referred to in sub-
10 section (a).”.

11 (b) CONFORMING AMENDMENT.—The table of con-
12 tents set forth in section 1(b) of the Congressional Budget
13 and Impoundment Control Act of 1974 is amended by
14 adding after the item relating to section 315 the following
15 new item:

“316. Removing Social Security and Medicare from budget surplus/deficit pro-
nouncements.”.
