## A BILL

To provide for the transmission to congressional committees of certain reports pertaining to international human rights law or related laws in connection with military detainees.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Detainee Treatment  
5 Accountability Act”.

1 **SEC. 2. TRANSMISSION TO CONGRESSIONAL COMMITTEES**  
2 **OF CERTAIN REPORTS PERTAINING TO**  
3 **INTERNATIONAL HUMAN RIGHTS LAW OR RE-**  
4 **LATED LAWS IN CONNECTION WITH MILI-**  
5 **TARY DETAINEES.**

6 (a) REQUIREMENT.—Within 15 days of receipt of a  
7 report described in subsection (b), the Secretary of De-  
8 fense shall transmit a copy of the report to each of the  
9 congressional committees specified in subsection (c). Any  
10 such report shall be provided on a confidential basis if  
11 such confidentiality is required by the entity providing the  
12 report to the Department of Defense.

13 (b) COVERED REPORTS.—A report referred to in sub-  
14 section (a) is any report provided to the Department of  
15 Defense on a confidential or exclusive basis by an entity  
16 outside the United States Government that pertains to  
17 treatment of detainees in custody of Department of De-  
18 fense personnel held at any location in the world in con-  
19 nection with any armed conflict, including the war on ter-  
20 ror.

21 (c) SPECIFIED COMMITTEES.—The congressional  
22 committees referred to in subsection (a) are the following:

23 (1) The Committee on Armed Services and the  
24 Committee on Foreign Relations of the Senate.

1           (2) The Committee on Armed Services and the  
2           Committee on International Relations of the House  
3           of Representatives.
