A BILL

To amend the Small Business Act to expand and improve the assistance provided by Small Business Development

Centers to Indian tribe members, Alaska Natives, and Native Hawaiians.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS AND PURPOSES.**

4 *(a) FINDINGS.—Congress finds the following:*

5 *(1) Approximately 60 percent of Indian tribe*
6 *members and Alaska Natives live on or adjacent to*
7 *Indian lands, which suffer from an average unem-*
8 *ployment rate of 45 percent.*

9 *(2) Indian tribe members and Alaska Natives*
10 *own more than 197,000 businesses and generate more*
11 *than \$34,000,000,000 in revenues. The service indus-*
12 *try accounted for 17 percent of these businesses (of*
13 *which 40 percent were engaged in business and per-*
14 *sonal services) and 15.1 percent of their total receipts.*
15 *The next largest was the construction industry (13.9*
16 *percent and 15.7 percent, respectively). The third*
17 *largest was the retail trade industry (7.5 percent and*
18 *13.4 percent, respectively).*

19 *(3) The number of businesses owned by Indian*
20 *tribe members and Alaska Natives grew by 84 percent*
21 *from 1992 to 1997, and their gross receipts grew by*
22 *179 percent in that period. This is compared to all*
23 *businesses which grew by 7 percent, and their total*
24 *gross receipts grew by 40 percent, in that period.*

1 (4) *The Small Business Development Center pro-*
2 *gram is cost effective. Clients receiving long-term*
3 *counseling under the program in 1998 generated ad-*
4 *ditional tax revenues of \$468,000,000, roughly 6 times*
5 *the cost of the program to the Federal Government.*

6 (5) *Using the existing infrastructure of the*
7 *Small Business Development Center program, small*
8 *businesses owned by Indian tribe members, Alaska*
9 *Natives, and Native Hawaiians receiving services*
10 *under the program will have a higher survival rate*
11 *than the average small business not receiving such*
12 *services.*

13 (6) *Business counseling and technical assistance*
14 *is critical on Indian lands where similar services are*
15 *scarce and expensive.*

16 (7) *Increased assistance through counseling*
17 *under the Small Business Development Center pro-*
18 *gram has been shown to reduce the default rate associ-*
19 *ated with lending programs of the Small Business*
20 *Administration.*

21 (b) *PURPOSES.—The purposes of this Act are as fol-*
22 *lows:*

23 (1) *To stimulate economies on Indian lands.*

24 (2) *To foster economic development on Indian*
25 *lands.*

1 (3) *To assist in the creation of new small busi-*
 2 *nesses owned by Indian tribe members, Alaska Na-*
 3 *tives, and Native Hawaiians and expand existing*
 4 *ones.*

5 (4) *To provide management, technical, and re-*
 6 *search assistance to small businesses owned by Indian*
 7 *tribe members, Alaska Natives, and Native Hawai-*
 8 *ians.*

9 (5) *To seek the advice of local Tribal Councils on*
 10 *where small business development assistance is most*
 11 *needed.*

12 (6) *To ensure that Indian tribe members, Alaska*
 13 *Natives, and Native Hawaiians have full access to ex-*
 14 *isting business counseling and technical assistance*
 15 *available through the Small Business Development*
 16 *Center program.*

17 **SEC. 2. SMALL BUSINESS DEVELOPMENT CENTER ASSIST-**
 18 **ANCE TO INDIAN TRIBE MEMBERS, ALASKA**
 19 **NATIVES, AND NATIVE HAWAIIANS.**

20 (a) *IN GENERAL.*—*Section 21(a) of the Small Business*
 21 *Act (15 U.S.C. 648(a)) is amended by adding at the end*
 22 *the following:*

23 “(8) **ADDITIONAL GRANT TO ASSIST INDIAN**
 24 **TRIBE MEMBERS, ALASKA NATIVES, AND NATIVE HA-**
 25 **WAIANS.—**

1 “(A) *IN GENERAL.*—Any applicant in an
2 eligible State that is funded by the Administra-
3 tion as a Small Business Development Center
4 may apply for an additional grant to be used
5 solely to provide services described in subsection
6 (c)(3) to assist with outreach, development, and
7 enhancement on Indian lands of small business
8 startups and expansions owned by Indian tribe
9 members, Alaska Natives, and Native Hawai-
10 ians.

11 “(B) *ELIGIBLE STATES.*—For purposes of
12 subparagraph (A), an eligible State is a State
13 that has a combined population of Indian tribe
14 members, Alaska Natives, and Native Hawaiians
15 that comprises at least 1 percent of the State’s
16 total population, as shown by the latest available
17 census.

18 “(C) *GRANT APPLICATIONS.*—An applicant
19 for a grant under subparagraph (A) shall submit
20 to the Administration an application that is in
21 such form as the Administration may require.
22 The application shall include information re-
23 garding the applicant’s goals and objectives for
24 the services to be provided using the grant, in-
25 cluding—

1 “(i) the capability of the applicant to
2 provide training and services to a rep-
3 resentative number of Indian tribe members,
4 Alaska Natives, and Native Hawaiians;

5 “(ii) the location of the Small Business
6 Development Center site proposed by the ap-
7 plicant;

8 “(iii) the required amount of grant
9 funding needed by the applicant to imple-
10 ment the program; and

11 “(iv) the extent to which the applicant
12 has consulted with local Tribal Councils.

13 “(D) *APPLICABILITY OF GRANT REQUIRE-*
14 *MENTS.—An applicant for a grant under sub-*
15 *paragraph (A) shall comply with all of the re-*
16 *quirements of this section, except that the match-*
17 *ing funds requirements under paragraph (4)(A)*
18 *shall not apply.*

19 “(E) *MAXIMUM AMOUNT OF GRANTS.—No*
20 *applicant may receive more than \$300,000 in*
21 *grants under this paragraph for one fiscal year.*

22 “(F) *REGULATIONS.—After providing notice*
23 *and an opportunity for comment and after con-*
24 *sulting with the Association recognized by the*
25 *Administration pursuant to paragraph (3)(A)*

1 *(but not later than 180 days after the date of en-*
2 *actment of this paragraph), the Administration*
3 *shall issue final regulations to carry out this*
4 *paragraph, including regulations that estab-*
5 *lish—*

6 *“(i) standards relating to educational,*
7 *technical, and support services to be pro-*
8 *vided by Small Business Development Cen-*
9 *ters receiving assistance under this para-*
10 *graph; and*

11 *“(ii) standards relating to any work*
12 *plan that the Administration may require a*
13 *Small Business Development Center receiv-*
14 *ing assistance under this paragraph to de-*
15 *velop.*

16 *“(G) DEFINITIONS.—In this section, the fol-*
17 *lowing definitions apply:*

18 *“(i) INDIAN LANDS.—The term ‘Indian*
19 *lands’ has the meaning given the term ‘In-*
20 *dian country’ in section 1151 of title 18,*
21 *United States Code, the meaning given the*
22 *term ‘Indian reservation’ in section 151.2 of*
23 *title 25, Code of Federal Regulations (as in*
24 *effect on the date of enactment of this para-*
25 *graph), and the meaning given the term*

1 “(II) a descendant of the aborigi-
2 nal people, who prior to 1778, occupied
3 and exercised sovereignty in the area
4 that now constitutes the State of Ha-
5 waii.

6 “(vi) *TRIBAL ORGANIZATION*.—The
7 term ‘tribal organization’ has the meaning
8 given that term in section 4(l) of the Indian
9 Self-Determination and Education Assist-
10 ance Act (25 U.S.C. 450b(l)).

11 “(H) *AUTHORIZATION OF APPROPRIA-*
12 *TIONS*.—There is authorized to be appropriated
13 to carry out this paragraph \$7,000,000 for each
14 of fiscal years 2006 through 2008.

15 “(I) *FUNDING LIMITATIONS*.—

16 “(i) *NONAPPLICABILITY OF CERTAIN*
17 *LIMITATIONS*.—Funding under this para-
18 graph shall be in addition to the dollar pro-
19 gram limitations specified in paragraph
20 (4).

21 “(ii) *LIMITATION ON USE OF FUNDS*.—
22 The Administration may carry out this
23 paragraph only with amounts appropriated
24 in advance specifically to carry out this
25 paragraph.”.

1 **SEC. 3. STATE CONSULTATION WITH TRIBAL ORGANIZA-**
2 **TIONS.**

3 *Section 21(c) of the Small Business Act (15 U.S.C.*
4 *648(c)) is amended by adding at the end the following:*

5 *“(9) ADVICE OF LOCAL TRIBAL ORGANIZA-*
6 *TIONS.—A Small Business Development Center re-*
7 *ceiving a grant under this section shall request the*
8 *advice of tribal organization on how best to provide*
9 *assistance to Indian tribe members, Alaska Natives,*
10 *and Native Hawaiians and where to locate satellite*
11 *centers to provide such assistance.”.*
