AN ACT

Making appropriations for the Departments of Transportation, Treasury, and Housing and Urban Development, the Judiciary, District of Columbia, and independent agencies for the fiscal year ending September 30, 2006, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 Departments of Transportation, Treasury, and Housing
6 and Urban Development, the Judiciary, District of Colum-
7 bia, and independent agencies for the fiscal year ending
8 September 30, 2006, and for other purposes, namely:

9 TITLE I

10 DEPARTMENT OF TRANSPORTATION

11 OFFICE OF THE SECRETARY

12 SALARIES AND EXPENSES

13 For necessary expenses of the Office of the Secretary,
14 \$84,913,000 (increased by \$250,000) (reduced by
15 \$17,339,000), of which not to exceed \$2,198,000 shall be
16 available for the immediate Office of the Secretary; not
17 to exceed \$698,000 shall be available for the immediate
18 Office of the Deputy Secretary; not to exceed \$15,183,000
19 (increased by \$250,000) shall be available for the Office
20 of the General Counsel; not to exceed \$11,680,000 shall
21 be available for the Office of the Under Secretary of
22 Transportation for Policy; not to exceed \$7,593,000 shall
23 be available for the Office of the Assistant Secretary for
24 Budget and Programs; not to exceed \$2,052,000 (reduced
25 by \$2,052,000) shall be available for the Office of the As-

1 sistant Secretary for Governmental Affairs; not to exceed
2 \$23,139,000 shall be available for the Office of the Assist-
3 ant Secretary for Administration; not to exceed
4 \$1,910,000 (reduced by \$1,910,000) shall be available for
5 the Office of Public Affairs; not to exceed \$1,442,000 (re-
6 duced by \$1,422,000) shall be available for the Office of
7 the Executive Secretariat; not to exceed \$697,000 shall
8 be available for the Board of Contract Appeals; not to ex-
9 ceed \$1,265,000 shall be available for the Office of Small
10 and Disadvantaged Business Utilization; not to exceed
11 \$2,033,000 for the Office of Intelligence and Security; not
12 to exceed \$3,128,000 shall be available for the Office of
13 Emergency Transportation; and not to exceed
14 \$11,895,000 (reduced by \$11,895,000) shall be available
15 for the Office of the Chief Information Officer: *Provided*,
16 That the Secretary of Transportation is authorized to
17 transfer funds appropriated for any office of the Office
18 of the Secretary to any other office of the Office of the
19 Secretary: *Provided further*, That no appropriation for any
20 office shall be increased or decreased by more than 5 per-
21 cent by all such transfers: *Provided further*, That notice
22 of any change in funding greater than 5 percent shall be
23 submitted for approval to the House and Senate Commit-
24 tees on Appropriations: *Provided further*, That not to ex-
25 ceed \$60,000 (reduced by \$60,000) shall be for allocation

1 within the Department for official reception and represen-
 2 tation expenses as the Secretary may determine: *Provided*
 3 *further*, That notwithstanding any other provision of law,
 4 excluding fees authorized in Public Law 107–71, there
 5 may be credited to this appropriation up to \$2,500,000
 6 in funds received in user fees: *Provided further*, That none
 7 of the funds provided in this Act shall be available for
 8 the position of Assistant Secretary for Public Affairs.

9 OFFICE OF CIVIL RIGHTS

10 For necessary expenses of the Office of Civil Rights,
 11 \$8,550,000.

12 TRANSPORTATION PLANNING, RESEARCH, AND

13 DEVELOPMENT

14 For necessary expenses for conducting transportation
 15 planning, research, systems development, development ac-
 16 tivities, and making grants, to remain available until ex-
 17 pended, \$40,613,000 (reduced by \$31,583,000).

18 WORKING CAPITAL FUND

19 Necessary expenses for operating costs and capital
 20 outlays of the Working Capital Fund, not to exceed
 21 \$120,014,000, shall be paid from appropriations made
 22 available to the Department of Transportation: *Provided*,
 23 That such services shall be provided on a competitive basis
 24 to entities within the Department of Transportation: *Pro-*
 25 *vided further*, That the above limitation on operating ex-
 26 penses shall not apply to non-DOT entities: *Provided fur-*

1 *ther*, That no funds appropriated in this Act to an agency
2 of the Department shall be transferred to the Working
3 Capital Fund without the approval of the agency modal
4 administrator: *Provided further*, That no assessments may
5 be levied against any program, budget activity, subactivity
6 or project funded by this Act unless notice of such assess-
7 ments and the basis therefor are presented to the House
8 and Senate Committees on Appropriations and are ap-
9 proved by such Committees.

10 MINORITY BUSINESS RESOURCE CENTER PROGRAM

11 For the cost of guaranteed loans, \$500,000, as au-
12 thorized by 49 U.S.C. 332: *Provided*, That such costs, in-
13 cluding the cost of modifying such loans, shall be as de-
14 fined in section 502 of the Congressional Budget Act of
15 1974: *Provided further*, That these funds are available to
16 subsidize total loan principal, any part of which is to be
17 guaranteed, not to exceed \$18,367,000. In addition, for
18 administrative expenses to carry out the guaranteed loan
19 program, \$400,000.

20 MINORITY BUSINESS OUTREACH

21 For necessary expenses of Minority Business Re-
22 source Center outreach activities, \$3,000,000, to remain
23 available until September 30, 2007: *Provided*, That not-
24 withstanding 49 U.S.C. 332, these funds may be used for
25 business opportunities related to any mode of transpor-
26 tation.

1 PAYMENTS TO AIR CARRIERS

2 (AIRPORT AND AIRWAY TRUST FUND)

3 In addition to funds made available from any other
4 source to carry out the essential air service program under
5 49 U.S.C. 41731–41742, \$54,000,000 to remain available
6 until expended: *Provided*, That the Secretary may transfer
7 amounts appropriated to the Federal Aviation Administra-
8 tion under any heading in this Act or otherwise available
9 to the Federal Aviation Administration, to make such
10 amounts available for obligation and expenditure for the
11 essential air service program, in satisfaction of the re-
12 quirements of section 41742(a)(1) of title 49, United
13 States Code, in advance of the collection of fees under sec-
14 tion 45301 of title 49, United States Code: *Provided fur-*
15 *ther*, That the Secretary shall reimburse such amounts to
16 the Federal Aviation Administration proportionally by
17 transfer, to the extent possible, from amounts credited to
18 the account established under section 45303 of title 49,
19 United States Code, as such fees are collected during the
20 fiscal year: *Provided further*, That, in determining between
21 or among carriers competing to provide service to a com-
22 munity, the Secretary may consider the relative subsidy
23 requirements of the carriers.

24 NEW HEADQUARTERS BUILDING

25 For necessary expenses of the Department of Trans-
26 portation's new headquarters building and related serv-

1 ices, \$100,000,000 (reduced by \$25,000,000) (reduced by
2 \$20,000,000), to remain available until expended.

3 FEDERAL AVIATION ADMINISTRATION

4 OPERATIONS

5 For necessary expenses of the Federal Aviation Ad-
6 ministration, not otherwise provided for, including oper-
7 ations and research activities related to commercial space
8 transportation, administrative expenses for research and
9 development, establishment of air navigation facilities, the
10 operation (including leasing) and maintenance of aircraft,
11 subsidizing the cost of aeronautical charts and maps sold
12 to the public, lease or purchase of passenger motor vehi-
13 cles for replacement only, in addition to amounts made
14 available by Public Law 108–176, \$8,042,920,000 (in-
15 creased by \$263,000,000), of which \$4,986,000,000 shall
16 be derived from the Airport and Airway Trust Fund, of
17 which not to exceed \$6,424,229,000 shall be available for
18 air traffic services activities; not to exceed \$951,042,000
19 (increased by \$263,000,000) shall be available for aviation
20 regulation and certification activities; not to exceed
21 \$222,171,000 shall be available for research and acquisi-
22 tion activities; not to exceed \$11,759,000 shall be available
23 for commercial space transportation activities; not to ex-
24 ceed \$50,583,000 shall be available for financial services
25 activities; not to exceed \$69,943,000 shall be available for

1 human resources program activities; not to exceed
2 \$150,744,000 shall be available for region and center op-
3 erations and regional coordination activities; not to exceed
4 \$140,337,000 shall be available for staff offices; and not
5 to exceed \$36,612,000 shall be available for information
6 services: *Provided*, That none of the funds in this Act shall
7 be available for the Federal Aviation Administration to fi-
8 nalize or implement any regulation that would promulgate
9 new aviation user fees not specifically authorized by law
10 after the date of the enactment of this Act: *Provided fur-*
11 *ther*, That there may be credited to this appropriation
12 funds received from States, counties, municipalities, for-
13 eign authorities, other public authorities, and private
14 sources, for expenses incurred in the provision of agency
15 services, including receipts for the maintenance and oper-
16 ation of air navigation facilities, and for issuance, renewal
17 or modification of certificates, including airman, aircraft,
18 and repair station certificates, or for tests related thereto,
19 or for processing major repair or alteration forms: *Pro-*
20 *vided further*, That of the funds appropriated under this
21 heading, not less than \$7,500,000 shall be for the contract
22 tower cost-sharing program: *Provided further*, That funds
23 may be used to enter into a grant agreement with a non-
24 profit standard-setting organization to assist in the devel-
25 opment of aviation safety standards: *Provided further*,

1 That none of the funds in this Act shall be available for
 2 new applicants for the second career training program:
 3 *Provided further*, That none of the funds in this Act shall
 4 be available for paying premium pay under 5 U.S.C.
 5 5546(a) to any Federal Aviation Administration employee
 6 unless such employee actually performed work during the
 7 time corresponding to such premium pay: *Provided fur-*
 8 *ther*, That none of the funds in this Act may be obligated
 9 or expended to operate a manned auxiliary flight service
 10 station in the contiguous United States: *Provided further*,
 11 That none of the funds in this Act for aeronautical chart-
 12 ing and cartography are available for activities conducted
 13 by, or coordinated through, the Working Capital Fund:
 14 *Provided further*, That none of the funds in this Act may
 15 be obligated or expended for an employee of the Federal
 16 Aviation Administration to purchase a store gift card or
 17 gift certificate through use of a Government-issued credit
 18 card. In addition, \$150,000,000 (reduced by \$59,000,000)
 19 for transition costs associated with OMB Circular A-76
 20 Flight Service Station competition.

21 FACILITIES AND EQUIPMENT

22 (AIRPORT AND AIRWAY TRUST FUND)

23 For necessary expenses, not otherwise provided for,
 24 for acquisition, establishment, technical support services,
 25 improvement by contract or purchase, and hire of air navi-
 26 gation and experimental facilities and equipment, as au-

1 thorized under part A of subtitle VII of title 49, United
2 States Code, including initial acquisition of necessary sites
3 by lease or grant; engineering and service testing, includ-
4 ing construction of test facilities and acquisition of nec-
5 essary sites by lease or grant; construction and furnishing
6 of quarters and related accommodations for officers and
7 employees of the Federal Aviation Administration sta-
8 tioned at remote localities where such accommodations are
9 not available; and the purchase, lease, or transfer of air-
10 craft from funds available under this heading; to be de-
11 rived from the Airport and Airway Trust Fund,
12 \$3,053,000,000, of which \$2,618,000,000 shall remain
13 available until September 30, 2008, and of which
14 \$435,000,000 shall remain available until September 30,
15 2006: *Provided*, That there may be credited to this appro-
16 priation funds received from States, counties, municipali-
17 ties, other public authorities, and private sources, for ex-
18 penses incurred in the establishment and modernization
19 of air navigation facilities: *Provided further*, That upon ini-
20 tial submission to the Congress of the fiscal year 2007
21 President's budget, the Secretary of Transportation shall
22 transmit to the Congress a comprehensive capital invest-
23 ment plan for the Federal Aviation Administration which
24 includes funding for each budget line item for fiscal years
25 2007 through 2011, with total funding for each year of

1 the plan constrained to the funding targets for those years
 2 as estimated and approved by the Office of Management
 3 and Budget.

4 RESEARCH, ENGINEERING, AND DEVELOPMENT

5 (AIRPORT AND AIRWAY TRUST FUND)

6 For necessary expenses, not otherwise provided for,
 7 for research, engineering, and development, as authorized
 8 under part A of subtitle VII of title 49, United States
 9 Code, including construction of experimental facilities and
 10 acquisition of necessary sites by lease or grant,
 11 \$130,000,000, to be derived from the Airport and Airway
 12 Trust Fund and to remain available until September 30,
 13 2008: *Provided*, That there may be credited to this appro-
 14 priation funds received from States, counties, municipali-
 15 ties, other public authorities, and private sources, for ex-
 16 penses incurred for research, engineering, and develop-
 17 ment.

18 GRANTS-IN-AID FOR AIRPORTS

19 (LIQUIDATION OF CONTRACT AUTHORIZATION)

20 (LIMITATION ON OBLIGATIONS)

21 (AIRPORT AND AIRWAY TRUST FUND)

22 (INCLUDING RESCISSION)

23 For liquidation of obligations incurred for grants-in-
 24 aid for airport planning and development, and noise com-
 25 patibility planning and programs as authorized under sub-
 26 chapter I of chapter 471 and subchapter I of chapter 475

1 of title 49, United States Code, and under other law au-
 2 thorizing such obligations; for procurement, installation,
 3 and commissioning of runway incursion prevention devices
 4 and systems at airports of such title; \$3,600,000,000 to
 5 be derived from the Airport and Airway Trust Fund and
 6 to remain available until expended: *Provided*, That none
 7 of the funds under this heading shall be available for the
 8 planning or execution of programs the obligations for
 9 which are in excess of \$3,600,000,000 in fiscal year 2006,
 10 notwithstanding section 47117(g) of title 49, United
 11 States Code: *Provided further*, That none of the funds
 12 under this heading shall be available for the replacement
 13 of baggage conveyor systems, reconfiguration of terminal
 14 baggage areas, or other airport improvements that are
 15 necessary to install bulk explosive detection systems: *Pro-*
 16 *vided further*, That of the amount authorized for the fiscal
 17 year ending September 30, 2005, under sections 48103
 18 and 48112 of title 49, United States Code, \$469,000,000
 19 are rescinded.

20 ADMINISTRATIVE PROVISIONS—FEDERAL AVIATION

21 ADMINISTRATION

22 SEC. 101. Notwithstanding any other provision of
 23 law, airports may transfer without consideration to the
 24 Federal Aviation Administration (FAA) instrument land-
 25 ing systems (along with associated approach lighting
 26 equipment and runway visual range equipment) which

1 conform to FAA design and performance specifications,
2 the purchase of which was assisted by a Federal airport-
3 aid program, airport development aid program or airport
4 improvement program grant: *Provided*, That, the Federal
5 Aviation Administration shall accept such equipment,
6 which shall thereafter be operated and maintained by FAA
7 in accordance with agency criteria.

8 SEC. 102. None of the funds in this Act may be used
9 to compensate in excess of 375 technical staff-years under
10 the federally funded research and development center con-
11 tract between the Federal Aviation Administration and the
12 Center for Advanced Aviation Systems Development dur-
13 ing fiscal year 2005.

14 SEC. 103. None of the funds in this Act shall be used
15 to pursue or adopt guidelines or regulations requiring air-
16 port sponsors to provide to the Federal Aviation Adminis-
17 tration without cost building construction, maintenance,
18 utilities and expenses, or space in airport sponsor-owned
19 buildings for services relating to air traffic control, air
20 navigation, or weather reporting: *Provided*, That the pro-
21 hibition of funds in this section does not apply to negotia-
22 tions between the agency and airport sponsors to achieve
23 agreement on “below-market” rates for these items or to
24 grant assurances that require airport sponsors to provide

1 land without cost to the FAA for air traffic control facili-
2 ties.

3 SEC. 104. None of the funds appropriated or limited
4 by this Act may be used to change weight restrictions or
5 prior permission rules at Teterboro Airport in Teterboro,
6 New Jersey.

7 SEC. 105. (a) Section 44302(f)(1) of title 49, United
8 States Code, is amended by striking “2005,” each place
9 it appears and inserting “2006,”.

10 (b) Section 44303(b) of such title is amended by
11 striking “2005,” and inserting “2006,”.

12 SEC. 106. None of the funds made available in this
13 Act shall be used for engineering work related to an addi-
14 tional runway at Louis Armstrong New Orleans Inter-
15 national Airport.

16 FEDERAL HIGHWAY ADMINISTRATION

17 LIMITATION ON ADMINISTRATIVE EXPENSES

18 Necessary expenses for administration and operation
19 of the Federal Highway Administration, not to exceed
20 \$359,529,000 shall be paid in accordance with law from
21 appropriations made available by this Act to the Federal
22 Highway Administration together with advances and reim-
23 bursements received by the Federal Highway Administra-
24 tion.

FEDERAL-AID HIGHWAYS
(LIMITATION ON OBLIGATIONS)
(HIGHWAY TRUST FUND)

None of the funds in this Act shall be available for the implementation or execution of programs, the obligations for which are in excess of \$36,287,100,000 for Federal-aid highways and highway safety construction programs for fiscal year 2006: *Provided*, That within the \$36,287,100,000 obligation limitation on Federal-aid highways and highway safety construction programs, not more than \$485,000,000 shall be available for the implementation or execution of programs for transportation research (as authorized by title 23, United States Code, as amended; section 5505 of title 49, United States Code, as amended; and sections 5112 and 5204–5209 of Public Law 105–178, as amended) for fiscal year 2006: *Provided further*, That this limitation on transportation research programs shall not apply to any authority previously made available for obligation: *Provided further*, That the Secretary may, as authorized by sections 183 and 184 of title 23, United States Code, charge and collect a fee, from the applicant for a direct loan, guaranteed loan, or line of credit to cover the cost of the financial and legal analyses performed on behalf of the Department: *Provided further*, That such fees are available until expended to pay for such costs: *Provided further*, That such amounts are

1 in addition to administrative expenses that are also avail-
 2 able for such purpose, and are not subject to any obliga-
 3 tion limitation or the limitation on administrative expenses
 4 under 23 U.S.C. 188.

5 FEDERAL-AID HIGHWAYS

6 (LIQUIDATION OF CONTRACT AUTHORIZATION)

7 (HIGHWAY TRUST FUND)

8 For carrying out the provisions of title 23, United
 9 States Code, that are attributable to Federal-aid high-
 10 ways, including the National Scenic and Recreational
 11 Highway as authorized by 23 U.S.C. 148, not otherwise
 12 provided, including reimbursement for sums expended
 13 pursuant to the provisions of 23 U.S.C. 308,
 14 \$36,000,000,000 or so much thereof as may be available
 15 in and derived from the Highway Trust Fund (other than
 16 the Mass Transit Account), to remain available until ex-
 17 pended.

18 ADMINISTRATIVE PROVISIONS—FEDERAL HIGHWAY

19 ADMINISTRATION

20 SEC. 110. Notwithstanding 31 U.S.C. 3302, funds re-
 21 ceived by the Bureau of Transportation Statistics from the
 22 sale of data products, for necessary expenses incurred pur-
 23 suant to 49 U.S.C. 111 may be credited to the Federal-
 24 aid highways account for the purpose of reimbursing the
 25 Bureau for such expenses: *Provided*, That such funds shall

1 be subject to the obligation limitation for Federal-aid
 2 highways and highway safety construction.

3 FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION

4 MOTOR CARRIER SAFETY OPERATIONS AND PROGRAMS

5 (LIMITATION ON OBLIGATIONS)

6 (LIQUIDATION OF CONTRACT AUTHORIZATION)

7 (HIGHWAY TRUST FUND)

8 (INCLUDING TRANSFER OF FUNDS)

9 None of the funds provided for expenses for adminis-
 10 tration of motor carrier safety programs and motor carrier
 11 safety research shall be available for fiscal year 2006, the
 12 obligations for which are in excess of \$215,000,000: *Pro-*
 13 *vided*, That for payment of obligations incurred to pay ad-
 14 ministrative expenses of and motor carrier research by the
 15 Federal Motor Carrier Safety Administration,
 16 \$215,000,000, to be derived from the Highway Trust
 17 Fund (other than the Mass Transit Account), together
 18 with advances and reimbursements received by the Fed-
 19 eral Motor Carrier Safety Administration, the sum of
 20 which shall remain available until expended.

21 NATIONAL MOTOR CARRIER SAFETY PROGRAM

22 LIQUIDATION OF CONTRACT AUTHORIZATION

23 (LIMITATION ON OBLIGATIONS)

24 (HIGHWAY TRUST FUND)

25 For payment of obligations incurred in carrying out
 26 motor carrier safety grant programs in accordance with

1 title 49, United States Code, \$286,000,000, to be derived
 2 from the Highway Trust Fund (other than the Mass Tran-
 3 sit Account) and to remain available until expended: *Pro-*
 4 *vided*, That none of the funds provided for the implemen-
 5 tation or execution of motor carrier safety grant programs
 6 authorized by title 49, United States Code, shall be avail-
 7 able for fiscal year 2006, the obligations for which are in
 8 excess of \$286,000,000.

9 ADMINISTRATIVE PROVISION—FEDERAL MOTOR CARRIER
 10 SAFETY ADMINISTRATION

11 SEC. 120. Funds appropriated or limited in this Act
 12 shall be subject to the terms and conditions stipulated in
 13 section 350 of Public Law 107–87, including that the Sec-
 14 retary submit a report to the House and Senate Appro-
 15 priations Committees annually on the safety and security
 16 of transportation into the United States by Mexico-domi-
 17 ciled motor carriers.

18 NATIONAL HIGHWAY TRAFFIC SAFETY ADMINISTRATION
 19 OPERATIONS AND RESEARCH

20 For expenses necessary to discharge the functions of
 21 the Secretary, with respect to traffic and highway safety
 22 under chapter 301 of title 49, United States Code, and
 23 part C of subtitle VI of title 49, United States Code,
 24 \$152,367,000, of which \$135,367,000 is to remain avail-
 25 able until September 30, 2008, and \$17,000,000 is to re-
 26 main available until expended: *Provided*, That none of the

1 funds appropriated by this Act may be obligated or ex-
 2 pended to plan, finalize, or implement any rulemaking to
 3 add to section 575.104 of title 49 of the Code of Federal
 4 Regulations any requirement pertaining to a grading
 5 standard that is different from the three grading stand-
 6 ards (treadwear, traction, and temperature resistance) al-
 7 ready in effect.

8 OPERATIONS AND RESEARCH
 9 (LIQUIDATION OF CONTRACT AUTHORIZATION)
 10 (LIMITATION ON OBLIGATIONS)
 11 (HIGHWAY TRUST FUND)

12 For payment of obligations incurred in carrying out
 13 the provisions of 23 U.S.C. 403, to remain available until
 14 expended, \$75,000,000, to be derived from the Highway
 15 Trust Fund: *Provided*, That none of the funds in this Act
 16 shall be available for the planning or execution of pro-
 17 grams the total obligations for which, in fiscal year 2006,
 18 are in excess of \$75,000,000 for programs authorized
 19 under 23 U.S.C. 403.

20 NATIONAL DRIVER REGISTER
 21 (LIQUIDATION OF CONTRACT AUTHORIZATION)
 22 (LIMITATION ON OBLIGATIONS)
 23 (HIGHWAY TRUST FUND)

24 For payment of obligations incurred in carrying out
 25 chapter 303 of title 49, United States Code, \$4,000,000,
 26 to be derived from the Highway Trust Fund: *Provided*,

1 That none of the funds in this Act shall be available for
 2 the implementation or execution of programs the obliga-
 3 tions for which are in excess of \$4,000,000 for the Na-
 4 tional Driver Register authorized under chapter 303 of
 5 title 49, United States Code.

6 HIGHWAY TRAFFIC SAFETY GRANTS
 7 (LIQUIDATION OF CONTRACT AUTHORIZATION)
 8 (LIMITATION ON OBLIGATIONS)
 9 (HIGHWAY TRUST FUND)

10 For payment of obligations incurred in carrying out
 11 the provisions of 23 U.S.C. 402, 405, and 410, to remain
 12 available until expended, \$551,000,000 to be derived from
 13 the Highway Trust Fund and to remain available until
 14 expended: *Provided*, That none of the funds in this Act
 15 shall be available for the planning or execution of pro-
 16 grams the total obligations for which, in fiscal year 2006,
 17 are in excess of \$551,000,000 for programs authorized
 18 under 23 U.S.C. 402, 405, and 410, and the State Traffic
 19 Safety Information Systems Improvements, High Visi-
 20 bility Enforcement, Child Safety and Booster Seat, and

9 change in funding greater than 2 percent shall be sub-
10 mitted for approval to the House and Senate Committees
11 on Appropriations: *Provided further*, That of the amount
12 appropriated under this heading, not to exceed
13 \$3,000,000, to remain available until September 30, 2007,
14 is for information technology modernization requirements;
15 not to exceed \$100,000 is for official reception and rep-
16 resentation expenses; and not to exceed \$258,000 is for
17 unforeseen emergencies of a confidential nature, to be allo-
18 cated and expended under the direction of the Secretary
19 of the Treasury and to be accounted for solely on his cer-

7 For development and acquisition of automatic data
8 processing equipment, software, and services for the De-
9 partment of the Treasury, \$21,412,000, to remain avail-
10 able until September 30, 2008: *Provided*, That these funds
11 shall be transferred to accounts and in amounts as nec-
12 essary to satisfy the requirements of the Department's of-
13 fices, bureaus, and other organizations: *Provided further*,
14 That this transfer authority shall be in addition to any
15 other transfer authority provided in this Act: *Provided fur-*
16 *ther*, That none of the funds appropriated shall be used
17 to support or supplement "Internal Revenue Service, In-
18 formation Systems" or "Internal Revenue Service, Busi-
19 ness Systems Modernization".

20 OFFICE OF INSPECTOR GENERAL

21 SALARIES AND EXPENSES

22 For necessary expenses of the Office of Inspector
23 General in carrying out the provisions of the Inspector
24 General Act of 1978, as amended, not to exceed
25 \$2,000,000 for official travel expenses, including hire of
26 passenger motor vehicles; and not to exceed \$100,000 for

1 unforeseen emergencies of a confidential nature, to be allo-
 2 cated and expended under the direction of the Inspector
 3 General of the Treasury, \$17,000,000, of which not to ex-
 4 ceed \$2,500 shall be available for official reception and
 5 representation expenses.

6 TREASURY INSPECTOR GENERAL FOR TAX

7 ADMINISTRATION

8 SALARIES AND EXPENSES

9 For necessary expenses of the Treasury Inspector
 10 General for Tax Administration in carrying out the In-
 11 spector General Act of 1978, as amended, including pur-
 12 chase (not to exceed 150 for replacement only for police-
 13 type use) and hire of passenger motor vehicles (31 U.S.C.
 14 1343(b)); services authorized by 5 U.S.C. 3109, at such
 15 rates as may be determined by the Inspector General for
 16 Tax Administration; not to exceed \$6,000,000 for official
 17 travel expenses; and not to exceed \$500,000 for unfore-
 18 seen emergencies of a confidential nature, to be allocated
 19 and expended under the direction of the Inspector General

8 available until September 30, 2008.

9 FINANCIAL CRIMES ENFORCEMENT NETWORK
10 SALARIES AND EXPENSES

11 For necessary expenses of the Financial Crimes En-
12 forcement Network, including hire of passenger motor ve-
13 hicles; travel expenses of non-Federal law enforcement
14 personnel to attend meetings concerned with financial in-
15 telligence activities, law enforcement, and financial regula-
16 tion; not to exceed \$14,000 for official reception and rep-
17 resentation expenses; and for assistance to Federal law en-
18 forcement agencies, with or without reimbursement,
19 \$73,630,000 of which not to exceed \$6,944,000 shall re-
20 main available until September 30, 2008; and of which
21 \$8,521,000 shall remain available until September 30,
22 2007: *Provided*, That funds appropriated in this account
23 may be used to procure personal services contracts.

1 FINANCIAL MANAGEMENT SERVICE

2 SALARIES AND EXPENSES

3 For necessary expenses of the Financial Management
4 Service, \$236,243,000, of which not to exceed \$9,220,000
5 shall remain available until September 30, 2008, for infor-
6 mation systems modernization initiatives; and of which not
7 to exceed \$2,500 shall be available for official reception
8 and representation expenses.

9 ALCOHOL AND TOBACCO TAX AND TRADE BUREAU

10 SALARIES AND EXPENSES

11 For necessary expenses of carrying out section 1111
12 of the Homeland Security Act of 2002, including hire of
13 passenger motor vehicles, \$91,126,000; of which not to ex-
14 ceed \$6,000 for official reception and representation ex-
15 penses; not to exceed \$50,000 for cooperative research and
16 development programs for laboratory services; and provi-
17 sion of laboratory assistance to State and local agencies
18 with or without reimbursement.

19 UNITED STATES MINT

20 UNITED STATES MINT PUBLIC ENTERPRISE FUND

21 Pursuant to section 5136 of title 31, United States
22 Code, the United States Mint is provided funding through
23 the United States Mint Public Enterprise Fund for costs
24 associated with the production of circulating coins, numis-
25 matic coins, and protective services, including both oper-

1 ating expenses and capital investments. The aggregate
2 amount of new liabilities and obligations incurred during
3 fiscal year 2006 under such section 5136 for circulating
4 coinage and protective service capital investments of the
5 United States Mint shall not exceed \$36,900,000.

6 BUREAU OF THE PUBLIC DEBT

7 ADMINISTERING THE PUBLIC DEBT

8 For necessary expenses connected with any public-
9 debt issues of the United States, \$179,923,000, of which
10 not to exceed \$2,500 shall be available for official recep-
11 tion and representation expenses, and of which not to ex-
12 ceed \$2,000,000 shall remain available until expended for
13 systems modernization: *Provided*, That the sum appro-
14 priated herein from the General Fund for fiscal year 2006
15 shall be reduced by not more than \$3,000,000 as definitive
16 security issue fees and Treasury Direct Investor Account
17 Maintenance fees are collected, so as to result in a final
18 fiscal year 2006 appropriation from the General Fund es-
19 timated at \$176,923,000. In addition, \$70,000 to be de-
20 rived from the Oil Spill Liability Trust Fund to reimburse
21 the Bureau for administrative and personnel expenses for
22 financial management of the Fund, as authorized by sec-
23 tion 1012 of Public Law 101–380.

1 COMMUNITY DEVELOPMENT FINANCIAL INSTITUTIONS
2 FUND PROGRAM ACCOUNT

3 To carry out the Community Development Banking
4 and Financial Institutions Act of 1994, including services
5 authorized by 5 U.S.C. 3109, but at rates for individuals
6 not to exceed the per diem rate equivalent to the rate for
7 ES-3, \$55,000,000, to remain available until September
8 30, 2006, of which up to \$13,000,000 may be used for
9 administrative expenses, including administration of the
10 New Markets Tax Credit, up to \$6,000,000 may be used
11 for the cost of direct loans, and up to \$250,000 may be
12 used for administrative expenses to carry out the direct
13 loan program: *Provided*, That the cost of direct loans, in-
14 cluding the cost of modifying such loans, shall be as de-
15 fined in section 502 of the Congressional Budget Act of
16 1974, as amended: *Provided further*, That these funds are
17 available to subsidize gross obligations for the principal
18 amount of direct loans not to exceed \$11,000,000.

19 INTERNAL REVENUE SERVICE
20 PROCESSING, ASSISTANCE, AND MANAGEMENT

21 For necessary expenses of the Internal Revenue Serv-
22 ice for pre-filing taxpayer assistance and education, filing
23 and account services, shared services support, general
24 management and administration; and services as author-
25 ized by 5 U.S.C. 3109, at such rates as may be determined

1 by the Commissioner, \$4,181,520,000, of which up to
 2 \$4,100,000 shall be for the Tax Counseling for the Elderly
 3 Program, of which \$8,000,000 shall be available for low-
 4 income taxpayer clinic grants, of which \$1,500,000 shall
 5 be for the Internal Revenue Service Oversight Board; and
 6 of which not to exceed \$25,000 shall be for official recep-
 7 tion and representation expenses.

8 TAX LAW ENFORCEMENT

9 (INCLUDING TRANSFER OF FUNDS)

10 For necessary expenses of the Internal Revenue Serv-
 11 ice for determining and establishing tax liabilities; pro-
 12 viding litigation support; conducting criminal investigation
 13 and enforcement activities; securing unfiled tax returns;
 14 collecting unpaid accounts; conducting a document match-
 15 ing program; resolving taxpayer problems through prompt
 16 identification, referral and settlement; expanded customer
 17 service and public outreach programs, strengthened en-
 18 forcement activities, and enhanced research efforts to re-
 19 duce erroneous filings associated with the earned income
 20 tax credit; compiling statistics of income and conducting
 21 compliance research; purchase (for police-type use, not to
 22 exceed 850) and hire of passenger motor vehicles (31
 23 U.S.C. 1343(b)); and services as authorized by 5 U.S.C.
 24 3109, at such rates as may be determined by the Commis-
 25 sioner, \$4,541,466,000 (increased by \$38,750,000), of
 26 which \$55,584,000 shall be for the Interagency Crime and

5 propriation solely for the purposes of management of the

7 *vided further*, That up to \$10,000,000 may be transferred

9 sistance, and Management appropriation or the IRS Infor-
10 mation Systems appropriation solely for the purposes of

17 INFORMATION SYSTEMS

18 For necessary expenses of the Internal Revenue Serv-
19 ice for information systems and telecommunications sup-
20 port, including developmental information systems and
21 operational information systems; the hire of passenger
22 motor vehicles (31 U.S.C. 1343(b)); and services as au-
23 thorized by 5 U.S.C. 3109, at such rates as may be deter-
24 mined by the Commissioner, \$1,606,846,000 (reduced by
25 \$24,000,000) (reduced by \$7,700,000), of which

1 \$75,000,000 shall remain available until September 30,
2 2007.

3 BUSINESS SYSTEMS MODERNIZATION

4 For necessary expenses of the Internal Revenue Serv-
5 ice, \$199,000,000, to remain available until September 30,
6 2008, for the capital asset acquisition of information tech-
7 nology systems, including management and related con-
8 tractual costs of said acquisitions, including contractual
9 costs associated with operations authorized by 5 U.S.C.
10 3109: *Provided*, That none of these funds may be obli-
11 gated until the Internal Revenue Service submits to the
12 Committees on Appropriations, and such Committees ap-
13 prove, a plan for expenditure that: (1) meets the capital
14 planning and investment control review requirements es-
15 tablished by the Office of Management and Budget, in-
16 cluding Circular A-11; (2) complies with the Internal Rev-
17 enue Service's enterprise architecture, including the mod-
18 ernization blueprint; (3) conforms with the Internal Rev-
19 enue Service's enterprise life cycle methodology; (4) is ap-
20 proved by the Internal Revenue Service, the Department
21 of the Treasury, and the Office of Management and Budg-
22 et; (5) has been reviewed by the Government Account-
23 ability Office; and (6) complies with the acquisition rules,
24 requirements, guidelines, and systems acquisition manage-
25 ment practices of the Federal Government.

1 HEALTH INSURANCE TAX CREDIT ADMINISTRATION

2 For expenses necessary to implement the health in-
3 surance tax credit included in the Trade Act of 2002
4 (Public Law 107–210), \$20,210,000.

5 ADMINISTRATIVE PROVISIONS—INTERNAL REVENUE

6 SERVICE

7 (INCLUDING TRANSFER OF FUNDS)

8 SEC. 201. Not to exceed 5 percent of any appropria-
9 tion made available in this Act to the Internal Revenue
10 Service or not to exceed 3 percent of appropriations under
11 the heading “Tax Law Enforcement” may be transferred
12 to any other Internal Revenue Service appropriation upon
13 the advance approval of the Committees on Appropria-
14 tions.

15 SEC. 202. The Internal Revenue Service shall main-
16 tain a training program to ensure that Internal Revenue
17 Service employees are trained in taxpayers’ rights, in deal-
18 ing courteously with taxpayers, and in cross-cultural rela-
19 tions.

20 SEC. 203. The Internal Revenue Service shall insti-
21 tute and enforce policies and procedures that will safe-
22 guard the confidentiality of taxpayer information.

23 SEC. 204. Funds made available by this or any other
24 Act to the Internal Revenue Service shall be available for
25 improved facilities and increased manpower to provide suf-
26 ficient and effective 1–800 help line service for taxpayers.

1 The Commissioner shall continue to make the improve-
2 ment of the Internal Revenue Service 1–800 help line serv-
3 ice a priority and allocate resources necessary to increase
4 phone lines and staff to improve the Internal Revenue
5 Service 1–800 help line service.

6 SEC. 205. None of the funds in this title may be used
7 to modify the number or location of Taxpayer Assistance
8 Centers until the Treasury Inspector General for Tax Ad-
9 ministration completes a study detailing the impact that
10 such closures would have on taxpayer compliance and sub-
11 mits such study to the Committees on Appropriations of
12 the House of Representatives and the Senate for review:
13 *Provided*, That no funds shall be obligated by the Internal
14 Revenue Service for such purposes for 60 days after re-
15 ceipt of such study: *Provided further*, That the Internal
16 Revenue Service shall consult with stakeholder organiza-
17 tions, including but no limited to, the National Taxpayer
18 Advocate, the Internal Revenue Service Oversight Board,
19 the Treasury Inspector General for Tax Administration,
20 and Internal Revenue Service employees with respect to
21 the types of data to be included in the model that will
22 determine which Taxpayer Assistance Centers should be
23 closed and the relative weight of such data as it relates
24 to such model.

1 ADMINISTRATIVE PROVISIONS—DEPARTMENT OF THE
2 TREASURY

3 (INCLUDING TRANSFER OF FUNDS)

4 SEC. 210. Appropriations to the Department of the
5 Treasury in this Act shall be available for uniforms or al-
6 lowances therefor, as authorized by law (5 U.S.C. 5901),
7 including maintenance, repairs, and cleaning; purchase of
8 insurance for official motor vehicles operated in foreign
9 countries; purchase of motor vehicles without regard to the
10 general purchase price limitations for vehicles purchased
11 and used overseas for the current fiscal year; entering into
12 contracts with the Department of State for the furnishing
13 of health and medical services to employees and their de-
14 pendants serving in foreign countries; and services author-
15 ized by 5 U.S.C. 3109.

16 SEC. 211. Not to exceed 2 percent of any appropria-
17 tion made available in this Act to the Internal Revenue
18 Service may be transferred to the Treasury Inspector Gen-
19 eral for Tax Administration's appropriation upon the ad-
20 vance approval of the Committees on Appropriations: *Pro-*
21 *vided*, That no transfer may increase or decrease any such
22 appropriation by more than 2 percent.

23 SEC. 212. Of the funds available for the purchase of
24 law enforcement vehicles, no funds may be obligated until
25 the Secretary of the Treasury certifies that the purchase

1 by the respective Treasury bureau is consistent with De-
2 partmental vehicle management principles: *Provided*, That
3 the Secretary may delegate this authority to the Assistant
4 Secretary for Management.

5 SEC. 213. None of the funds appropriated in this Act
6 or otherwise available to the Department of the Treasury
7 or the Bureau of Engraving and Printing may be used
8 to redesign the \$1 Federal Reserve note.

9 SEC. 214. The Secretary of the Treasury may trans-
10 fer funds from “Financial Management Services, Salaries
11 and Expenses” to “Debt Collection Fund” as necessary
12 to cover the costs of debt collection: *Provided*, That such
13 amounts shall be reimbursed to such salaries and expenses
14 account from debt collections received in the Debt Collec-
15 tion Fund.

16 SEC. 215. Section 122(g)(1) of Public Law 105–119
17 (5 U.S.C. 3104 note), is further amended by striking “7
18 years” and inserting “ 8 years”.

19 SEC. 216. None of the funds appropriated or other-
20 wise made available by this or any other Act may be used
21 by the United States Mint to construct or operate any mu-
22 seum without the explicit approval of the House Com-
23 mittee on Financial Services and the Senate Committee
24 on Banking, Housing, and Urban Affairs.

12 TITLE III—DEPARTMENT OF HOUSING AND
13 URBAN DEVELOPMENT
14 PUBLIC AND INDIAN HOUSING
15 TENANT-BASED RENTAL ASSISTANCE
16 (INCLUDING TRANSFER OF FUNDS)

For activities and assistance for the provision of ten-
ant-based rental assistance authorized under the United
States Housing act of 1937, as amended (42 U.S.C. 1437
et seq.) (“the Act” herein), not otherwise provided for,
\$15,531,400,000 (increased by \$100,000,000), to remain
available until expended, of which \$11,331,400,000 (in-
creased by \$100,000,000) shall be available on October
1, 2005, and \$4,200,000,000 shall be available on October
1, 2006: *Provided*, That the amounts made available under
this heading are provided as follows:

1 (1) \$14,089,755,725 (increased by
2 \$100,000,000) for renewals of expiring section 8
3 tenant-based annual contributions contracts (includ-
4 ing renewals of enhanced vouchers under any provi-
5 sion of law authorizing such assistance under section
6 8(t) of the Act: *Provided*, That notwithstanding any
7 other provision of law, from amounts provided under
8 this paragraph, the Secretary for the calendar year
9 2006 funding cycle shall provide renewal funding for
10 each public housing agency based on each public
11 housing agency's 2005 annual budget for renewal
12 funding as calculated by HUD, prior to prorations,
13 and by applying the 2006 Annual Adjustment Fac-
14 tor as established by the Secretary, and by making
15 any necessary adjustments for the costs associated
16 with the first-time renewal of tenant protection or
17 HOPE VI vouchers: *Provided further*, That the Sec-
18 retary shall, to the extent necessary to stay within
19 the amount provided under this paragraph, pro rate
20 each public housing agency's allocation otherwise es-
21 tablished pursuant to this paragraph: *Provided fur-*
22 *ther*, That except as provided in the following pro-
23 viso, the entire amount provided under this para-
24 graph shall be obligated to the public housing agen-
25 cies based on the allocation and pro rata method de-

1 scribed above: *Provided further*, That up to
2 \$45,000,000 shall be available only: (1) to adjust the
3 allocations for public housing agencies, after applica-
4 tion for an adjustment by a public housing agency
5 and verification by HUD, whose allocations under
6 this heading for contract renewals for the calendar
7 year 2005 funding cycle were based on verified VMS
8 leasing and cost data averaged for the months of
9 May, June, and July of 2004 and solely because of
10 temporarily low leasing levels during such 3-month
11 period did not accurately reflect leasing levels and
12 costs for the 2004 fiscal year of the agencies; and
13 (2) for adjustments for public housing agencies that
14 experienced a significant increase, as determined by
15 the Secretary, in renewal costs resulting from the
16 portability under section 8(r) of the United States
17 Housing Act of 1937 of tenant-based rental assist-
18 ance: *Provided further*, That none of the funds pro-
19 vided in this paragraph may be used to support a
20 total number of unit months under lease which ex-
21 ceeds a public housing agency's authorized level of
22 units under contract;

23 (2) \$165,700,000 for section 8 rental assistance
24 for relocation and replacement of housing units that
25 are demolished or disposed of pursuant to the Omni-

1 bus Consolidated Rescissions and Appropriations Act
2 of 1996 (Public Law 104–134), conversion of section
3 23 projects to assistance under section 8, the family
4 unification program under section 8(x) of the Act,
5 relocation of witnesses in connection with efforts to
6 combat crime in public and assisted housing pursu-
7 ant to a request from a law enforcement or prosecu-
8 tion agency, enhanced vouchers under any provision
9 of law authorizing such assistance under section 8(t)
10 of the Act, HOPE VI vouchers, mandatory and vol-
11 untary conversions, vouchers necessary to complete
12 the consent decree requirements in Walker vs. U.S.
13 Department of Housing and Urban Development,
14 and tenant protection assistance including replace-
15 ment and relocation assistance;

16 (3) \$45,000,000 for family self-sufficiency coor-
17 dinators under section 23 of the Act;

18 (4) \$5,900,000 shall be transferred to the
19 Working Capital Fund; and

20 (5) \$1,225,000,000 for administrative and
21 other expenses of public housing agencies in admin-
22 istering the section 8 tenant-based rental assistance
23 program, of which up to \$25,000,000 shall be avail-
24 able to the Secretary to allocate to public housing
25 agencies that need additional funds to administer

1 their section 8 programs: *Provided*, That
 2 \$1,200,000,000 of the amount provided in this para-
 3 graph shall be allocated for the calendar year 2006
 4 funding cycle on a pro rata basis to public housing
 5 agencies based on the amount public housing agen-
 6 cies were eligible to receive in calendar year 2005:
 7 *Provided further*, That all amounts provided under
 8 this paragraph shall be only for activities related to
 9 the provision of tenant-based rental assistance au-
 10 thorized under section 8, including related develop-
 11 ment activities, except that up to \$200,000,000 of
 12 funds made available on October 1, 2006, to this ac-
 13 count may be transferred to the “Project Based
 14 Rental Assistance Account” at the discretion of the
 15 Secretary.

16 HOUSING CERTIFICATE FUND

17 (RESCISSION)

18 Of the unobligated balances, including recaptures and
 19 carryover, remaining from funds appropriated to the De-
 20 partment of Housing and Urban Development under this
 21 heading or the heading “Annual contributions for assisted
 22 housing” or any other heading for fiscal year 2005 and
 23 prior years, \$2,493,600,000 is rescinded, to be effected by
 24 the Secretary no later than September 30, 2006: *Provided*,
 25 That any such balances governed by reallocation provi-
 26 sions under the statute authorizing the program for which

1 the funds were originally appropriated shall be available
 2 for the rescission: *Provided further*, That any obligated
 3 balances of contract authority from fiscal year 1974 and
 4 prior that have been terminated shall be cancelled: *Pro-*
 5 *vided further*, That no amounts recaptured from amounts
 6 appropriated in prior years under this heading or the
 7 heading “Annual contributions for assisted housing” and
 8 no carryover of such appropriated amounts for project-
 9 based assistance shall be available for the calendar year
 10 2006 funding cycle for activities provided for under the
 11 heading “Tenant-based rental assistance”.

12 PROJECT-BASED RENTAL ASSISTANCE

13 (INCLUDING TRANSFER OF FUNDS)

14 For activities and assistance for the provision of
 15 project-based subsidy contracts under the United States
 16 Housing Act of 1937, as amended (42 U.S.C. 1437 et
 17 seq.) (“the Act” herein), not otherwise provided for,
 18 \$5,088,300,000, to remain available until expended: *Pro-*
 19 *vided*, That the amounts made available under this head-
 20 ing are provided as follows:

21 (1) \$4,940,100,000 for expiring or terminating
 22 section 8 project-based subsidy contracts (including
 23 section 8 moderate rehabilitation contracts), for
 24 amendments to section 8 project-based subsidy con-
 25 tracts (including section 8 moderate rehabilitation
 26 contracts), for contracts entered into pursuant to

1 section 441 of the McKinney-Vento Homeless Assist-
2 ance Act, for renewal of section 8 contracts for units

14 ministrators for: interest reduction payments pursu-
15 ant to section 236(a) of the National Housing Act
16 (12 U.S.C. 1715z–1(a)); rent supplement payments
17 pursuant to section 101 of the Housing and Urban
18 Development Act of 1965 (12 U.S.C. 1701s); Sec-
19 tion 236(f)(2) rental assistance payments (12 U.S.C.
20 1715z–1(f)(2)); project rental assistance contracts
21 for the elderly under section 202(c)(2) of the Hous-
22 ing Act of 1959, as amended (12 U.S.C. 1701q,
23 1701q–1); project rental assistance contracts for
24 supportive housing for persons with disabilities
25 under section 811(d)(2) of the Cranston-Gonzalez

1 National Affordable Housing Act; project assistance
 2 contracts pursuant to section 202(h) of the Housing

 4 and loans under section 202 of the Housing Act of
 5 1959 (Public Law 86–372; 73 Stat. 667).

6 (3) \$1,000,000 shall be transferred to the
 7 Working Capital Fund: *Provided further*, That
 8 amounts recaptured under this heading, the heading,
 9 ‘Annual Contributions for Assisted Housing,’ or the
 10 heading, ‘Housing Certificate Fund,’ for project-
 11 based section 8 activities may be used for renewals
 12 of or amendments to section 8 project-based subsidy
 13 contracts or for performance-based contract adminis-
 14 trators, notwithstanding the purposes for which such
 15 amounts were appropriated.

 22 U.S.C. 1437g) (the “Act”), \$2,600,000,000, to remain
 23 available until September 30, 2009: *Provided*, That not-
 24 withstanding any other provision of law or regulation, dur-
 25 ing fiscal year 2006, the Secretary may not delegate to
 26 any Department official other than the Deputy Secretary

1 and the Assistant Secretary for Public and Indian Hous-
2 ing any authority under paragraph (2) of section 9(j) re-
3 garding the extension of the time periods under such sec-
4 tion: *Provided further*, That for purposes of such section
5 9(j), the term “obligate” means, with respect to amounts,
6 that the amounts are subject to a binding agreement that
7 will result in outlays, immediately or in the future: *Pro-*
8 *vided further*, That of the total amount provided under
9 this heading, up to \$11,000,000 shall be for carrying out
10 activities under section 9(h) of such Act: *Provided further*,
11 That \$10,000,000 shall be transferred to the Working
12 Capital Fund: *Provided further*, That no funds may be
13 used under this heading for the purposes specified in sec-
14 tion 9(k) of the United States Housing Act of 1937, as
15 amended: *Provided further*, That of the total amount pro-
16 vided under this heading, up to \$17,000,000 shall be avail-
17 able for the Secretary of Housing and Urban Development
18 to make grants, notwithstanding section 305 of this Act,
19 to public housing agencies for emergency capital needs re-
20 sulting from unforeseen emergencies and natural disasters
21 occurring in fiscal year 2006: *Provided further*, That of
22 the total amount provided under this heading,
23 \$24,000,000 shall be for supportive services, service coor-
24 dinators and congregate services as authorized by section
25 34 of the Act and the Native American Housing Assist-

1 ance and Self-Determination Act of 1996: *Provided fur-*
 2 *ther*, That up to \$8,820,000 is to support the costs of ad-
 3 ministrative and judicial receiverships.

4 PUBLIC HOUSING OPERATING FUND

5 For 2006 payments to public housing agencies for the
 6 operation and management of public housing, as author-
 7 ized by section 9(e) of the United States Housing Act of
 8 1937, as amended (42 U.S.C. 1437g(e)), \$3,600,000,000:
 9 *Provided*, That all funds made available under this head-
 10 ing shall be allocated to public housing agencies in accord-
 11 ance with the terms, conditions, criteria and methodology
 12 set forth in the “Post 4th Session Rule” issued on June
 13 10, 2004 and shall not be allocated using any other for-
 14 mula unless approved by the Committee: *Provided further*,
 15 That of the total amount provided under this heading, up
 16 to \$50,000,000 shall be for assistance for the conversion
 17 to asset management including project-based accounting,
 18 budgeting and management for public housing agencies
 19 operating three or more public housing projects, which will
 20 under the “Post 4th Session Rule” formula experience a
 21 loss of subsidy greater than 5 percent from the amount

15 ADMINISTRATION—FEDERAL BUILDINGS FUND” and for
16 building operations under such item are hereby reduced
17 by, \$60,000,000.

18 NATIVE AMERICAN HOUSING BLOCK GRANTS
19 (INCLUDING TRANSFER OF FUNDS)

20 For the Native American Housing Block Grants pro-
21 gram, as authorized under title I of the Native American
22 Housing Assistance and Self-Determination Act of 1996
23 (NAHASDA) (25 U.S.C. 4111 et seq.), \$600,000,000, to
24 remain available until expended. Notwithstanding the Na-
25 tive American Housing Assistance and Self-Determination
26 Act of 1996, to determine the amount of the allocation

1 under title I of such Act for each Indian tribe, the Sec-
2 retary shall apply the formula under section 302 of such
3 Act with the need component based on single-race Census
4 data and with the need component based on multi-race
5 Census data, and the amount of the allocation for each
6 Indian tribe shall be the greater of the two resulting allo-
7 cation amounts. Of funds made available under this head-
8 ing, \$1,200,000 shall be contracted through the Secretary
9 as technical assistance and capacity building to be used

21 106(a)(1) of such Act, to be allocated using the same
22 methodology as fiscal year 2005 funds of which up to
23 \$4,000,000 may be used for emergencies that constitute
24 imminent threats to health and safety, notwithstanding
25 any other provision of law (including section 205 of the

1 Act): *Provided*, That of the amount provided under this
2 heading, \$2,000,000 shall be made available for the cost
3 of guaranteed notes and other obligations, as authorized
4 by title VI of NAHASDA: *Provided further*, That such
5 costs, including the costs of modifying such notes and
6 other obligations, shall be as defined in section 502 of the
7 Congressional Budget Act of 1974, as amended: *Provided*
8 *further*, That these funds are available to subsidize the
9 total principal amount of any notes and other obligations,
10 any part of which is to be guaranteed, not to exceed
11 \$17,926,000: *Provided further*, That for administrative ex-
12 penses to carry out the guaranteed loan program, up to
13 \$150,000 from amounts in the first proviso, which shall
14 be transferred to and merged with the appropriation for
15 “Salaries and Expenses”.

16 NATIVE HAWAIIAN HOUSING BLOCK GRANT

17 For the Native Hawaiian Housing Block Grant pro-
18 gram, as authorized under title VIII of the Native Amer-
19 ican Housing Assistance and Self-Determination Act of
20 1996 (25 U.S.C. 4111 et seq.), \$8,815,000, to remain
21 available until expended, of which \$352,606 shall be for
22 training and technical assistance activities.

1 INDIAN HOUSING LOAN GUARANTEE FUND PROGRAM
2 ACCOUNT
3 (INCLUDING TRANSFER OF FUNDS)

4 For the cost of guaranteed loans, as authorized by
5 section 184 of the Housing and Community Development
6 Act of 1992 (12 U.S.C. 1715z–13a), \$2,645,000, to re-
7 main available until expended: *Provided*, That such costs,
8 including the costs of modifying such loans, shall be as
9 defined in section 502 of the Congressional Budget Act
10 of 1974, as amended: *Provided further*, That these funds
11 are available to subsidize total loan principal, any part of
12 which is to be guaranteed, not to exceed \$98,966,942.

13 In addition, for administrative expenses to carry out
14 the guaranteed loan program, up to \$250,000 from
15 amounts in the first paragraph, which shall be transferred
16 to and merged with the appropriation for “Salaries and
17 Expenses”.

18 NATIVE HAWAIIAN HOUSING LOAN GUARANTEE FUND
19 PROGRAM ACCOUNT
20 (INCLUDING TRANSFER OF FUNDS)

21 For the cost of guaranteed loans, as authorized by
22 section 184A of the Housing and Community Develop-
23 ment Act of 1992 (12 U.S.C. 1715z–13b), \$882,000, to
24 remain available until expended: *Provided*, That such
25 costs, including the costs of modifying such loans, shall
26 be as defined in section 502 of the Congressional Budget

1 Act of 1974, as amended: *Provided further*, That these
2 funds are available to subsidize total loan principal, any
3 part of which is to be guaranteed, not to exceed
4 \$35,000,000.

5 In addition, for administrative expenses to carry out
6 the guaranteed loan program, up to \$35,000 from
7 amounts in the first paragraph, which shall be transferred
8 to and merged with the appropriation for “Salaries and
9 Expenses”.

10 COMMUNITY PLANNING AND DEVELOPMENT

11 HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS

12 For carrying out the Housing Opportunities for Per-
13 sons with AIDS program, as authorized by the AIDS
14 Housing Opportunity Act (42 U.S.C. 12901 et seq.),
15 \$285,000,000 (increased by \$5,000,000) to remain avail-
16 able until September 30, 2007, except that amounts allo-
17 cated pursuant to section 854(c)(3) of such Act shall re-
18 main available until September 30, 2008: *Provided*, That
19 the Secretary shall renew all expiring contracts for perma-
20 nent supportive housing that were funded under section
21 854(c)(3) of such Act that meet all program requirements
22 before awarding funds for new contracts and activities au-
23 thorized under this section: *Provided further*, That the
24 Secretary may use up to \$1,000,000 of the funds under

1 this heading for training, oversight, and technical assist-
 2 ance activities.

3 RURAL HOUSING AND ECONOMIC DEVELOPMENT

4 For the Office of Rural Housing and Economic De-
 5 velopment in the Department of Housing and Urban De-
 6 velopment, \$10,000,000 to remain available until ex-
 7 pended, which amount shall be competitively awarded by
 8 September 1, 2006, to Indian tribes, State housing finance
 9 agencies, State community and/or economic development
 10 agencies, local rural nonprofits and community develop-
 11 ment corporations to support innovative housing and eco-
 12 nomic development activities in rural areas.

13 COMMUNITY DEVELOPMENT FUND

14 (INCLUDING TRANSFERS OF FUNDS)

15 For assistance to units of State and local govern-
 16 ment, and to other entities, for economic and community
 17 development activities, and for other purposes,
 18 \$4,151,500,000 (increased by \$67,500,000) (increased by
 19 \$24,000,000), to remain available until September 30,
 20 2008, unless otherwise specified: *Provided*, That of the
 21 amount provided, \$3,859,900,000 (increased by
 22 \$17,500,000) is for carrying out the community develop-
 23 ment block grant program under title I of the Housing

6 Of the amount made available under this heading,

18 tional Affordable Housing Act, as amended,
19 \$1,850,000,000 to remain available until September 30,
20 2008: *Provided*, That of the total amount provided in this
21 paragraph, up to \$41,700,000 shall be available for hous-
22 ing counseling under section 106 of the Housing and
23 Urban Development Act of 1968, and \$1,000,000 shall be
24 transferred to the Working Capital Fund.

25 In addition to amounts otherwise made available
26 under this heading, \$50,000,000, to remain available until

1 September 30, 2008, for assistance to homebuyers as au-
2 thorized under title I of the American Dream Downpay-
3 ment Act.

4 SELF-HELP AND ASSISTED HOMEOWNERSHIP

5 OPPORTUNITY PROGRAM

6 For the Self-Help and Assisted Homeownership Op-
7 portunity Program, \$60,800,000, to remain available until
8 September 30, 2008: *Provided*, That of the total amount
9 provided in this heading \$23,800,000 shall be made avail-
10 able to the Self Help Homeownership Opportunity Pro-
11 gram as authorized under section 11 of the Housing Op-
12 portunity Program Extension Act of 1996 as amended:
13 *Provided further*, That \$28,000,000 shall be made avail-
14 able for capacity building, of which \$27,000,000 shall be
15 for capacity building for Community Development and af-
16 fordable Housing for LIHC and the Enterprise Founda-
17 tion for activities authorized by Section 4 of the HUD
18 Demonstration Act of 1993 (42 USC 9816 note), as in
19 effect immediately before June 12, 1997 and \$1,000,000
20 shall be made available for capacity building activities ad-
21 ministered by Habitat for Humanity International: *Pro-*
22 *vided further*, That \$3,000,000 shall be made available to
23 the Housing Assistance Council, \$1,000,000 shall be made
24 available to the Native American Indian Housing Council,
25 \$4,000,000 shall be made available to the Housing Part-
26 nership Network, and \$1,000,000 shall be made available

1 to the Special Olympics, to remain available until Sep-
2 tember 30, 2008.

3 HOMELESS ASSISTANCE GRANTS

4 (INCLUDING TRANSFER OF FUNDS)

5 For the emergency shelter grants program as author-
6 ized under subtitle B of title IV of the McKinney-Vento
7 Homeless Assistance Act, as amended; the supportive
8 housing program as authorized under subtitle C of title
9 IV of such Act; the section 8 moderate rehabilitation sin-
10 gle room occupancy program as authorized under the
11 United States Housing Act of 1937, as amended, to assist
12 homeless individuals pursuant to section 441 of the
13 McKinney-Vento Homeless Assistance Act; and the shelter
14 plus care program as authorized under subtitle F of title
15 IV of such Act, \$1,340,000,000, of which \$1,320,000,000
16 shall remain available until September 30, 2008, and of
17 which \$20,000,000 shall remain available until expended:
18 *Provided*, That not less than 30 percent of funds made
19 available, excluding amounts provided for renewals under
20 the shelter plus care program, shall be used for permanent
21 housing: *Provided further*, That all funds awarded for
22 services shall be matched by 25 percent in funding by each
23 grantee: *Provided further*, That the Secretary shall renew
24 on an annual basis expiring contracts or amendments to
25 contracts funded under the shelter plus care program if
26 the program is determined to be needed under the applica-

1 ble continuum of care and meets appropriate program re-
2 quirements and financial standards, as determined by the
3 Secretary: *Provided further*, That all awards of assistance
4 under this heading shall be required to coordinate and in-
5 tegrate homeless programs with other mainstream health,
6 social services, and employment programs for which home-
7 less populations may be eligible, including Medicaid, State

5 tember 30, 2005, and any collections made during fiscal
6 year 2006 and all subsequent fiscal years, shall be trans-
7 ferred to the Flexible Subsidy Fund, as authorized by sec-
8 tion 236(g) of the National Housing Act, as amended.

9 PAYMENT TO MANUFACTURED HOUSING FEES TRUST

10 FUND

11 For necessary expenses as authorized by the National
12 Manufactured Housing Construction and Safety Stand-
13 ards Act of 1974, as amended (42 U.S.C. 5401 et seq.),
14 up to \$12,896,000 to remain available until expended, to
15 be derived from the Manufactured Housing Fees Trust
16 Fund: *Provided*, That not to exceed the total amount ap-
17 propriated under this heading shall be available from the
18 general fund of the Treasury to the extent necessary to
19 incur obligations and make expenditures pending the re-
20 ceipt of collections to the Fund pursuant to section 620
21 of such Act: *Provided further*, That the amount made
22 available under this heading from the general fund shall
23 be reduced as such collections are received during fiscal
24 year 2006 so as to result in a final fiscal year 2006 appro-
25 priation from the general fund estimated at not more than
26 \$0 and fees pursuant to such section 620 shall be modified

1 as necessary to ensure such a final fiscal year 2006 appro-
2 priation.

3 FEDERAL HOUSING ADMINISTRATION
4 MUTUAL MORTGAGE INSURANCE PROGRAM ACCOUNT

6 During fiscal year 2006, commitments to guarantee
7 loans to carry out the purposes of section 203(b) of the
8 National Housing Act, as amended, shall not exceed a loan
9 principal of \$185,000,000,000.

10 During fiscal year 2006, obligations to make direct
11 loans to carry out the purposes of section 204(g) of the
12 National Housing Act, as amended, shall not exceed
13 \$50,000,000: *Provided*, That the foregoing amount shall
14 be for loans to nonprofit and governmental entities in con-
15 nection with sales of single family real properties owned
16 by the Secretary and formerly insured under the Mutual
17 Mortgage Insurance Fund.

18 For administrative expenses necessary to carry out
19 the guaranteed and direct loan program, \$355,000,000,
20 of which not to exceed \$351,000,000 shall be transferred
21 to the appropriation for “Salaries and expenses”; and not
22 to exceed \$4,000,000 shall be transferred to the appro-
23 priation for “Office of Inspector General”. In addition, for
24 administrative contract expenses, \$62,600,000, of which
25 \$18,281,000 shall be transferred to the Working Capital
26 Fund: *Provided*, That to the extent guaranteed loan com-

1 mitments exceed \$65,500,000,000 on or before April 1,

5 amount for any amount below \$1,000,000), but in no case
6 shall funds made available by this proviso exceed
7 \$30,000,000.

8 GENERAL AND SPECIAL RISK PROGRAM ACCOUNT
9 (INCLUDING TRANSFERS OF FUNDS)

10 For the cost of guaranteed loans, as authorized by
11 sections 238 and 519 of the National Housing Act (12
12 U.S.C. 1715z-3 and 1735c), including the cost of loan
13 guarantee modifications, as that term is defined in section
14 502 of the Congressional Budget Act of 1974, as amend-
15 ed, \$8,800,000, to remain available until expended: *Pro-*
16 *vided*, That commitments to guarantee loans shall not ex-
17 ceed \$35,000,000,000 in total loan principal, any part of
18 which is to be guaranteed.

19 Gross obligations for the principal amount of direct
20 loans, as authorized by sections 204(g), 207(l), 238, and

10 In addition, for administrative contract expenses nec-

 4 (INCLUDING TRANSFER OF FUNDS)

5 New commitments to issue guarantees to carry out
 6 the purposes of section 306 of the National Housing Act,
 7 as amended (12 U.S.C. 1721(g)), shall not exceed
 8 \$200,000,000,000, to remain available until September
 9 30, 2007.

10 For administrative expenses necessary to carry out
 11 the guaranteed mortgage-backed securities program,
 12 \$10,700,000, to be derived from the GNMA guarantees
 13 of mortgage-backed securities guaranteed loan receipt ac-
 14 count, of which not to exceed \$10,700,000, shall be trans-
 15 ferred to the appropriation for “Salaries and Expenses”.

16 POLICY DEVELOPMENT AND RESEARCH
 17 RESEARCH AND TECHNOLOGY

18 For contracts, grants, and necessary expenses of pro-
 19 grams of research and studies relating to housing and
 20 urban problems, not otherwise provided for, as authorized
 21 by title V of the Housing and Urban Development Act
 22 of 1970, as amended (12 U.S.C. 1701z–1 et seq.), includ-
 23 ing carrying out the functions of the Secretary under sec-
 24 tion 1(a)(1)(i) of Reorganization Plan No. 2 of 1968,
 25 \$60,600,000, to remain available until September 30,
 26 2007: *Provided*, That of the total amount provided under

1 this heading, \$5,000,000 shall be for the Partnership for
2 Advancing Technology in Housing (PATH) Initiative:
3 *Provided further*, That of the amounts made available for
4 PATH under this heading, \$2,500,000 shall not be subject
5 to the requirements of section 305 of this title: *Provided*
6 *further*, That of funds made available under this heading,
7 \$750,000 shall be transferred to the National Research
8 Council for a study in accordance with the accompanying
9 Report: *Provided further*, That \$29,038,000 is for grants
10 pursuant to section 107 of the Housing and Community
11 Development Act of 1974, as amended, as follows:
12 \$2,989,000 to support Alaska Native serving institutions
13 and Native Hawaiian serving institutions as defined under
14 the Higher Education Act, as amended; \$2,562,000 for

3 For contracts, grants, and other assistance, not oth-
4 erwise provided for, as authorized by title VIII of the Civil
5 Rights Act of 1968, as amended by the Fair Housing
6 Amendments Act of 1988, and section 561 of the Housing
7 and Community Development Act of 1987, as amended,
8 \$38,800,000 (increased by \$7,700,000), to remain avail-
9 able until September 30, 2007, of which \$16,100,000 (in-
10 creased by \$3,900,000) shall be to carry out activities pur-
11 suant to such section 561: *Provided*, That no funds made
12 available under this heading shall be used to lobby the ex-
13 ecutive or legislative branches of the Federal Government
14 in connection with a specific contract, grant or loan.

15 OFFICE OF LEAD HAZARD CONTROL

16 LEAD HAZARD REDUCTION

17 For the Lead Hazard Reduction Program, as author-
18 ized by section 1011 of the Residential Lead-Based Paint
19 Hazard Reduction Act of 1992, \$119,000,000 (increased
20 by \$47,656,000), to remain available until September 30,
21 2007, of which \$8,800,000 shall be for the Healthy Homes
22 Initiative, pursuant to sections 501 and 502 of the Hous-
23 ing and Urban Development Act of 1970 that shall include
24 research, studies, testing, and demonstration efforts, in-
25 cluding education and outreach concerning lead-based

1 paint poisoning and other housing-related diseases and
 2 hazards: *Provided*, That for purposes of environmental re-
 3 view, pursuant to the National Environmental Policy Act
 4 of 1969 (42 U.S.C. 4321 et seq.) and other provisions of
 5 law that further the purposes of such Act, a grant under
 6 the Healthy Homes Initiative, Operation Lead Elimination
 7 Action Plan (LEAP), or the Lead Technical Studies pro-
 8 gram under this heading or under prior appropriations
 9 Acts for such purposes under this heading, shall be consid-
 10 ered to be funds for a special project for purposes of sec-
 11 tion 305(c) of the Multifamily Housing Property Disposi-

13 MANAGEMENT AND ADMINISTRATION

14 SALARIES AND EXPENSES

15 (INCLUDING TRANSFER OF FUNDS)

16 For necessary administrative and non-administrative
 17 expenses of the Department of Housing and Urban Devel-
 18 opment, not otherwise provided for, including purchase of
 19 uniforms, or allowances therefore, as authorized by 5
 20 U.S.C. 5901–5902; hire of passenger motor vehicles; serv-
 21 ices as authorized by 5 U.S.C. 3109; and not to exceed
 22 \$25,000 for official reception and representation expenses,
 23 \$1,152,535,000, of which \$562,400,000 shall be provided
 24 from the various funds of the Federal Housing Adminis-
 25 tration, \$10,700,000 shall be provided from funds of the
 26 Government National Mortgage Association, \$150,000

1 shall be provided by transfer from the “Native American
2 housing block grants” account, \$250,000 shall be provided
3 by transfer from the “Indian housing loan guarantee fund
4 program” account and \$35,000 shall be transferred from
5 the “Native Hawaiian housing loan guarantee fund” ac-
6 count: *Provided*, That funds made available under this
7 heading shall only be allocated in the manner specified in
8 the Report accompanying this Act unless the Committees
9 on Appropriations of both the House of Representatives
10 and the Senate are notified of any changes in an operating
11 plan or reprogramming: *Provided further*, That no official
12 or employee of the Department shall be designated as an
13 allotment holder unless the Office of the Chief Financial
14 Officer (OCFO) has determined that such allotment hold-
15 er has implemented an adequate system of funds control
16 and has received training in funds control procedures and
17 directives: *Provided further*, That the Chief Financial Offi-
18 cer shall establish positive control of and maintain ade-
19 quate systems of accounting for appropriations and other
20 available funds as required by 31 U.S.C. 1514: *Provided*
21 *further*, That for purposes of funds control and deter-
22 mining whether a violation exists under the Anti-Defi-
23 ciency Act (31 U.S.C. 1341 et seq.), the point of obligation
24 shall be the executed agreement or contract, except with
25 respect to insurance and guarantee programs, certain

1 types of salaries and expenses funding, and incremental
2 funding that is authorized under an executed agreement
3 or contract, and shall be designated in the approved funds
4 control plan: *Provided further*, That the Chief Financial
5 Officer shall: (1) appoint qualified personnel to conduct
6 investigations of potential or actual violations; (2) estab-
7 lish minimum training requirements and other qualifica-
8 tions for personnel that may be appointed to conduct in-
9 vestigations; (3) establish guidelines and timeframes for

 3 \$5,000,000), to remain available until September 30,
 4 2007: *Provided*, That any amounts transferred to this
 5 Fund under this Act shall remain available until expended:
 6 *Provided further*, That any amounts transferred to this
 7 Fund from amounts appropriated by previously enacted
 8 appropriations Acts or from within this Act may be used
 9 for the purposes specified under this Fund, in addition
 10 to the purposes for which such amounts were appro-
 11 priated.

12 OFFICE OF INSPECTOR GENERAL

13 (INCLUDING TRANSFER OF FUNDS)

14 For necessary expenses of the Office of Inspector
 15 General in carrying out the Inspector General Act of 1978,
 16 as amended, \$103,000,000, of which \$24,000,000 shall be
 17 provided from the various funds of the Federal Housing
 18 Administration: *Provided*, That the Inspector General
 19 shall have independent authority over all personnel issues
 20 within this office.

21 OFFICE OF FEDERAL HOUSING ENTERPRISE OVERSIGHT

22 SALARIES AND EXPENSES

23 (INCLUDING TRANSFER OF FUNDS)

24 For carrying out the Federal Housing Enterprises
 25 Financial Safety and Soundness Act of 1992, including
 26 not to exceed \$500 for official reception and representa-

1 tion expenses, \$60,000,000, to remain available until ex-
2 pended, to be derived from the Federal Housing Enter-
3 prises Oversight Fund: *Provided*, That of the amount
4 made available under this heading, \$5,000,000 is for liti-
5 gation and to continue ongoing special investigations of
6 the Federal housing enterprises: *Provided further*, That
7 the Director shall submit a spending plan for the amounts
8 provided under this heading no later than January 15,
9 2005: *Provided further*, That not less than 80 percent of
10 total amount made available under this heading shall be
11 used only for examination, supervision, and capital over-
12 sight of the enterprises (as such term is defined in section
13 1303 of the Federal Housing Enterprises Financial Safety
14 and Soundness Act of 1992 (12 U.S.C. 4502)) to ensure
15 that the enterprises are operating in a financially safe and
16 sound manner and complying with the capital require-
17 ments under Subtitle B of such Act: *Provided further*,
18 That not to exceed the amount provided herein shall be
19 available from the general fund of the Treasury to the ex-
20 tent necessary to incur obligations and make expenditures
21 pending the receipt of collections to the Fund: *Provided*
22 *further*, That the general fund amount shall be reduced
23 as collections are received during the fiscal year so as to
24 result in a final appropriation from the general fund esti-
25 mated at not more than \$0.

1 ADMINISTRATIVE PROVISIONS

2 SEC. 301. Fifty percent of the amounts of budget au-
3 thority, or in lieu thereof 50 percent of the cash amounts
4 associated with such budget authority, that are recaptured
5 from projects described in section 1012(a) of the Stewart
6 B. McKinney Homeless Assistance Amendments Act of
7 1988 (42 U.S.C. 1437 note) shall be rescinded, or in the
8 case of cash, shall be remitted to the Treasury, and such
9 amounts of budget authority or cash recaptured and not
10 rescinded or remitted to the Treasury shall be used by
11 State housing finance agencies or local governments or
12 local housing agencies with projects approved by the Sec-
13 retary of Housing and Urban Development for which set-
14 tlement occurred after January 1, 1992, in accordance
15 with such section. Notwithstanding the previous sentence,
16 the Secretary may award up to 15 percent of the budget
17 authority or cash recaptured and not rescinded or remitted
18 to the Treasury to provide project owners with incentives
19 to refinance their project at a lower interest rate.

20 SEC. 302. None of the amounts made available under
21 this Act may be used during fiscal year 2006 to investigate
22 or prosecute under the Fair Housing Act any otherwise
23 lawful activity engaged in by one or more persons, includ-
24 ing the filing or maintaining of a non-frivolous legal ac-
25 tion, that is engaged in solely for the purpose of achieving

1 or preventing action by a Government official or entity,
2 or a court of competent jurisdiction.

3 SEC. 303. (a) Notwithstanding section 854(c)(1)(A)
4 of the AIDS Housing Opportunity Act (42 U.S.C.
5 12903(c)(1)(A)), from any amounts made available under
6 this title for fiscal year 2006 that are allocated under such
7 section, the Secretary of Housing and Urban Development
8 shall allocate and make a grant, in the amount determined
9 under subsection (b), for any State that—

10 (1) received an allocation in a prior fiscal year
11 under clause (ii) of such section; and

12 (2) is not otherwise eligible for an allocation for
13 fiscal year 2006 under such clause (ii) because the
14 areas in the State outside of the metropolitan statis-
15 tical areas that qualify under clause (i) in fiscal year
16 2006 do not have the number of cases of acquired
17 immunodeficiency syndrome (AIDS) required under
18 such clause.

19 (b) The amount of the allocation and grant for any
20 State described in subsection (a) shall be an amount based
21 on the cumulative number of AIDS cases in the areas of
22 that State that are outside of metropolitan statistical
23 areas that qualify under clause (i) of such section
24 854(c)(1)(A) in fiscal year 2006, in proportion to AIDS
25 cases among cities and States that qualify under clauses

1 (i) and (ii) of such section and States deemed eligible
2 under subsection (a).

3 (c) Notwithstanding any other provision of law, the
4 amount allocated for fiscal year 2006 under section 854(c)
5 of the AIDS Housing Opportunity Act (42 U.S.C.
6 12903(c)), to the City of New York, New York, on behalf
7 of the New York-Wayne-White Plains, New York-New
8 Jersey Metropolitan Division (hereafter “metropolitan di-
9 vision”) of the New York-Newark-Edison, NY-NJ-PA
10 Metropolitan Statistical Area, shall be adjusted by the
11 Secretary of Housing and Urban Development by: (1) allo-
12 cating to the City of Jersey City, New Jersey, the propor-
13 tion of the metropolitan area’s or division’s amount that
14 is based on the number of cases of AIDS reported in the
15 portion of the metropolitan area or division that is located
16 in Hudson County, New Jersey, and adjusting for the pro-
17 portion of the metropolitan division’s high incidence bonus
18 if this area in New Jersey also has a higher than average
19 per capita incidence of AIDS; and (2) allocating to the
20 City of Paterson, New Jersey, the proportion of the metro-
21 politan area’s or division’s amount that is based on the
22 number of cases of AIDS reported in the portion of the
23 metropolitan area or division that is located in Bergen
24 County and Passaic County, New Jersey, and adjusting
25 for the proportion of the metropolitan division’s high inci-

1 dence bonus if this area in New Jersey also has a higher
2 than average per capita incidence of AIDS. The recipient
3 cities shall use amounts allocated under this subsection
4 to carry out eligible activities under section 855 of the
5 AIDS Housing Opportunity Act (42 U.S.C. 12904) in
6 their respective portions of the metropolitan division that
7 is located in New Jersey.

8 (d) Notwithstanding any other provision of law, the
9 amount allocated for fiscal year 2006 under section 854(c)
10 of the AIDS Housing Opportunity Act (42 U.S.C.
11 12903(c)) to areas with a higher than average per capita
12 incidence of AIDS, shall be adjusted by the Secretary on
13 the basis of area incidence reported over a three year pe-
14 riod.

15 SEC. 304. (a) During fiscal year 2006, in the provi-
16 sion of rental assistance under section 8(o) of the United
17 States Housing Act of 1937 (42 U.S.C. 1437f(o)) in con-
18 nection with a program to demonstrate the economy and
19 effectiveness of providing such assistance for use in as-
20 sisted living facilities that is carried out in the counties
21 of the State of Michigan notwithstanding paragraphs (3)
22 and (18)(B)(iii) of such section 8(o), a family residing in
23 an assisted living facility in any such county, on behalf
24 of which a public housing agency provides assistance pur-
25 suant to section 8(o)(18) of such Act, may be required,

1 at the time the family initially receives such assistance,
2 to pay rent in an amount exceeding 40 percent of the
3 monthly adjusted income of the family by such a percent-
4 age or amount as the Secretary of Housing and Urban
5 Development determines to be appropriate.

6 SEC. 305. Except as explicitly provided in law, any
7 grant, cooperative agreement or other assistance made
8 pursuant to title III of this Act shall be made on a com-
9 petitive basis and in accordance with section 102 of the
10 Department of Housing and Urban Development Reform
11 Act of 1989.

12 SEC. 306. Funds of the Department of Housing and
13 Urban Development subject to the Government Corpora-
14 tion Control Act or section 402 of the Housing Act of
15 1950 shall be available, without regard to the limitations
16 on administrative expenses, for legal services on a contract
17 or fee basis, and for utilizing and making payment for
18 services and facilities of the Federal National Mortgage
19 Association, Government National Mortgage Association,
20 Federal Home Loan Mortgage Corporation, Federal Fi-
21 nancing Bank, Federal Reserve banks or any member
22 thereof, Federal Home Loan banks, and any insured bank
23 within the meaning of the Federal Deposit Insurance Cor-
24 poration Act, as amended (12 U.S.C. 1811–1831).

1 SEC. 307. Unless otherwise provided for in this Act
2 or through a reprogramming of funds, no part of any ap-
3 propriation for the Department of Housing and Urban
4 Development shall be available for any program, project
5 or activity in excess of amounts set forth in the budget
6 estimates submitted to Congress.

7 SEC. 308. Corporations and agencies of the Depart-
8 ment of Housing and Urban Development which are sub-
9 ject to the Government Corporation Control Act, as
10 amended, are hereby authorized to make such expendi-
11 tures, within the limits of funds and borrowing authority
12 available to each such corporation or agency and in ac-
13 cordance with law, and to make such contracts and com-
14 mitments without regard to fiscal year limitations as pro-
15 vided by section 104 of such Act as may be necessary in
16 carrying out the programs set forth in the budget for 2006
17 for such corporation or agency except as hereinafter pro-
18 vided: *Provided*, That collections of these corporations and
19 agencies may be used for new loan or mortgage purchase
20 commitments only to the extent expressly provided for in
21 this Act (unless such loans are in support of other forms
22 of assistance provided for in this or prior appropriations
23 Acts), except that this proviso shall not apply to the mort-
24 gage insurance or guaranty operations of these corpora-
25 tions, or where loans or mortgage purchases are necessary

1 to protect the financial interest of the United States Gov-
2 ernment.

3 SEC. 309. None of the funds provided in this title
4 for technical assistance, training, or management improve-
5 ments may be obligated or expended unless HUD provides
6 to the Committees on Appropriations a description of each
7 proposed activity and a detailed budget estimate of the
8 costs associated with each program, project or activity as
9 part of the Budget Justifications. For fiscal year 2006,
10 HUD shall transmit this information to the Committees
11 by March 15, 2006 for 30 days of review.

12 SEC. 310. The Secretary of Housing and Urban De-
13 velopment shall provide quarterly reports to the House
14 and Senate Committees on Appropriations regarding all
15 uncommitted, unobligated, recaptured and excess funds in
16 each program and activity within the jurisdiction of the
17 Department and shall submit additional, updated budget
18 information to these Committees upon request.

19 SEC. 311. Notwithstanding any other provision of
20 law, in fiscal year 2006, in managing and disposing of any
21 multifamily property that is owned or held by the Sec-
22 retary and is occupied primarily by elderly or disabled
23 families, the Secretary of Housing and Urban Develop-
24 ment shall maintain any rental assistance payments under
25 section 8 of the United States Housing Act of 1937 that

1 are attached to any dwelling units in the property. To the
2 extent the Secretary determines that such a multifamily
3 property owned or held by the Secretary is not feasible
4 for continued rental assistance payments under such sec-
5 tion 8, the Secretary may, in consultation with the tenants
6 of that property, contract for project-based rental assist-
7 ance payments with an owner or owners of other existing
8 housing properties or provide other rental assistance.

9 SEC. 312. (a) Notwithstanding any other provision
10 of law, the amount allocated for fiscal year 2006 under
11 section 854(c) of the AIDS Housing Opportunity Act (42
12 U.S.C. 12903(c)), to the City of Wilmington, Delaware,
13 on behalf of the Wilmington, Delaware-Maryland-New
14 Jersey Metropolitan Division (hereafter “metropolitan di-
15 vision”), shall be adjusted by the Secretary of Housing
16 and Urban Development by allocating to the State of New
17 Jersey the proportion of the metropolitan division’s
18 amount that is based on the number of cases of AIDS
19 reported in the portion of the metropolitan division that
20 is located in New Jersey, and adjusting for the proportion
21 of the metropolitan division’s high incidence bonus if this
22 area in New Jersey also has a higher than average per
23 capita incidence of AIDS. The State of New Jersey shall
24 use amounts allocated to the State under this subsection
25 to carry out eligible activities under section 855 of the

1 AIDS Housing Opportunity Act (42 U.S.C. 12904) in the
2 portion of the metropolitan division that is located in New
3 Jersey.

4 (b) Notwithstanding any other provision of law, the
5 Secretary of Housing and Urban Development shall allo-
6 cate to Wake County, North Carolina, the amounts that
7 otherwise would be allocated for fiscal year 2006 under
8 section 854(c) of the AIDS Housing Opportunity Act (42
9 U.S.C. 12903(c)) to the City of Raleigh, North Carolina,
10 on behalf of the Raleigh-Cary, North Carolina Metropoli-
11 tan Statistical Area. Any amounts allocated to Wake
12 County shall be used to carry out eligible activities under
13 section 855 of such Act (42 U.S.C. 12904) within such
14 metropolitan statistical area.

15 (c) Notwithstanding section 854(c) of the AIDS
16 Housing Opportunity Act (42 U.S.C. 12903(c)), the Sec-
17 retary of Housing and Urban Development may adjust the
18 allocation of the amounts that otherwise would be allo-
19 cated for fiscal year 2006 under section 854(c) of such
20 Act, upon the written request of an applicant, in conjunc-
21 tion with the State(s), for a formula allocation on behalf
22 of a metropolitan statistical area, to designate the State
23 or States in which the metropolitan statistical area is lo-
24 cated as the eligible grantee(s) of the allocation. In the
25 case that a metropolitan statistical area involves more

1 than one State, such amounts allocated to each State shall
2 be in proportion to the number of cases of AIDS reported
3 in the portion of the metropolitan statistical area located
4 in that State. Any amounts allocated to a State under this
5 section shall be used to carry out eligible activities within
6 the portion of the metropolitan statistical area located in
7 that State.

8 SEC. 313. Notwithstanding any other provision of
9 law, for this fiscal year and every fiscal year thereafter,
10 funds appropriated for housing for the elderly, as author-
11 ized by section 202 of the Housing Act of 1959, as amend-
12 ed, and for supportive housing for persons with disabil-
13 ities, as authorized by section 811 of the Cranston-Gon-
14 zalez National Affordable Housing Act, shall be available
15 for the cost of maintaining and disposing of such prop-
16 erties that are acquired or otherwise become the responsi-
17 bility of the Department.

18 SEC. 314. The Secretary of Housing and Urban De-
19 velopment shall submit an annual report no later than Au-
20 gust 30, 2006 and annually thereafter to the House and
21 Senate Committees on Appropriations regarding the num-
22 ber of Federally assisted units under lease and the per
23 unit cost of these units to the Department of Housing and
24 Urban Development.

1 SEC. 315. The Department of Housing and Urban
2 Development shall submit the Department's fiscal year
3 2006 congressional budget justifications to the Commit-
4 tees on Appropriations of the House of Representatives
5 and the Senate using the identical structure provided
6 under this Act and only in accordance with the direction
7 specified in the report accompanying this Act.

8 SEC. 316. That incremental vouchers previously made
9 available under the heading "Housing Certificate Fund"
10 or renewed under the heading, "Tenant-Based Rental As-
11 sistance," for non-elderly disabled families shall, to the ex-
12 tent practicable, continue to be provided to non-elderly dis-
13 abled families upon turnover.

14 SEC. 317. A public housing agency or such other enti-
15 ty that administers Federal housing assistance in the
16 States of Alaska, Iowa, and Mississippi shall not be re-
17 quired to include a resident of public housing or a recipi-
18 ent of assistance provided under section 8 of the United
19 States Housing Act of 1937 on the board of directors or
20 a similar governing board of such agency or entity as re-
21 quired under section (2)(b) of such Act. Each public hous-
22 ing agency or other entity that administers Federal hous-
23 ing assistance under section 8 in the States of Alaska,
24 Iowa and Mississippi shall establish an advisory board of
25 not less than 6 residents of public housing or recipients

1 of section 8 assistance to provide advice and comment to
2 the public housing agency or other administering entity
3 on issues related to public housing and section 8. Such
4 advisory board shall meet not less than quarterly.

5 SEC. 318. The funds made available for Native Alas-
6 kans under the heading “Native American Housing Block
7 Grants” in title II of this Act shall be allocated to the
8 same Native Alaskan housing block grant recipients that
9 received funds in fiscal year 2005.

10 SEC. 319. No funds provided under this title may be
11 used for an audit of the Government National Mortgage
12 Association that makes applicable requirements under the
13 Federal Credit Reform Act of 1990 (2 U.S.C. 661 et seq.).

14 SEC. 320. CLARIFICATION REGARDING MORTGAGE
15 INSURANCE FOR PURCHASE OF EXISTING HEALTH CARE
16 FACILITIES.—Section 223(f)(1) of the National Housing
17 Act is amended by inserting “purchase or” immediately
18 before “refinancing of existing debt”.

19 SEC. 321. Notwithstanding any other provision of
20 law, for fiscal year 2006 and thereafter, all mortgagees
21 receiving interest reduction payments under section 236
22 of the National Housing Act (12 U.S.C. 1715z–1) shall
23 submit only electronic invoices to the Department of
24 Housing and Development in order to receive such pay-
25 ments. The mortgagees shall comply with this requirement

1 no later than 90 days from the date of enactment of this
 2 provision.

3 SEC. 322. Notwithstanding any other provision of
 4 law, the recipient of a grant under section 202b of the
 5 Housing Act of 1959 (12 U.S.C. 1701q–2) after Decem-
 6 ber 26, 2000, in accordance with the unnumbered para-
 7 graph at the end of section 202b(b) of such Act, may, at
 8 its option, establish a single-asset nonprofit entity to own
 9 the project and may lend the grant funds to such entity,
 10 which may be a private nonprofit organization described
 11 in section 831 of the American Homeownership and Eco-
 12 nomic Opportunity Act of 2000.

13 TITLE IV—THE JUDICIARY

14 SUPREME COURT OF THE UNITED STATES

15 SALARIES AND EXPENSES

16 For expenses necessary for the operation of the Su-
 17 preme Court, as required by law, excluding care of the
 18 building and grounds, including purchase or hire, driving,
 19 maintenance, and operation of an automobile for the Chief
 20 Justice, not to exceed \$10,000 for the purpose of trans-
 21 porting Associate Justices, and hire of passenger motor
 22 vehicles as authorized by 31 U.S.C. 1343 and 1344; not
 23 to exceed \$10,000 for official reception and representation
 24 expenses; and for miscellaneous expenses, to be expended

1 as the Chief Justice may approve, \$60,730,000, of which
2 \$2,000,000 shall remain available until expended.

3 CARE OF THE BUILDING AND GROUNDS

4 For such expenditures as may be necessary to enable
5 the Architect of the Capitol to carry out the duties im-
6 posed upon the Architect by the Act approved May 7,
7 1934 (40 U.S.C. 13a–13b), \$5,624,000, which shall re-
8 main available until expended.

9 UNITED STATES COURT OF APPEALS FOR THE FEDERAL
10 CIRCUIT

11 SALARIES AND EXPENSES

12 For salaries of the chief judge, judges, and other offi-
13 cers and employees, and for necessary expenses of the
14 court, as authorized by law, \$24,613,000.

15 UNITED STATES COURT OF INTERNATIONAL TRADE

16 SALARIES AND EXPENSES

17 For salaries of the chief judge and eight judges, sala-
18 ries of the officers and employees of the court, services,
19 and necessary expenses of the court, as authorized by law,
20 \$15,480,000.

21 COURTS OF APPEALS, DISTRICT COURTS, AND OTHER

22 JUDICIAL SERVICES

23 SALARIES AND EXPENSES

24 For the salaries of circuit and district judges (includ-
25 ing judges of the territorial courts of the United States),
26 justices and judges retired from office or from regular ac-

1 tive service, judges of the United States Court of Federal
2 Claims, bankruptcy judges, magistrate judges, and all
3 other officers and employees of the Federal Judiciary not
4 otherwise specifically provided for, and necessary expenses
5 of the courts, as authorized by law, \$4,348,780,000 (in-
6 cluding the purchase of firearms and ammunition); of
7 which not to exceed \$27,817,000 shall remain available
8 until expended for space alteration projects and for fur-
9 niture and furnishings related to new space alteration and
10 construction projects; of which \$1,300,000 of the funds
11 provided for the Judiciary Information Technology Fund
12 will be for the Edwin L. Nelson Local Initiatives Program,
13 within which \$1,000,000 will be reserved for local court
14 grants.

15 In addition, for expenses of the United States Court
16 of Federal Claims associated with processing cases under
17 the National Childhood Vaccine Injury Act of 1986, not
18 to exceed \$3,833,000, to be appropriated from the Vaccine
19 Injury Compensation Trust Fund.

20 DEFENDER SERVICES

21 For the operation of Federal Defender organizations;
22 the compensation and reimbursement of expenses of attor-
23 neys appointed to represent persons under the Criminal
24 Justice Act of 1964, as amended (18 U.S.C. 3006A); the
25 compensation and reimbursement of expenses of persons
26 furnishing investigative, expert and other services under

1 the Criminal Justice Act of 1964 as amended (18 U.S.C.
2 3006A(e)); the compensation (in accordance with Criminal
3 Justice Act maximums) and reimbursement of expenses
4 of attorneys appointed to assist the court in criminal cases
5 where the defendant has waived representation by counsel;
6 the compensation and reimbursement of travel expenses
7 of guardians ad litem acting on behalf of financially eligi-
8 ble minor or incompetent offenders in connection with
9 transfers from the United States to foreign countries with
10 which the United States has a treaty for the execution
11 of penal sentences; the compensation of attorneys ap-
12 pointed to represent jurors in civil actions for the protec-
13 tion of their employment, as authorized by 28 U.S.C.
14 1875(d); and for necessary training and general adminis-
15 trative expenses, \$721,919,000, to remain available until
16 expended.

17 FEES OF JURORS AND COMMISSIONERS

18 For fees and expenses of jurors as authorized by 28
19 U.S.C. 1871 and 1876; compensation of jury commis-
20 sioners as authorized by 28 U.S.C. 1863; and compensa-
21 tion of commissioners appointed in condemnation cases
22 pursuant to rule 71A(h) of the Federal Rules of Civil Pro-
23 cedure (28 U.S.C. Appendix Rule 71A(h)), \$60,053,000,
24 to remain available until expended: *Provided*, That the
25 compensation of land commissioners shall not exceed the

1 daily equivalent of the highest rate payable under section
2 5332 of title 5, United States Code.

3 COURT SECURITY

4 (INCLUDING TRANSFER OF FUNDS)

5 For necessary expenses, not otherwise provided for,
6 incident to the provision of protective guard services for
7 United States courthouses and other facilities housing
8 Federal court operations, and the procurement, installa-
9 tion, and maintenance of security systems and equipment
10 for United States courthouses and other facilities housing
11 Federal court operations, including building ingress-egress
12 control, inspection of mail and packages, directed security
13 patrols, perimeter security, basic security services provided
14 by the Federal Protective Service, and other similar activi-
15 ties as authorized by section 1010 of the Judicial Improve-
16 ment and Access to Justice Act (Public Law 100–702),
17 \$379,461,000, of which not to exceed \$15,000,000 shall
18 remain available until expended, to be expended directly
19 or transferred to the United States Marshals Service,
20 which shall be responsible for administering the Judicial
21 Facility Security Program consistent with standards or
22 guidelines agreed to by the Director of the Administrative
23 Office of the United States Courts and the Attorney Gen-
24 eral.

1 ADMINISTRATIVE OFFICE OF THE UNITED STATES

2 COURTS

3 SALARIES AND EXPENSES

4 For necessary expenses of the Administrative Office
5 of the United States Courts as authorized by law, includ-
6 ing travel as authorized by 31 U.S.C. 1345, hire of a pas-
7 senger motor vehicle as authorized by 31 U.S.C. 1343(b),
8 advertising and rent in the District of Columbia and else-
9 where, \$70,262,000, of which not to exceed \$8,500 is au-
10 thorized for official reception and representation expenses.

11 FEDERAL JUDICIAL CENTER

12 SALARIES AND EXPENSES

13 For necessary expenses of the Federal Judicial Cen-
14 ter, as authorized by Public Law 90–219, \$22,249,000;
15 of which \$1,800,000 shall remain available through Sep-
16 tember 30, 2007, to provide education and training to
17 Federal court personnel; and of which not to exceed
18 \$1,500 is authorized for official reception and representa-
19 tion expenses.

20 JUDICIAL RETIREMENT FUNDS

21 PAYMENT TO JUDICIARY TRUST FUNDS

22 For payment to the Judicial Officers' Retirement
23 Fund, as authorized by 28 U.S.C. 377(o), \$36,800,000;
24 to the Judicial Survivors' Annuities Fund, as authorized
25 by 28 U.S.C. 376(c), \$600,000; and to the United States

1 Court of Federal Claims Judges' Retirement Fund, as au-
2 thorized by 28 U.S.C. 178(l), \$3,200,000.

3 UNITED STATES SENTENCING COMMISSION

4 SALARIES AND EXPENSES

5 For the salaries and expenses necessary to carry out
6 the provisions of chapter 58 of title 28, United States
7 Code, \$14,046,000, of which not to exceed \$1,000 is au-
8 thorized for official reception and representation expenses.

9 ADMINISTRATIVE PROVISIONS—THE JUDICIARY

10 SEC. 401. Appropriations and authorizations made in
11 this title which are available for salaries and expenses shall
12 be available for services as authorized by 5 U.S.C. 3109.

13 SEC. 402. Not to exceed 5 percent of any appropria-
14 tion made available for the current fiscal year for the Judi-
15 ciary in this Act may be transferred between such appro-
16 priations, but no such appropriation, except “Courts of
17 Appeals, District Courts, and Other Judicial Services, De-
18 fender Services” and “Courts of Appeals, District Courts,
19 and Other Judicial Services, Fees of Jurors and Commis-
20 sioners”, shall be increased by more than 10 percent by
21 any such transfers: *Provided*, That any transfer pursuant
22 to this section shall be treated as a reprogramming of
23 funds under section 810 of this Act and shall not be avail-
24 able for obligation or expenditure except in compliance
25 with the procedures set forth in that section.

1 SEC. 403. Notwithstanding any other provision of
2 law, the salaries and expenses appropriation for Courts of
3 Appeals, District Courts, and Other Judicial Services shall
4 be available for official reception and representation ex-
5 penses of the Judicial Conference of the United States:
6 *Provided*, That such available funds shall not exceed
7 \$11,000 and shall be administered by the Director of the
8 Administrative Office of the United States Courts in the
9 capacity as Secretary of the Judicial Conference.

10 TITLE V—THE DISTRICT OF COLUMBIA

11 FEDERAL FUNDS

12 FEDERAL PAYMENT FOR RESIDENT TUITION SUPPORT

13 For a Federal payment to the District of Columbia,
14 to be deposited into a dedicated account, for a nationwide
15 program to be administered by the Mayor, for District of
16 Columbia resident tuition support, \$33,200,000, to remain
17 available until expended: *Provided*, That such funds, in-
18 cluding any interest accrued thereon, may be used on be-
19 half of eligible District of Columbia residents to pay an
20 amount based upon the difference between in-State and
21 out-of-State tuition at public institutions of higher edu-
22 cation, or to pay up to \$2,500 each year at eligible private
23 institutions of higher education: *Provided further*, That the
24 awarding of such funds may be prioritized on the basis
25 of a resident's academic merit, the income and need of

1 eligible students and such other factors as may be author-
2 ized: *Provided further*, That the District of Columbia gov-
3 ernment shall maintain a dedicated account for the Resi-
4 dent Tuition Support Program that shall consist of the
5 Federal funds appropriated to the Program in this Act
6 and any subsequent appropriations, any unobligated bal-
7 ances from prior fiscal years, and any interest earned in
8 this or any fiscal year: *Provided further*, That the account
9 shall be under the control of the District of Columbia
10 Chief Financial Officer, who shall use those funds solely
11 for the purposes of carrying out the Resident Tuition Sup-
12 port Program: *Provided further*, That the Office of the
13 Chief Financial Officer shall provide a quarterly financial
14 report to the Committees on Appropriations of the House
15 of Representatives and Senate for these funds showing,
16 by object class, the expenditures made and the purpose
17 therefor: *Provided further*, That not more than \$1,200,000
18 of the total amount appropriated for this program may
19 be used for administrative expenses.

20 FEDERAL PAYMENT FOR EMERGENCY PLANNING AND
21 SECURITY COSTS IN THE DISTRICT OF COLUMBIA

22 For necessary expenses, as determined by the Mayor
23 of the District of Columbia in written consultation with
24 the elected county or city officials of surrounding jurisdic-
25 tions, \$15,000,000, to remain available until expended, to
26 reimburse the District of Columbia for the costs of pro-

1 viding public safety at events related to the presence of
2 the national capital in the District of Columbia and for
3 the costs of providing support to respond to immediate
4 and specific terrorist threats or attacks in the District of
5 Columbia or surrounding jurisdictions: *Provided*, That any
6 amount provided under this heading shall be available only
7 after notice of its proposed use has been transmitted by
8 the President to Congress and such amount has been ap-
9 portioned pursuant to chapter 15 of title 31, United
10 States Code.

11 FEDERAL PAYMENT TO THE DISTRICT OF COLUMBIA

12 COURTS

13 For salaries and expenses for the District of Colum-
14 bia Courts, \$221,693,000, to be allocated as follows: for
15 the District of Columbia Court of Appeals, \$9,198,000,
16 of which not to exceed \$1,500 is for official reception and
17 representation expenses; for the District of Columbia Su-
18 perior Court, \$87,342,000, of which not to exceed \$1,500
19 is for official reception and representation expenses; for
20 the District of Columbia Court System, \$41,643,000, of
21 which not to exceed \$1,500 is for official reception and
22 representation expenses; and \$83,510,000, to remain
23 available until September 30, 2007, for capital improve-
24 ments for District of Columbia courthouse facilities: *Pro-*
25 *vided*, That notwithstanding any other provision of law,
26 a single contract or related contracts for development and

1 construction of facilities may be employed which collec-
2 tively include the full scope of the project: *Provided fur-*
3 *ther*, That the solicitation and contract shall contain the
4 clause “availability of Funds” found at 48 CFR 52.232–
5 18: *Provided further*, That funds made available for capital
6 improvements shall be expended consistent with the Gen-
7 eral Services Administration master plan study and build-
8 ing evaluation report: *Provided further*, That notwith-
9 standing any other provision of law, all amounts under
10 this heading shall be apportioned quarterly by the Office
11 of Management and Budget and obligated and expended
12 in the same manner as funds appropriated for salaries and
13 expenses of other Federal agencies, with payroll and finan-
14 cial services to be provided on a contractual basis with
15 the General Services Administration (GSA), and such
16 services shall include the preparation of monthly financial
17 reports, copies of which shall be submitted directly by GSA
18 to the President and to the Committees on Appropriations
19 of the House of Representatives and Senate, the Com-
20 mittee on Government Reform of the House of Represent-
21 atives, and the Committee on Governmental Affairs of the
22 Senate: *Provided further*, That 30 days after providing
23 written notice to the Committees on Appropriations of the
24 House of Representatives and Senate, the District of Co-
25 lumbia Courts may reallocate not more than \$1,000,000

1 of the funds provided under this heading among the items
2 and entities funded under this heading for operations, and
3 not more than 4 percent of the funds provided under this

17 under chapter 3 of title 16, D.C. Code, and payments for

21 and Durable Power of Attorney Act of 1986),
22 \$45,000,000, to remain available until expended: *Pro-*
23 *vided*, That the funds provided in this Act under the head-
24 ing “Federal Payment to the District of Columbia Courts”

26 for capital improvements for District of Columbia court-

1 house facilities) may also be used for payments under this
2 heading: *Provided further*, That in addition to the funds
3 provided under this heading, the Joint Committee on Ju-
4 dicial Administration in the District of Columbia may use
5 funds provided in this Act under the heading “Federal
6 Payment to the District of Columbia Courts” (other than
7 the \$83,510,000 provided under such heading for capital
8 improvements for District of Columbia courthouse facili-
9 ties), to make payments described under this heading for
10 obligations incurred during any fiscal year: *Provided fur-*
11 *ther*, That funds provided under this heading shall be ad-
12 ministered by the Joint Committee on Judicial Adminis-
13 tration in the District of Columbia: *Provided futher*, That
14 notwithstanding any other provision of law, this appro-
15 priation shall be apportioned quarterly by the Office of
16 Management and Budget and obligated and expended in
17 the same manner as funds appropriated for expenses of
18 other Federal agencies, with payroll and financial services
19 to be provided on a contractual basis with the General
20 Services Administration (GSA), and such services shall in-

6 (INCLUDING TRANSFER OF FUNDS)

7 For salaries and expenses, including the transfer and
8 hire of motor vehicles, of the Court Services and Offender
9 Supervision Agency for the District of Columbia and the
10 Public Defender Service for the District of Columbia, as
11 authorized by the National Capital Revitalization and Self-
12 Government Improvement Act of 1997, \$203,388,000, of
13 which not to exceed \$2,000 is for official receptions and
14 representation expenses related to Community Supervision
15 and Pretrial Services Agency programs; of which not to
16 exceed \$25,000 is for dues and assessments relating to
17 the implementation of the Court Services and Offender
18 Supervision Agency Interstate Supervision Act of 2002;
19 of which \$131,360,000 shall be for necessary expenses of
20 Community Supervision and Sex Offender Registration, to
21 include expenses relating to the supervision of adults sub-
22 ject to protection orders or the provision of services for
23 or related to such persons; of which \$42,195,000 shall be
24 available to the Pretrial Services Agency; and of which
25 \$29,833,000 shall be transferred to the Public Defender
26 Service for the District of Columbia: *Provided*, That not-

1 withstanding any other provision of law, all amounts
2 under this heading shall be apportioned quarterly by the
3 Office of Management and Budget and obligated and ex-
4 pended in the same manner as funds appropriated for sal-
5 aries and expenses of other Federal agencies: *Provided fur-*
6 *ther*, That the Director is authorized to accept and use
7 gifts in the form of in-kind contributions of space and hos-
8 pitality to support offender and defendant programs, and
9 equipment and vocational training services to educate and
10 train offenders and defendants: *Provided further*, That the
11 Director shall keep accurate and detailed records of the
12 acceptance and use of any gift or donation under the pre-
13 vious proviso, and shall make such records available for
14 audit and public inspection: *Provided further*, That the
15 Court Services and Offender Supervision Agency Director
16 is authorized to accept and use reimbursement from the
17 D.C. Government for space and services provided on a cost
18 reimbursable basis: *Provided further*, That the Public De-
19 fender Service is authorized to charge fees to cover costs
20 of materials distributed and training provided to attendees
21 of educational events, including conferences, sponsored by
22 the Public Defender Service, and notwithstanding section
23 3302 of title 31, United States Code, said fees shall be
24 credited to the Public Defender Service account to be
25 available for use without further appropriation.

1 FEDERAL PAYMENT TO THE DISTRICT OF COLUMBIA
2 WATER AND SEWER AUTHORITY

3 For a Federal payment to the District of Columbia
4 Water and Sewer Authority, \$10,000,000, to remain avail-
5 able until expended, to continue implementation of the
6 Combined Sewer Overflow Long-Term Plan: *Provided*,
7 That the District of Columbia Water and Sewer Authority
8 provides a 100 percent match for this payment.

9 FEDERAL PAYMENT FOR THE ANACOSTIA WATERFRONT
10 INITIATIVE

11 For a Federal payment to the District of Columbia
12 Department of Transportation, \$5,000,000, to remain
13 available until September 30, 2007, for design and con-
14 struction of a continuous pedestrian and bicycle trail sys-
15 tem from the Potomac River to the District's border with
16 Maryland.

17 FEDERAL PAYMENT TO THE CRIMINAL JUSTICE
18 COORDINATING COUNCIL

19 For a Federal payment to the Criminal Justice Co-
20 ordinating Council, \$1,300,000, to remain available until
21 expended, to support initiatives related to the coordination
22 of Federal and local criminal justice resources in the Dis-
23 trict of Columbia.

1 FEDERAL PAYMENT TO THE OFFICE OF THE CHIEF
2 FINANCIAL OFFICER OF THE DISTRICT OF COLUMBIA

3 For a Federal payment to the Office of the Chief Fi-
4 nancial Officer of the District of Columbia, \$20,000,000:
5 *Provided*, That each entity that receives funding under
6 this heading shall submit to the Office of the Chief Finan-
7 cial Officer of the District of Columbia (CFO) a report
8 on the activities to be carried out with such funds no later
9 than March 15, 2006, and the CFO shall submit a com-
10 prehensive report to the Committees on Appropriations of
11 the House of Representatives and the Senate no later
12 June 1, 2006.

13 FEDERAL PAYMENT FOR SCHOOL IMPROVEMENT

14 For a Federal payment for a school improvement pro-
15 gram in the District of Columbia, \$41,616,000, to be allo-
16 cated as follows: for the District of Columbia Public
17 Schools, \$13,525,000 to improve public school education
18 in the District of Columbia; for the State Education Of-
19 fice, \$13,525,000 to expand quality public charter schools
20 in the District of Columbia, to remain available until Sep-
21 tember 30, 2007; for the Secretary of the Department of
22 Education, \$14,566,000 to provide opportunity scholar-
23 ships for students in the District of Columbia in accord-
24 ance with division C, title III of the District of Columbia
25 Appropriations Act, 2004 (Public Law 108–199; 118 Stat.

1 126), of which up to \$1,000,000 may be used to admin-
 2 ister and fund assessments.

3 FEDERAL PAYMENT FOR BIOTERRORISM AND FORENSICS

4 LABORATORY

5 For a Federal payment to the District of Columbia,
 6 \$7,200,000, to remain available until September 30, 2007,
 7 for design, planning, and procurement costs associated
 8 with the construction of a bioterrorism and forensics lab-
 9 oratory: *Provided*, That the District of Columbia shall pro-
 10 vide an additional \$1,500,000 with local funds as a condi-
 11 tion of receiving this payment.

12 DISTRICT OF COLUMBIA FUNDS

13 The following amounts are appropriated for the Dis-
 14 trict of Columbia for the current fiscal year out of the
 15 general fund of the District of Columbia, except as other-
 16 wise specifically provided: *Provided*, That notwithstanding
 17 any other provision of law, except as provided in section
 18 450A of the District of Columbia Home Rule Act (D.C.
 19 Official Code, sec. 1-204.50a) and provisions of this Act,
 20 the total amount appropriated in this Act for operating
 21 expenses for the District of Columbia for fiscal year 2006
 22 under this heading shall not exceed the lesser of the sum
 23 of the total revenues of the District of Columbia for such
 24 fiscal year or \$8,700,158,000 (of which \$5,007,344,000
 25 shall be from local funds, \$1,921,287,000 shall be from
 26 Federal grant funds, \$1,754,399,000 shall be from other

1 funds, and \$17,129,000 shall be from private funds), in
2 addition, \$163,116,000 from funds previously appro-
3 priated in this Act as Federal payments: *Provided further*,
4 That of the local funds, \$466,830,000 shall be derived
5 from the District's general fund balance: *Provided further*,
6 That of these funds the District's intradistrict authority
7 shall be \$468,486,000: *Provided further*, That the
8 amounts provided under this heading are to be allocated
9 and expended as proposed under "Title II-District of Co-
10 lumbia Funds" of the Fiscal Year 2006 Proposed Budget
11 and Financial Plan submitted to the Congress of the
12 United States by the District of Columbia on June 6,
13 2005: *Provided further*, That this amount may be in-
14 creased by proceeds of one-time transactions, which are
15 expended for emergency or unanticipated operating or
16 capital needs: *Provided further*, That such increases shall
17 be approved by enactment of local District law and shall
18 comply with all reserve requirements contained in the Dis-
19 trict of Columbia Home Rule Act as amended by this Act:
20 *Provided further*, That the Chief Financial Officer of the
21 District of Columbia shall take such steps as are necessary
22 to assure that the District of Columbia meets these re-
23 quirements, including the apportioning by the Chief Fi-
24 nancial Officer of the appropriations and funds made
25 available to the District during fiscal year 2006, except

1 that the Chief Financial Officer may not reprogram for
2 operating expenses any funds derived from bonds, notes,
3 or other obligations issued for capital projects.

4 GOVERNMENTAL DIRECTION AND SUPPORT

5 ADMINISTRATIVE PROVISIONS—DISTRICT OF COLUMBIA

6 SEC. 501. Whenever in this title, an amount is speci-
7 fied within an appropriation for a particular purposes or
8 objects of expenditure, such amount, unless otherwise
9 specified, shall be considered as the maximum amount
10 that may be expended for said purpose or object rather
11 than an amount set apart exclusively therefor.

12 SEC. 502. Appropriations in this title shall be avail-
13 able for expenses of travel and for the payment of dues
14 of organizations concerned with the work of the District
15 of Columbia government, when authorized by the Mayor,
16 or, in the case of the Council of the District of Columbia,
17 funds may be expended with the authorization of the
18 Chairman of the Council.

19 SEC. 503. There are appropriated from the applicable
20 funds of the District of Columbia such sums as may be
21 necessary for making refunds and for the payment of legal
22 settlements or judgments that have been entered against
23 the District of Columbia government.

24 SEC. 504. (a) Except as provided in subsection (b),
25 no part of this appropriation shall be used for publicity
26 or propaganda purposes or implementation of any policy

1 including boycott designed to support or defeat legislation
2 pending before Congress or any State legislature.

3 (b) The District of Columbia may use local funds pro-
4 vided in this title to carry out lobbying activities on any
5 matter other than—

6 (1) the promotion or support of any boycott; or

7 (2) statehood for the District of Columbia or
8 voting representation in Congress for the District of
9 Columbia.

10 (c) Nothing in this section may be construed to pro-
11 hibit any elected official from advocating with respect to
12 any of the issues referred to in subsection (b).

13 SEC. 505. (a) None of the funds provided under this
14 title to the agencies funded by this title, both Federal and
15 District government agencies, that remain available for
16 obligation or expenditure in fiscal year 2006, or provided
17 from any accounts in the Treasury of the United States
18 derived by the collection of fees available to the agencies
19 funded by this title, shall be available for obligation or ex-
20 penditures for an agency through a reprogramming of
21 funds which—

22 (1) creates new programs;

23 (2) eliminates a program, project, or responsi-
24 bility center;

1 (3) establishes or changes allocations specifi-
2 cally denied, limited or increased under this Act;

3 (4) increases funds or personnel by any means
4 for any program, project, or responsibility center for
5 which funds have been denied or restricted;

6 (5) reestablishes any program or project pre-
7 viously deferred through reprogramming;

8 (6) augments any existing program, project, or
9 responsibility center through a reprogramming of
10 funds in excess of \$3,000,000 or 10 percent, which-
11 ever is less; or

12 (7) increases by 20 percent or more personnel
13 assigned to a specific program, project or responsi-
14 bility center,

15 unless the Committees on Appropriations of the House of
16 Representatives and Senate are notified in writing 15 days
17 in advance of the reprogramming.

18 (b) None the local funds contained in this title may
19 be available for obligation or expenditure for an agency
20 through a transfer of any local funds in excess of
21 \$3,000,000 from one appropriation heading to another un-
22 less the Committees on Appropriations of the House of
23 Representatives and Senate are notified in writing 15 days
24 in advance of the transfer, except that in no event may

1 the amount of any funds transferred exceed 4 percent of
2 the local funds in the appropriations.

3 SEC. 506. Consistent with the provisions of section
4 1301(a) of title 31, United States Code, appropriations
5 under this title shall be applied only to the objects for
6 which the appropriations were made except as otherwise
7 provided by law.

8 SEC. 507. Notwithstanding any other provisions of
9 law, the provisions of the District of Columbia Govern-
10 ment Comprehensive Merit Personnel Act of 1978 (D.C.
11 Law 2–139; D.C. Official Code, sec. 1–601.01 et seq.),
12 enacted pursuant to section 422(3) of the District of Co-
13 lumbia Home Rule Act (D.C. Official Code, sec. 1–
14 2041.22(3)), shall apply with respect to the compensation
15 of District of Columbia employees. For pay purposes, em-
16 ployees of the District of Columbia government shall not
17 be subject to the provisions of title 5, United States Code.

18 SEC. 508. No later than 30 days after the end of the
19 first quarter of fiscal year 2006, the Mayor of the District
20 of Columbia shall submit to the Council of the District
21 of Columbia and the Committees on Appropriations of the
22 House of Representatives and Senate the new fiscal year
23 2006 revenue estimates as of the end of such quarter.
24 These estimates shall be used in the budget request for

1 fiscal year 2007. The officially revised estimates at mid-
2 year shall be used for the midyear report.

3 SEC. 509. No sole source contract with the District
4 of Columbia government or any agency thereof may be re-
5 newed or extended without opening that contract to the
6 competitive bidding process as set forth in section 303 of
7 the District of Columbia Procurement Practices Act of
8 1985 (D.C. Law 6–85; D.C. Official Code, sec. 2–303.03),
9 except that the District of Columbia government or any
10 agency thereof may renew or extend sole source contracts
11 for which competition is not feasible or practical, but only
12 if the determination as to whether to invoke the competi-
13 tive bidding process has been made in accordance with
14 duly promulgated rules and procedures and has been re-
15 viewed and certified by the Chief Financial Officer of the
16 District of Columbia.

17 SEC. 510. None of the Federal funds provided in this
18 title may be used by the District of Columbia to provide
19 for salaries, expenses, or other costs associated with the
20 offices of United States Senator or United States Rep-
21 resentative under section 4(d) of the District of Columbia
22 Statehood Constitutional Convention Initiatives of 1979
23 (D.C. Law 3–171; D.C. Official Code, sec. 1–123).

24 SEC. 511. None of the Federal funds made available
25 in this title may be used to implement or enforce the

1 Health Care Benefits Expansion Act of 1992 (D.C. Law
2 9–114; D.C. Official Code, sec. 32–701 et seq.) or to oth-
3 erwise implement or enforce any system of registration of
4 unmarried, cohabiting couples, including but not limited
5 to registration for the purpose of extending employment,
6 health, or governmental benefits to such couples on the
7 same basis that such benefits are extended to legally mar-
8 ried couples.

9 SEC. 512. (a) Notwithstanding any other provision
10 of this title, the Mayor, in consultation with the Chief Fi-
11 nancial Officer of the District of Columbia may accept,
12 obligate, and expend Federal, private, and other grants
13 received by the District government that are not reflected
14 in the amounts appropriated in this title.

15 (b)(1) No such Federal, private, or other grant may
16 be obligated, or expended pursuant to subsection (a)
17 until—

18 (A) the Chief Financial Officer of the District
19 of Columbia submits to the Council a report setting
20 forth detailed information regarding such grant; and

21 (B) the Council has reviewed and approved the
22 obligation, and expenditure of such grant.

23 (2) For purposes of paragraph (1)(B), the Council
24 shall be deemed to have reviewed and approved the obliga-
25 tion, and expenditure of a grant if—

1 (A) no written notice of disapproval is filed with
2 the Secretary of the Council within 14 calendar days
3 of the receipt of the report from the Chief Financial
4 Officer under paragraph (1)(A); or

5 (B) if such a notice of disapproval is filed with-
6 in such deadline, the Council does not by resolution
7 disapprove the obligation, or expenditure of the
8 grant within 30 calendar days of the initial receipt
9 of the report from the Chief Financial Officer under
10 paragraph (1)(A).

11 (c) No amount may be obligated or expended from
12 the general fund or other funds of the District of Colum-
13 bia government in anticipation of the approval or receipt
14 of a grant under subsection (b)(2) or in anticipation of
15 the approval or receipt of a Federal, private, or other
16 grant not subject to such subsection.

17 (d) The Chief Financial Officer of the District of Co-
18 lumbia may adjust the budget for Federal, private, and
19 other grants received by the District government reflected
20 in the amounts appropriated in this title, or approved and
21 received under subsection (b)(2) to reflect a change in the
22 actual amount of the grant.

23 (e) The Chief Financial Officer of the District of Co-
24 lumbia shall prepare a quarterly report setting forth de-
25 tailed information regarding all Federal, private, and

1 other grants subject to this section. Each such report shall
2 be submitted to the Council of the District of Columbia
3 and to the Committees on Appropriations of the House
4 of Representatives and Senate not later than 15 days after
5 the end of the quarter covered by the report.

6 SEC. 513. (a) Except as otherwise provided in this
7 section, none of the funds made available by this title or
8 by any other title may be used to provide any officer or
9 employee of the District of Columbia with an official vehi-
10 cle unless the officer or employee uses the vehicle only in
11 the performance of the officer's or employee's official du-
12 ties. For purposes of this paragraph, the term "official
13 duties" does not include travel between the officer's or em-
14 ployee's residence and workplace, except in the case of—

15 (1) an officer or employee of the Metropolitan
16 Police Department who resides in the District of Co-
17 lumbia or is otherwise designated by the Chief of the
18 Department;

19 (2) at the discretion of the Fire Chief, an offi-
20 cer or employee of the District of Columbia Fire and
21 Emergency Medical Services Department who re-
22 sides in the District of Columbia and is on call 24
23 hours a day or is otherwise designated by the Fire
24 Chief;

25 (3) the Mayor of the District of Columbia; and

1 (4) the Chairman of the Council of the District
2 of Columbia.

3 (b) The Chief Financial Officer of the District of Co-
4 lumbia shall submit by March 1, 2006, an inventory, as
5 of September 30, 2005, of all vehicles owned, leased or
6 operated by the District of Columbia government. The in-
7 ventory shall include, but not be limited to, the depart-
8 ment to which the vehicle is assigned; the year and make
9 of the vehicle; the acquisition date and cost; the general
10 condition of the vehicle; annual operating and mainte-
11 nance costs; current mileage; and whether the vehicle is
12 allowed to be taken home by a District officer or employee
13 and if so, the officer or employee's title and resident loca-
14 tion.

15 SEC. 514. None of the funds contained in this title
16 may be used for purposes of the annual independent audit
17 of the District of Columbia government for fiscal year
18 2006 unless—

19 (1) the audit is conducted by the Inspector
20 General of the District of Columbia, in coordination
21 with the Chief Financial Officer of the District of
22 Columbia, pursuant to section 208(a)(4) of the Dis-
23 trict of Columbia Procurement Practices Act of
24 1985 (D.C. Official Code, sec. 2–302.8); and

1 (2) the audit includes as a basic financial state-
2 ment a comparison of audited actual year-end re-
3 sults with the revenues submitted in the budget doc-
4 ument for such year and the appropriations enacted
5 into law for such year using the format, terminology,
6 and classifications contained in the law making the
7 appropriations for the year and its legislative his-
8 tory.

9 SEC. 515. (a) None of the funds contained in this
10 title may be used by the District of Columbia Corporation
11 Counsel or any other officer or entity of the District gov-
12 ernment to provide assistance for any petition drive or civil
13 action which seeks to require Congress to provide for vot-
14 ing representation in Congress for the District of Colum-
15 bia.

16 (b) Nothing in this section bars the District of Co-
17 lumbia Corporation Counsel from reviewing or com-
18 menting on briefs in private lawsuits, or from consulting
19 with officials of the District government regarding such
20 lawsuits.

21 SEC. 516. (a) None of the funds contained in this
22 title may be used for any program of distributing sterile
23 needles or syringes for the hypodermic injection of any ille-
24 gal drug.

1 (b) Any individual or entity who receives any funds
2 contained in this title and who carries out any program
3 described in subsection (a) shall account for all funds used
4 for such program separately from any funds contained in
5 this title.

6 SEC. 517. None of the funds contained in this title
7 may be used after the expiration of the 60-day period that
8 begins on the date of the enactment of this title to pay
9 the salary of any chief financial officer of any office of
10 the District of Columbia government (including any inde-
11 pendent agency of the District of Columbia) who has not
12 filed a certification with the Mayor and the Chief Finan-
13 cial Officer of the District of Columbia that the officer
14 understands the duties and restrictions applicable to the
15 officer and the officer's agency as a result of this title (and
16 the amendments made by this title), including any duty
17 to prepare a report requested either in the title or in any
18 of the reports accompanying the title and the deadline by
19 which each report must be submitted: *Provided*, That the
20 Chief Financial Officer of the District of Columbia shall
21 provide to the Committees on Appropriations of the House
22 of Representatives and Senate by the 10th day after the
23 end of each quarter a summary list showing each report,
24 the due date, and the date submitted to the Committees.

1 SEC. 518. Nothing in this title may be construed to
2 prevent the Council or Mayor of the District of Columbia
3 from addressing the issue of the provision of contraceptive
4 coverage by health insurance plans, but it is the intent
5 of Congress that any legislation enacted on such issue
6 should include a “conscience clause” which provides excep-
7 tions for religious beliefs and moral convictions.

8 SEC. 519. The Mayor of the District of Columbia
9 shall submit to the Committees on Appropriations of the
10 House of Representatives and Senate, the Committee on
11 Government Reform of the House of Representatives, and
12 the Committee on Governmental Affairs of the Senate
13 quarterly reports addressing—

14 (1) crime, including the homicide rate, imple-
15 mentation of community policing, the number of po-
16 lice officers on local beats, and the closing down of
17 open-air drug markets;

18 (2) access to substance and alcohol abuse treat-
19 ment, including the number of treatment slots, the
20 number of people served, the number of people on
21 waiting lists, and the effectiveness of treatment pro-
22 grams;

23 (3) management of parolees and pre-trial vio-
24 lent offenders, including the number of halfway
25 houses escapes and steps taken to improve moni-

1 toring and supervision of halfway house residents to
2 reduce the number of escapes to be provided in con-
3 sultation with the Court Services and Offender Su-
4 pervision Agency for the District of Columbia;

5 (4) education, including access to special edu-
6 cation services and student achievement to be pro-
7 vided in consultation with the District of Columbia
8 Public Schools and the District of Columbia public
9 charter schools;

10 (5) improvement in basic District services, in-
11 cluding rat control and abatement;

12 (6) application for and management of Federal
13 grants, including the number and type of grants for
14 which the District was eligible but failed to apply
15 and the number and type of grants awarded to the
16 District but for which the District failed to spend
17 the amounts received; and

18 (7) indicators of child well-being.

19 SEC. 520. (a) No later than 30 calendar days after
20 the date of the enactment of this Act, the Chief Financial
21 Officer of the District of Columbia shall submit to the ap-
22 propriate committees of Congress, the Mayor, and the
23 Council of the District of Columbia a revised appropriated
24 funds operating budget in the format of the budget that
25 the District of Columbia government submitted pursuant

1 to section 442 of the District of Columbia Home Rule Act
2 (D.C. Official Code, sec. 1–204.42), for all agencies of the
3 District of Columbia government for fiscal year 2006 that
4 is in the total amount of the approved appropriation and
5 that realigns all budgeted data for personal services and
6 other-than-personal-services, respectively, with anticipated
7 actual expenditures.

8 (b) This section shall apply only to an agency where
9 the Chief Financial Officer of the District of Columbia
10 certifies that a reallocation is required to address unantici-
11 pated changes in program requirements.

12 SEC. 521. None of the Federal funds made available
13 in this title may be transferred to any department, agency,
14 or instrumentality of the United States Government, ex-
15 cept pursuant to a transfer made by, or transfer authority
16 provided in, this Act or any other appropriation Act.

17 SEC. 522. Notwithstanding any other law, in fiscal
18 year 2006 and in each subsequent fiscal year, the District
19 of Columbia Courts shall transfer to the general treasury
20 of the District of Columbia all fines levied and collected
21 by the Courts under section 10(b)(1) and (2) of the Dis-
22 trict of Columbia Traffic Act (D.C. Official Code, sec. 50–
23 2201.05(b)(1) and (2)): *Provided*, that the transferred
24 funds are hereby made available and shall remain available
25 until expended and shall be used by the Office of the At-

1 torney General of the District of Columbia for enforce-
2 ment and prosecution of District traffic alcohol laws in
3 accordance with section 10(b)(3) of the District of Colum-
4 bia Traffic Act (D.C. Official Code, sec. 50-
5 2201.05(b)(3)).

6 SEC. 523. (a) None of the funds contained in this
7 Act may be made available to pay—

8 (1) the fees of an attorney who represents a
9 party in an action or an attorney who defends an ac-
10 tion brought against the District of Columbia Public
11 Schools under the Individuals with Disabilities Edu-
12 cation Act (20 U.S.C. 1400 et seq.) in excess of
13 \$4,000 for that action; or

14 (2) the fees of an attorney or firm whom the
15 Chief Financial Officer of the District of Columbia
16 determines to have a pecuniary interest, either
17 through an attorney, officer, or employee of the
18 firm, in any special education diagnostic services,
19 schools, or other special education service providers.

20 (b) In this section, the term “action” includes an ad-
21 ministrative proceeding and any ensuing or related pro-
22 ceedings before a court of competent jurisdiction.

23 SEC. 524. The Chief Financial Officer of the District
24 of Columbia shall require attorneys in special education
25 cases brought under the Individuals with Disabilities Edu-

1 cation Act (IDEA) in the District of Columbia to certify
2 in writing that the attorney or representative rendered any
3 and all services for which they receive awards, including
4 those received under a settlement agreement or as part
5 of an administrative proceeding, under the IDEA from the
6 District of Columbia. As part of the certification, the Chief
7 Financial Officer of the District of Columbia shall require
8 all attorneys in IDEA cases to disclose any financial, cor-
9 porate, legal, memberships on boards of directors, or other
10 relationships with any special education diagnostic serv-
11 ices, schools, or other special education service providers
12 to which the attorneys have referred any clients as part
13 of this certification. The Chief Financial Officer shall pre-
14 pare and submit quarterly reports to the Committees on
15 Appropriations of the House of Representatives and Sen-
16 ate on the certification of and the amount paid by the gov-
17 ernment of the District of Columbia, including the District
18 of Columbia Public Schools, to attorneys in cases brought
19 under IDEA. The Inspector General of the District of Co-
20 lumbia may conduct investigations to determine the accu-
21 racy of the certifications.

22 SEC. 525. The amount appropriated by this title may
23 be increased by no more than \$42,000,000 from funds
24 identified in the comprehensive annual financial report as
25 the District's fiscal year 2005 unexpended general fund

1 surplus. The District may obligate and expend these
2 amounts only in accordance with the following conditions:

3 (1) The Chief Financial Officer of the District
4 of Columbia shall certify that the use of any such
5 amounts is not anticipated to have a negative impact
6 on the District's long-term financial, fiscal, and eco-
7 nomic vitality.

8 (2) The District of Columbia may only use
9 these funds for the following expenditures:

10 (A) One-time expenditures.

11 (B) Expenditures to avoid deficit spending.

12 (C) Debt Reduction.

13 (D) Program needs.

14 (E) Expenditures to avoid revenue short-
15 falls.

16 (3) The amounts shall be obligated and ex-
17 pended in accordance with laws enacted by the
18 Council in support of each such obligation or ex-
19 penditure.

20 (4) The amounts may not be used to fund the
21 agencies of the District of Columbia government
22 under court ordered receivership.

23 (5) The amounts may not be obligated or ex-
24 pended unless the Mayor notifies the Committees on
25 Appropriations of the House of Representatives and

1 Senate not fewer than 30 days in advance of the ob-
2 ligation or expenditure.

3 SEC. 526. (a) The fourth proviso in the item relating
4 to “Federal Payment for School Improvement” in the Dis-
5 trict of Columbia Appropriations Act, 2005 (Public Law
6 108–335; 118 Stat. 1327) is amended—

7 (1) by striking “\$4,000,000” and inserting
8 “\$4,000,000, to remain available until expended,”;
9 and

10 (2) by striking “\$2,000,000 shall be for a new
11 incentive fund” and inserting “\$2,000,000, to re-
12 main available until expended, shall be for a new in-
13 centive fund”.

14 (b) The amendments made by subsection (a) shall
15 take effect as if included in the enactment of the District
16 of Columbia Appropriations Act, 2005.

17 SEC. 527. (a) To account for an unanticipated growth
18 of revenue collections, the amount appropriated as District
19 of Columbia Funds pursuant to this Act may be in-
20 creased—

21 (1) by an aggregate amount of not more than
22 25 percent, in the case of amounts proposed to be
23 allocated as “Other-Type Funds” in the Fiscal Year
24 2006 Proposed Budget and Financial Plan sub-

1 mitted to Congress by the District of Columbia on
2 June 6, 2005; and

3 (2) by an aggregate amount of not more than
4 6 percent, in the case of any other amounts pro-
5 posed to be allocated in such Proposed Budget and
6 Financial Plan.

7 (b) The District of Columbia may obligate and ex-
8 pend any increase in the amount of funds authorized
9 under this section only in accordance with the following
10 conditions:

11 (1) The Chief Financial Officer of the District
12 of Columbia shall certify—

13 (A) the increase in revenue; and

14 (B) that the use of the amounts is not an-
15 ticipated to have a negative impact on the long-
16 term financial, fiscal, or economic health of the
17 District.

18 (2) The amounts shall be obligated and ex-
19 pended in accordance with laws enacted by the
20 Council of the District of Columbia in support of
21 each such obligation and expenditure, consistent
22 with the requirements of this Act.

23 (3) The amounts may not be used to fund any
24 agencies of the District government operating under
25 court-ordered receivership.

1 (4) The amounts may not be obligated or ex-
2 pended unless the Mayor has notified the Commit-
3 tees on Appropriations of the House of Representa-
4 tives and Senate not fewer than 30 days in advance
5 of the obligation or expenditure.

6 SEC. 528. (a) Notwithstanding section 450A of the
7 District of Columbia Home Rule Act, during fiscal year
8 2006 the District of Columbia may allocate amounts from
9 the emergency reserve fund established under section
10 450A(a) of such Act and the contingency reserve fund es-
11 tablished under section 450A(b) of such Act and use such
12 amounts to fund the operations of the District government

15 (b) The aggregate amount allocated from the emer-
16 gency reserve fund or the contingency reserve fund under
17 this section may not exceed 50 percent of the balance of
18 the fund involved as of October 1, 2005.

19 (c) If the District of Columbia allocates any amounts
20 from a reserve fund under this section, the District shall
21 fully replenish the fund for the amounts allocated not later
22 than February 15, 2007.

23 SEC. 529. Notwithstanding any other provision of
24 this Act, there is hereby appropriated for the Office of
25 the Inspector General such amounts in local funds, as are

1 consistent with the annual estimates for the expenditures
2 and appropriations necessary for the operation of the Of-
3 fice of the Inspector General as prepared by the Inspector
4 General and submitted to the Mayor and forwarded to the

OPERATING EXPENSES

For the care, maintenance, repair and alteration, re-furnishing, improvement, heating, and lighting, including electric power and fixtures, of the Executive Residence at the White House and official entertainment expenses of the President, \$12,436,000, to be expended and accounted for as provided by 3 U.S.C. 105, 109, 110, and 112–114.

REIMBURSABLE EXPENSES

For the reimbursable expenses of the Executive Residence at the White House, such sums as may be necessary: *Provided*, That all reimbursable operating expenses of the Executive Residence shall be made in accordance with the provisions of this paragraph: *Provided further*, That, notwithstanding any other provision of law, such amount for reimbursable operating expenses shall be the exclusive authority of the Executive Residence to incur obligations and to receive offsetting collections, for such expenses: *Provided further*, That the Executive Residence shall require each person sponsoring a reimbursable political event to pay in advance an amount equal to the estimated cost of the event, and all such advance payments shall be credited to this account and remain available until expended: *Provided further*, That the Executive Residence

1 shall require the national committee of the political party
2 of the President to maintain on deposit \$25,000, to be
3 separately accounted for and available for expenses relat-
4 ing to reimbursable political events sponsored by such
5 committee during such fiscal year: *Provided further*, That
6 the Executive Residence shall ensure that a written notice
7 of any amount owed for a reimbursable operating expense
8 under this paragraph is submitted to the person owing
9 such amount within 60 days after such expense is in-
10 curred, and that such amount is collected within 30 days
11 after the submission of such notice: *Provided further*, That
12 the Executive Residence shall charge interest and assess
13 penalties and other charges on any such amount that is
14 not reimbursed within such 30 days, in accordance with
15 the interest and penalty provisions applicable to an out-
16 standing debt on a United States Government claim under
17 section 3717 of title 31, United States Code: *Provided fur-*
18 *ther*, That each such amount that is reimbursed, and any
19 accompanying interest and charges, shall be deposited in
20 the Treasury as miscellaneous receipts: *Provided further*,
21 That the Executive Residence shall prepare and submit
22 to the Committees on Appropriations, by not later than
23 90 days after the end of the fiscal year covered by this
24 Act, a report setting forth the reimbursable operating ex-
25 penses of the Executive Residence during the preceding

1 fiscal year, including the total amount of such expenses,
2 the amount of such total that consists of reimbursable offi-
3 cial and ceremonial events, the amount of such total that
4 consists of reimbursable political events, and the portion
5 of each such amount that has been reimbursed as of the
6 date of the report: *Provided further*, That the Executive
7 Residence shall maintain a system for the tracking of ex-
8 penses related to reimbursable events within the Executive
9 Residence that includes a standard for the classification
10 of any such expense as political or nonpolitical: *Provided*
11 *further*, That no provision of this paragraph may be con-
12 strued to exempt the Executive Residence from any other
13 applicable requirement of subchapter I or II of chapter
14 37 of title 31, United States Code.

4 (INCLUDING TRANSFERS OF FUNDS)

5 SEC. 801. Such sums as may be necessary for fiscal
6 year 2006 pay raises for programs funded in this Act shall
7 be absorbed within the levels appropriated in this Act or
8 previous appropriations Acts.

9 SEC. 802. None of the funds in this Act shall be used
10 for the planning or execution of any program to pay the
11 expenses of, or otherwise compensate, non-Federal parties
12 intervening in regulatory or adjudicatory proceedings
13 funded in this Act.

14 SEC. 803. None of the funds appropriated in this Act
15 shall remain available for obligation beyond the current
16 fiscal year, nor may any be transferred to other appropria-
17 tions, unless expressly so provided herein.

18 SEC. 804. The expenditure of any appropriation
19 under this Act for any consulting service through procure-
20 ment contract pursuant to section 3109 of title 5, United
21 States Code, shall be limited to those contracts where such
22 expenditures are a matter of public record and available
23 for public inspection, except where otherwise provided
24 under existing law, or under existing Executive order
25 issued pursuant to existing law.

1 SEC. 805. None of the funds made available in this
2 Act may be transferred to any department, agency, or in-
3 strumentality of the United States Government, except
4 pursuant to a transfer made by, or transfer authority pro-
5 vided in, this Act or any other appropriations Act.

6 SEC. 806. None of the funds made available by this
7 Act shall be available for any activity or for paying the
8 salary of any Government employee where funding an ac-
9 tivity or paying a salary to a Government employee would
10 result in a decision, determination, rule, regulation, or pol-
11 icy that would prohibit the enforcement of section 307 of
12 the Tariff Act of 1930.

13 SEC. 807. No part of any appropriation contained in
14 this Act shall be available to pay the salary for any person
15 filling a position, other than a temporary position, for-
16 merly held by an employee who has left to enter the Armed
17 Forces of the United States and has satisfactorily com-
18 pleted his period of active military or naval service, and
19 has within 90 days after his release from such service or
20 from hospitalization continuing after discharge for a pe-
21 riod of not more than 1 year, made application for restora-
22 tion to his former position and has been certified by the
23 Office of Personnel Management as still qualified to per-
24 form the duties of his former position and has not been
25 restored thereto.

1 SEC. 808. No funds appropriated or otherwise made
2 available under this Act shall be made available to any
3 person or entity that has been convicted of violating the
4 Buy American Act (41 U.S.C. 10a–10c).

5 SEC. 809. None of the funds provided in this Act,
6 provided by previous appropriations Acts to the agencies
7 or entities funded in this Act that remain available for
8 obligation or expenditure in fiscal year 2005, or provided
9 from any accounts in the Treasury derived by the collec-
10 tion of fees and available to the agencies funded by this
11 Act, shall be available for obligation or expenditure
12 through a reprogramming of funds that: (1) creates a new
13 program; (2) eliminates a program, project, or activity; (3)
14 increases funds or personnel for any program, project, or
15 activity for which funds have been denied or restricted by
16 the Congress; (4) proposes to use funds directed for a spe-
17 cific activity by either the House or Senate Committees
18 on Appropriations for a different purpose; (5) augments
19 existing programs, projects, or activities in excess of
20 \$2,000,000 or 10 percent, whichever is greater; (6) re-
21 duces existing programs, projects, or activities by
22 \$2,000,000 or 10 percent, whichever is greater; or (7) cre-
23 ates, reorganizes, or restructures a branch, division, office,
24 bureau, board, commission, agency, administration, or de-
25 partment different from the budget justifications sub-

mitted to the Committees on Appropriations or the table accompanying the statement of the managers accompanying this Act, whichever is more detailed, unless prior approval is received from the House and Senate Committees on Appropriations: *Provided*, That not later than 60 days after the date of enactment of this Act, each agency funded by this Act shall submit a report to the Committee on Appropriations of the Senate and of the House of Representatives to establish the baseline for application of reprogramming and transfer authorities for the current fiscal year: *Provided further*, That the report shall include: (1) a table for each appropriation with a separate column to display the President's budget request, adjustments made by Congress, adjustments due to enacted rescissions, if appropriate, and the fiscal year enacted level; (2) a delineation in the table for each appropriation both by object class and program, project, and activity as detailed in the budget appendix for the respective appropriation; and (3) an identification of items of special congressional interest: *Provided further*, That the amount appropriated or limited for salaries and expenses for an agency shall be reduced by \$100,000 per day for each day after the required date that the report has not been submitted to the Congress.

SEC. 810. Except as otherwise specifically provided by law, not to exceed 50 percent of unobligated balances

1 remaining available at the end of fiscal year 2006 from
2 appropriations made available for salaries and expenses
3 for fiscal year 2006 in this Act, shall remain available
4 through September 30, 2007, for each such account for
5 the purposes authorized: *Provided*, That a request shall
6 be submitted to the Committees on Appropriations for ap-
7 proval prior to the expenditure of such funds: *Provided*
8 *further*, That these requests shall be made in compliance
9 with reprogramming guidelines.

10 SEC. 811. None of the funds made available in this
11 Act may be used by the Executive Office of the President
12 to request from the Federal Bureau of Investigation any
13 official background investigation report on any individual,
14 except when—

15 (1) such individual has given his or her express
16 written consent for such request not more than 6
17 months prior to the date of such request and during
18 the same presidential administration; or

19 (2) such request is required due to extraor-
20 dinary circumstances involving national security.

21 SEC. 812. The cost accounting standards promul-
22 gated under section 26 of the Office of Federal Procure-
23 ment Policy Act (Public Law 93–400; 41 U.S.C. 422)
24 shall not apply with respect to a contract under the Fed-

1 eral Employees Health Benefits Program established
2 under chapter 89 of title 5, United States Code.

3 SEC. 813. For the purpose of resolving litigation and
4 implementing any settlement agreements regarding the
5 nonforeign area cost-of-living allowance program, the Of-
6 fice of Personnel Management may accept and utilize
7 (without regard to any restriction on unanticipated travel
8 expenses imposed in an Appropriations Act) funds made
9 available to the Office pursuant to court approval.

10 SEC. 814. No funds appropriated by this Act shall
11 be available to pay for an abortion, or the administrative
12 expenses in connection with any health plan under the
13 Federal employees health benefits program which provides
14 any benefits or coverage for abortions.

15 SEC. 815. The provision of section 815 shall not
16 apply where the life of the mother would be endangered
17 if the fetus were carried to term, or the pregnancy is the
18 result of an act of rape or incest.

19 SEC. 816. In order to promote Government access to
20 commercial information technology, the restriction on pur-
21 chasing nondomestic articles, materials, and supplies set
22 forth in the Buy American Act (41 U.S.C. 10a et seq.),
23 shall not apply to the acquisition by the Federal Govern-
24 ment of information technology (as defined in section
25 11101 of title 40, United States Code), that is a commer-

1 cial item (as defined in section 4(12) of the Office of Fed-
2 eral Procurement Policy Act (41 U.S.C. 403(12)).

3 SEC. 817. None of the funds made available in the
4 Act may be used to finalize, implement, administer, or en-
5 force—

6 (1) the proposed rule relating to the determina-
7 tion that real estate brokerage is an activity that is
8 financial in nature or incidental to a financial activ-
9 ity published in the Federal Register on January 3,
10 2001 (66 Fed. Reg. 307 et seq.); or

11 (2) the revision proposed in such rule to section
12 1501.2 of title 12 of the Code of Federal Regula-
13 tions.

14 SEC. 818. Of the funds provided in title I of this Act
15 under the heading, “Office of the Secretary, Transpor-
16 tation Planning, Research, and Development”, \$3,000,000
17 shall be available for necessary expenses to reimburse
18 fixed-based general aviation operators and the providers
19 of general aviation ground support services at Ronald
20 Reagan Washington National Airport, and airports within
21 15 miles of Ronald Reagan Washington National Airport,
22 for financial losses incurred by these operators while such
23 airports were closed due to the actions of the Federal Gov-
24 ernment following the terrorist attacks on the United
25 States that occurred on September 11, 2001: *Provided,*

1 That such funds shall remain available until expended:
2 *Provided further*, That obligation and expenditure of these
3 funds shall be made conditional upon full release of the
4 United States Government for all claims arising from the
5 closing of these general aviation facilities.

6 SEC. 819. Section 640(c) of the Treasury and Gen-
7 eral Government Appropriations Act, 2000 (Public Law
8 106–58; 2 U.S.C. 437g note), as amended by section 642
9 of the Treasury and General Government Appropriations
10 Act, 2002 (Public Law 107–67) and by section 639 of the
11 Transportation, Treasury, and Independent Agencies Ap-
12 propriations Act, 2004 (Public Law 108–199), is amended
13 by striking “December 31, 2005” and inserting “Decem-
14 ber 31, 2008”.

15 TITLE IX—GENERAL PROVISIONS,
16 GOVERNMENT-WIDE

17 DEPARTMENTS, AGENCIES, AND CORPORATIONS

18 SEC. 901. Funds appropriated in this or any other
19 Act may be used to pay travel to the United States for
20 the immediate family of employees serving abroad in cases
21 of death or life threatening illness of said employee.

22 SEC. 902. No department, agency, or instrumentality
23 of the United States receiving appropriated funds under
24 this or any other Act for fiscal year 2006 shall obligate
25 or expend any such funds, unless such department, agen-

1 cy, or instrumentality has in place, and will continue to
2 administer in good faith, a written policy designed to en-
3 sure that all of its workplaces are free from the illegal
4 use, possession, or distribution of controlled substances
5 (as defined in the Controlled Substances Act) by the offi-
6 cers and employees of such department, agency, or instru-
7 mentality.

8 SEC. 903. Unless otherwise specifically provided, the
9 maximum amount allowable during the current fiscal year
10 in accordance with section 16 of the Act of August 2, 1946
11 (60 Stat. 810), for the purchase of any passenger motor
12 vehicle (exclusive of buses, ambulances, law enforcement,
13 and undercover surveillance vehicles), is hereby fixed at
14 \$8,100 except station wagons for which the maximum
15 shall be \$9,100: *Provided*, That these limits may be ex-
16 ceeded by not to exceed \$3,700 for police-type vehicles,
17 and by not to exceed \$4,000 for special heavy-duty vehi-
18 cles: *Provided further*, That the limits set forth in this sec-
19 tion may not be exceeded by more than 5 percent for elec-
20 tric or hybrid vehicles purchased for demonstration under
21 the provisions of the Electric and Hybrid Vehicle Re-
22 search, Development, and Demonstration Act of 1976:
23 *Provided further*, That the limits set forth in this section
24 may be exceeded by the incremental cost of clean alter-
25 native fuels vehicles acquired pursuant to Public Law

1 101–549 over the cost of comparable conventionally fueled
2 vehicles.

3 SEC. 904. Appropriations of the executive depart-
4 ments and independent establishments for the current fis-
5 cal year available for expenses of travel, or for the ex-
6 penses of the activity concerned, are hereby made available
7 for quarters allowances and cost-of-living allowances, in
8 accordance with 5 U.S.C. 5922–5924.

9 SEC. 905. Unless otherwise specified during the cur-
10 rent fiscal year, no part of any appropriation contained
11 in this or any other Act shall be used to pay the compensa-
12 tion of any officer or employee of the Government of the
13 United States (including any agency the majority of the
14 stock of which is owned by the Government of the United
15 States) whose post of duty is in the continental United
16 States unless such person: (1) is a citizen of the United
17 States; (2) is a person in the service of the United States
18 on the date of the enactment of this Act who, being eligible
19 for citizenship, has filed a declaration of intention to be-
20 come a citizen of the United States prior to such date and
21 is actually residing in the United States; (3) is a person
22 who owes allegiance to the United States; (4) is an alien
23 from Cuba, Poland, South Vietnam, the countries of the
24 former Soviet Union, or the Baltic countries lawfully ad-
25 mitted to the United States for permanent residence; (5)

1 is a South Vietnamese, Cambodian, or Laotian refugee pa-
2 roled in the United States after January 1, 1975; or (6)
3 is a national of the People's Republic of China who quali-
4 fies for adjustment of status pursuant to the Chinese Stu-
5 dent Protection Act of 1992: *Provided*, That for the pur-
6 pose of this section, an affidavit signed by any such person
7 shall be considered prima facie evidence that the require-
8 ments of this section with respect to his or her status have
9 been complied with: *Provided further*, That any person
10 making a false affidavit shall be guilty of a felony, and,
11 upon conviction, shall be fined no more than \$4,000 or
12 imprisoned for not more than 1 year, or both: *Provided*
13 *further*, That the above penal clause shall be in addition
14 to, and not in substitution for, any other provisions of ex-
15 isting law: *Provided further*, That any payment made to
16 any officer or employee contrary to the provisions of this
17 section shall be recoverable in action by the Federal Gov-
18 ernment. This section shall not apply to citizens of Ire-
19 land, Israel, or the Republic of the Philippines, or to na-
20 tionals of those countries allied with the United States in
21 a current defense effort, or to international broadcasters
22 employed by the United States Information Agency, or to
23 temporary employment of translators, or to temporary em-
24 ployment in the field service (not to exceed 60 days) as
25 a result of emergencies.

1 SEC. 906. Appropriations available to any depart-
2 ment or agency during the current fiscal year for nec-
3 essary expenses, including maintenance or operating ex-
4 penses, shall also be available for payment to the General
5 Services Administration for charges for space and services
6 and those expenses of renovation and alteration of build-
7 ings and facilities which constitute public improvements
8 performed in accordance with the Public Buildings Act of
9 1959 (73 Stat. 749), the Public Buildings Amendments
10 of 1972 (87 Stat. 216), or other applicable law.

11 SEC. 907. In addition to funds provided in this or
12 any other Act, all Federal agencies are authorized to re-
13 ceive and use funds resulting from the sale of materials,
14 including Federal records disposed of pursuant to a
15 records schedule recovered through recycling or waste pre-
16 vention programs. Such funds shall be available until ex-
17 pended for the following purposes:

18 (1) Acquisition, waste reduction and prevention,
19 and recycling programs as described in Executive
20 Order No. 13101 (September 14, 1998), including
21 any such programs adopted prior to the effective
22 date of the Executive order.

23 (2) Other Federal agency environmental man-
24 agement programs, including, but not limited to, the

1 development and implementation of hazardous waste
2 management and pollution prevention programs.

3 (3) Other employee programs as authorized by
4 law or as deemed appropriate by the head of the
5 Federal agency.

6 SEC. 908. Funds made available by this or any other
7 Act for administrative expenses in the current fiscal year
8 of the corporations and agencies subject to chapter 91 of
9 title 31, United States Code, shall be available, in addition
10 to objects for which such funds are otherwise available,
11 for rent in the District of Columbia; services in accordance
12 with 5 U.S.C. 3109; and the objects specified under this
13 head, all the provisions of which shall be applicable to the
14 expenditure of such funds unless otherwise specified in the
15 Act by which they are made available: *Provided*, That in
16 the event any functions budgeted as administrative ex-
17 penses are subsequently transferred to or paid from other
18 funds, the limitations on administrative expenses shall be
19 correspondingly reduced.

20 SEC. 909. No part of any appropriation for the cur-
21 rent fiscal year contained in this or any other Act shall
22 be paid to any person for the filling of any position for
23 which he or she has been nominated after the Senate has
24 voted not to approve the nomination of said person.

1 SEC. 910. No part of any appropriation contained in
2 this or any other Act shall be available for interagency
3 financing of boards (except Federal Executive Boards),
4 commissions, councils, committees, or similar groups
5 (whether or not they are interagency entities) which do
6 not have a prior and specific statutory approval to receive
7 financial support from more than one agency or instru-
8 mentality.

9 SEC. 911. Funds made available by this or any other
10 Act to the Postal Service Fund (39 U.S.C. 2003) shall
11 be available for employment of guards for all buildings and
12 areas owned or occupied by the Postal Service or under
13 the charge and control of the Postal Service. The Postal
14 Service may give such guards with respect to such prop-
15 erty, any of the powers of special policemen provided
16 under 40 U.S.C. 1315. The Postmaster General, or his
17 designee, may take any action that the Secretary of Home-
18 land Security may take under such section with respect
19 to that property.

20 SEC. 912. None of the funds made available pursuant
21 to the provisions of this Act shall be used to implement,
22 administer, or enforce any regulation which has been dis-
23 approved pursuant to a joint resolution duly adopted in
24 accordance with the applicable law of the United States.

1 SEC. 913. (a) Notwithstanding any other provision
2 of law, and except as otherwise provided in this section,
3 no part of any of the funds appropriated for fiscal year
4 2006, by this or any other Act, may be used to pay any
5 prevailing rate employee described in section
6 5342(a)(2)(A) of title 5, United States Code—

7 (1) during the period from the date of expira-
8 tion of the limitation imposed by the comparable sec-
9 tion for previous fiscal years until the normal effec-
10 tive date of the applicable wage survey adjustment
11 that is to take effect in fiscal year 2006, in an
12 amount that exceeds the rate payable for the appli-
13 cable grade and step of the applicable wage schedule
14 in accordance with such section; and

15 (2) during the period consisting of the remain-
16 der of fiscal year 2006, in an amount that exceeds,
17 as a result of a wage survey adjustment, the rate
18 payable under paragraph (1) by more than the sum
19 of—

20 (A) the percentage adjustment taking ef-
21 fect in fiscal year 2006 under section 5303 of
22 title 5, United States Code, in the rates of pay
23 under the General Schedule; and

24 (B) the difference between the overall aver-
25 age percentage of the locality-based com-

1 parability payments taking effect in fiscal year
2 2006 under section 5304 of such title (whether
3 by adjustment or otherwise), and the overall av-
4 erage percentage of such payments which was
5 effective in the previous fiscal year under such
6 section.

7 (b) Notwithstanding any other provision of law, no
8 prevailing rate employee described in subparagraph (B) or
9 (C) of section 5342(a)(2) of title 5, United States Code,
10 and no employee covered by section 5348 of such title,
11 may be paid during the periods for which subsection (a)
12 is in effect at a rate that exceeds the rates that would
13 be payable under subsection (a) were subsection (a) appli-
14 cable to such employee.

15 (c) For the purposes of this section, the rates payable
16 to an employee who is covered by this section and who
17 is paid from a schedule not in existence on September 30,
18 2005, shall be determined under regulations prescribed by
19 the Office of Personnel Management.

20 (d) Notwithstanding any other provision of law, rates
21 of premium pay for employees subject to this section may
22 not be changed from the rates in effect on September 30,
23 2005, except to the extent determined by the Office of
24 Personnel Management to be consistent with the purpose
25 of this section.

1 (e) This section shall apply with respect to pay for
2 service performed after September 30, 2005.

3 (f) For the purpose of administering any provision
4 of law (including any rule or regulation that provides pre-
5 mium pay, retirement, life insurance, or any other em-
6 ployee benefit) that requires any deduction or contribu-
7 tion, or that imposes any requirement or limitation on the
8 basis of a rate of salary or basic pay, the rate of salary
9 or basic pay payable after the application of this section
10 shall be treated as the rate of salary or basic pay.

11 (g) Nothing in this section shall be considered to per-
12 mit or require the payment to any employee covered by
13 this section at a rate in excess of the rate that would be
14 payable were this section not in effect.

15 (h) The Office of Personnel Management may provide
16 for exceptions to the limitations imposed by this section
17 if the Office determines that such exceptions are necessary
18 to ensure the recruitment or retention of qualified employ-
19 ees.

20 SEC. 914. During the period in which the head of
21 any department or agency, or any other officer or civilian
22 employee of the Government appointed by the President
23 of the United States, holds office, no funds may be obli-
24 gated or expended in excess of \$5,000 to furnish or re-
25 decorate the office of such department head, agency head,

1 officer, or employee, or to purchase furniture or make im-
2 provements for any such office, unless advance notice of
3 such furnishing or redecoration is expressly approved by
4 the Committees on Appropriations. For the purposes of
5 this section, the term “office” shall include the entire suite
6 of offices assigned to the individual, as well as any other
7 space used primarily by the individual or the use of which
8 is directly controlled by the individual.

9 SEC. 915. Notwithstanding section 1346 of title 31,
10 United States Code, or section 910 of this Act, funds
11 made available for the current fiscal year by this or any
12 other Act shall be available for the interagency funding
13 of national security and emergency preparedness tele-
14 communications initiatives which benefit multiple Federal
15 departments, agencies, or entities, as provided by Execu-
16 tive Order No. 12472 (April 3, 1984).

17 SEC. 916. (a) None of the funds appropriated by this
18 or any other Act may be obligated or expended by any
19 Federal department, agency, or other instrumentality for
20 the salaries or expenses of any employee appointed to a
21 position of a confidential or policy-determining character
22 excepted from the competitive service pursuant to section
23 3302 of title 5, United States Code, without a certification
24 to the Office of Personnel Management from the head of
25 the Federal department, agency, or other instrumentality

1 employing the Schedule C appointee that the Schedule C
2 position was not created solely or primarily in order to
3 detail the employee to the White House.

4 (b) The provisions of this section shall not apply to
5 Federal employees or members of the armed services de-
6 tailed to or from—

7 (1) the Central Intelligence Agency;

8 (2) the National Security Agency;

9 (3) the Defense Intelligence Agency;

10 (4) the offices within the Department of De-
11 fense for the collection of specialized national foreign
12 intelligence through reconnaissance programs;

13 (5) the Bureau of Intelligence and Research of
14 the Department of State;

15 (6) any agency, office, or unit of the Army,
16 Navy, Air Force, and Marine Corps, the Department
17 of Homeland Security, the Federal Bureau of Inves-
18 tigation and the Drug Enforcement Administration
19 of the Department of Justice, the Department of
20 Transportation, the Department of the Treasury,
21 and the Department of Energy performing intel-
22 ligence functions; and

23 (7) the Director of National Intelligence or the
24 Office of the Director of National Intelligence.

1 SEC. 917. No department, agency, or instrumentality
2 of the United States receiving appropriated funds under
3 this or any other Act for the current fiscal year shall obli-
4 gate or expend any such funds, unless such department,
5 agency, or instrumentality has in place, and will continue
6 to administer in good faith, a written policy designed to
7 ensure that all of its workplaces are free from discrimina-
8 tion and sexual harassment and that all of its workplaces
9 are not in violation of title VII of the Civil Rights Act
10 of 1964, as amended, the Age Discrimination in Employ-
11 ment Act of 1967, and the Rehabilitation Act of 1973.

12 SEC. 918. No part of any appropriation contained in
13 this or any other Act shall be available for the payment
14 of the salary of any officer or employee of the Federal
15 Government, who—

16 (1) prohibits or prevents, or attempts or threat-
17 ens to prohibit or prevent, any other officer or em-
18 ployee of the Federal Government from having any
19 direct oral or written communication or contact with
20 any Member, committee, or subcommittee of the
21 Congress in connection with any matter pertaining
22 to the employment of such other officer or employee
23 or pertaining to the department or agency of such
24 other officer or employee in any way, irrespective of
25 whether such communication or contact is at the ini-

1 tiative of such other officer or employee or in re-
2 sponse to the request or inquiry of such Member,
3 committee, or subcommittee; or

4 (2) removes, suspends from duty without pay,
5 demotes, reduces in rank, seniority, status, pay, or
6 performance of efficiency rating, denies promotion
7 to, relocates, reassigns, transfers, disciplines, or dis-
8 criminates in regard to any employment right, enti-
9 tlement, or benefit, or any term or condition of em-
10 ployment of, any other officer or employee of the
11 Federal Government, or attempts or threatens to
12 commit any of the foregoing actions with respect to
13 such other officer or employee, by reason of any
14 communication or contact of such other officer or
15 employee with any Member, committee, or sub-
16 committee of the Congress as described in paragraph
17 (1).

18 SEC. 919. (a) None of the funds made available in
19 this or any other Act may be obligated or expended for
20 any employee training that—

21 (1) does not meet identified needs for knowl-
22 edge, skills, and abilities bearing directly upon the
23 performance of official duties;

1 (2) contains elements likely to induce high lev-
2 els of emotional response or psychological stress in
3 some participants;

4 (3) does not require prior employee notification
5 of the content and methods to be used in the train-
6 ing and written end of course evaluation;

7 (4) contains any methods or content associated
8 with religious or quasi-religious belief systems or
9 “new age” belief systems as defined in Equal Em-
10 ployment Opportunity Commission Notice N-
11 915.022, dated September 2, 1988; or

12 (5) is offensive to, or designed to change, par-
13 ticipants’ personal values or lifestyle outside the
14 workplace.

15 (b) Nothing in this section shall prohibit, restrict, or
16 otherwise preclude an agency from conducting training
17 bearing directly upon the performance of official duties.

18 SEC. 920. No funds appropriated in this or any other
19 Act may be used to implement or enforce the agreements
20 in Standard Forms 312 and 4414 of the Government or
21 any other nondisclosure policy, form, or agreement if such
22 policy, form, or agreement does not contain the following
23 provisions: “These restrictions are consistent with and do
24 not supersede, conflict with, or otherwise alter the em-
25 ployee obligations, rights, or liabilities created by Execu-

1 tive Order No. 12958; section 7211 of title 5, United
2 States Code (governing disclosures to Congress); section
3 1034 of title 10, United States Code, as amended by the
4 Military Whistleblower Protection Act (governing disclo-
5 sure to Congress by members of the military); section
6 2302(b)(8) of title 5, United States Code, as amended by
7 the Whistleblower Protection Act (governing disclosures of
8 illegality, waste, fraud, abuse or public health or safety
9 threats); the Intelligence Identities Protection Act of 1982
10 (50 U.S.C. 421 et seq.) (governing disclosures that could
11 expose confidential Government agents); and the statutes
12 which protect against disclosure that may compromise the
13 national security, including sections 641, 793, 794, 798,
14 and 952 of title 18, United States Code, and section 4(b)
15 of the Subversive Activities Act of 1950 (50 U.S.C.
16 783(b)). The definitions, requirements, obligations, rights,
17 sanctions, and liabilities created by said Executive order
18 and listed statutes are incorporated into this agreement
19 and are controlling.”: *Provided*, That notwithstanding the
20 preceding paragraph, a nondisclosure policy form or agree-
21 ment that is to be executed by a person connected with
22 the conduct of an intelligence or intelligence-related activ-
23 ity, other than an employee or officer of the United States
24 Government, may contain provisions appropriate to the
25 particular activity for which such document is to be used.

1 Such form or agreement shall, at a minimum, require that
2 the person will not disclose any classified information re-
3 ceived in the course of such activity unless specifically au-
4 thorized to do so by the United States Government. Such
5 nondisclosure forms shall also make it clear that they do
6 not bar disclosures to Congress or to an authorized official
7 of an executive agency or the Department of Justice that
8 are essential to reporting a substantial violation of law.

9 SEC. 921. No part of any funds appropriated in this
10 or any other Act shall be used by an agency of the execu-
11 tive branch, other than for normal and recognized execu-
12 tive-legislative relationships, for publicity or propaganda
13 purposes, and for the preparation, distribution or use of
14 any kit, pamphlet, booklet, publication, radio, television or
15 film presentation designed to support or defeat legislation
16 pending before the Congress, except in presentation to the
17 Congress itself.

18 SEC. 922. None of the funds appropriated by this or
19 any other Act may be used by an agency to provide a Fed-
20 eral employee's home address to any labor organization
21 except when the employee has authorized such disclosure
22 or when such disclosure has been ordered by a court of
23 competent jurisdiction.

24 SEC. 923. None of the funds made available in this
25 Act or any other Act may be used to provide any non-

1 public information such as mailing or telephone lists to
2 any person or any organization outside of the Federal
3 Government without the approval of the Committees on
4 Appropriations.

5 SEC. 924. No part of any appropriation contained in
6 this or any other Act shall be used directly or indirectly,
7 including by private contractor, for publicity or propa-
8 ganda purposes within the United States not heretofor au-
9 thorized by the Congress.

10 SEC. 925. (a) In this section the term “agency”—

11 (1) means an Executive agency as defined
12 under section 105 of title 5, United States Code;

13 (2) includes a military department as defined
14 under section 102 of such title, the Postal Service,
15 and the Postal Rate Commission; and

16 (3) shall not include the Government Account-
17 ability Office.

18 (b) Unless authorized in accordance with law or regu-
19 lations to use such time for other purposes, an employee
20 of an agency shall use official time in an honest effort
21 to perform official duties. An employee not under a leave
22 system, including a Presidential appointee exempted under
23 section 6301(2) of title 5, United States Code, has an obli-
24 gation to expend an honest effort and a reasonable propor-

1 tion of such employee's time in the performance of official
2 duties.

3 SEC. 926. Notwithstanding 31 U.S.C. 1346 and sec-
4 tion 910 of this Act, funds made available for the current
5 fiscal year by this or any other Act to any department
6 or agency, which is a member of the Joint Financial Man-
7 agement Improvement Program (JFMIP), shall be avail-
8 able to finance an appropriate share of JFMIP adminis-
9 trative costs, as determined by the JFMIP, but not to ex-
10 ceed a total of \$800,000 including the salary of the Execu-
11 tive Director and staff support.

12 SEC. 927. Notwithstanding 31 U.S.C. 1346 and sec-
13 tion 910 of this Act, the head of each Executive depart-
14 ment and agency is hereby authorized to transfer to or
15 reimburse "General Services Administration, Government-
16 wide Policy" with the approval of the Director of the Of-
17 fice of Management and Budget, funds made available for
18 the current fiscal year by this or any other Act, including
19 rebates from charge card and other contracts: *Provided*,
20 That these funds shall be administered by the Adminis-
21 trator of General Services to support Government-wide fi-
22 nancial, information technology, procurement, and other
23 management innovations, initiatives, and activities, as ap-
24 proved by the Director of the Office of Management and
25 Budget, in consultation with the appropriate interagency

1 groups designated by the Director (including the Chief Fi-
2 nancial Officers Council and the Joint Financial Manage-
3 ment Improvement Program for financial management
4 initiatives, the Chief Information Officers Council for in-
5 formation technology initiatives, the Chief Human Capital
6 Officers Council for human capital initiatives, and the
7 Federal Acquisition Council for procurement initiatives).
8 The total funds transferred or reimbursed shall not exceed
9 \$10,000,000. Such transfers or reimbursements may only
10 be made 15 days following notification of the Committees
11 on Appropriations by the Director of the Office of Man-
12 agement and Budget.

13 SEC. 928. Notwithstanding any other provision of
14 law, a woman may breastfeed her child at any location
15 in a Federal building or on Federal property, if the woman
16 and her child are otherwise authorized to be present at
17 the location.

18 SEC. 929. Notwithstanding section 1346 of title 31,
19 United States Code, or section 910 of this Act, funds
20 made available for the current fiscal year by this or any
21 other Act shall be available for the interagency funding
22 of specific projects, workshops, studies, and similar efforts
23 to carry out the purposes of the National Science and
24 Technology Council (authorized by Executive Order No.
25 12881), which benefit multiple Federal departments,

1 agencies, or entities: *Provided*, That the Office of Manage-
2 ment and Budget shall provide a report describing the
3 budget of and resources connected with the National
4 Science and Technology Council to the Committees on Ap-
5 propriations, the House Committee on Science; and the
6 Senate Committee on Commerce, Science, and Transpor-
7 tation 90 days after enactment of this Act.

8 SEC. 930. Any request for proposals, solicitation,
9 grant application, form, notification, press release, or
10 other publications involving the distribution of Federal
11 funds shall indicate the agency providing the funds, the
12 Catalog of Federal Domestic Assistance Number, as appli-
13 cable, and the amount provided: *Provided*, That this provi-
14 sion shall apply to direct payments, formula funds, and
15 grants received by a State receiving Federal funds.

16 SEC. 931. Subsection (f) of section 403 of Public Law
17 103–356 (31 U.S.C. 501 note), as amended, is further
18 amended by striking “October 1, 2005” and inserting
19 “October 1, 2006”.

20 SEC. 932. (a) PROHIBITION OF FEDERAL AGENCY
21 MONITORING OF INDIVIDUALS’ INTERNET USE.—None of
22 the funds made available in this or any other Act may
23 be used by any Federal agency—

24 (1) to collect, review, or create any aggregation
25 of data, derived from any means, that includes any

1 personally identifiable information relating to an in-
2 dividual's access to or use of any Federal Govern-
3 ment Internet site of the agency; or

4 (2) to enter into any agreement with a third
5 party (including another government agency) to col-
6 lect, review, or obtain any aggregation of data, de-
7 rived from any means, that includes any personally
8 identifiable information relating to an individual's
9 access to or use of any nongovernmental Internet
10 site.

11 (b) EXCEPTIONS.—The limitations established in
12 subsection (a) shall not apply to—

13 (1) any record of aggregate data that does not
14 identify particular persons;

15 (2) any voluntary submission of personally iden-
16 tifiable information;

17 (3) any action taken for law enforcement, regu-
18 latory, or supervisory purposes, in accordance with
19 applicable law; or

20 (4) any action described in subsection (a)(1)
21 that is a system security action taken by the oper-
22 ator of an Internet site and is necessarily incident
23 to the rendition of the Internet site services or to the
24 protection of the rights or property of the provider
25 of the Internet site.

1 (c) DEFINITIONS.—For the purposes of this section:

2 (1) The term “regulatory” means agency ac-
3 tions to implement, interpret or enforce authorities
4 provided in law.

5 (2) The term “supervisory” means examina-
6 tions of the agency’s supervised institutions, includ-
7 ing assessing safety and soundness, overall financial
8 condition, management practices and policies and
9 compliance with applicable standards as provided in
10 law.

11 SEC. 933. (a) None of the funds appropriated by this
12 Act may be used to enter into or renew a contract which
13 includes a provision providing prescription drug coverage,
14 except where the contract also includes a provision for con-
15 traceptive coverage.

16 (b) Nothing in this section shall apply to a contract
17 with—

18 (1) any of the following religious plans:

19 (A) Personal Care’s HMO; and

20 (B) OSF HealthPlans, Inc.; and

21 (2) any existing or future plan, if the carrier
22 for the plan objects to such coverage on the basis of
23 religious beliefs.

24 (c) In implementing this section, any plan that enters
25 into or renews a contract under this section may not sub-

1 ject any individual to discrimination on the basis that the
2 individual refuses to prescribe or otherwise provide for
3 contraceptives because such activities would be contrary
4 to the individual's religious beliefs or moral convictions.

5 (d) Nothing in this section shall be construed to re-
6 quire coverage of abortion or abortion-related services.

7 SEC. 934. The Congress of the United States recog-
8 nizes the United States Anti-Doping Agency (USADA) as
9 the official anti-doping agency for Olympic, Pan Amer-
10 ican, and Paralympic sport in the United States.

11 SEC. 935. Notwithstanding any other provision of
12 law, funds appropriated for official travel by Federal de-
13 partments and agencies may be used by such departments
14 and agencies, if consistent with Office of Management and
15 Budget Circular A-126 regarding official travel for Gov-
16 ernment personnel, to participate in the fractional aircraft
17 ownership pilot program.

18 SEC. 936. None of the funds made available under
19 this or any other Act for fiscal year 2006 and each fiscal
20 year thereafter shall be expended for the purchase of a
21 product or service offered by Federal Prison Industries,
22 Inc., unless the agency making such purchase determines
23 that such offered product or service provides the best value
24 to the buying agency pursuant to governmentwide pro-
25 curement regulations, issued pursuant to section 25(c)(1)

1 of the Office of Federal Procurement Act (41 U.S.C.
2 421(c)(1)) that impose procedures, standards, and limita-
3 tions of section 2410n of title 10, United States Code.

4 SEC. 937. Notwithstanding any other provision of
5 law, none of the funds appropriated or made available
6 under this Act or any other appropriations Act may be
7 used to implement or enforce restrictions or limitations on
8 the Coast Guard Congressional Fellowship Program, or to
9 implement the proposed regulations of the Office of Per-
10 sonnel Management to add sections 300.311 through
11 300.316 to part 300 of title 5 of the Code of Federal Reg-
12 ulations, published in the Federal Register, volume 68,
13 number 174, on September 9, 2003 (relating to the detail
14 of executive branch employees to the legislative branch).

15 SEC. 938. Each Executive department and agency
16 shall evaluate the creditworthiness of an individual before
17 issuing the individual a government travel charge card.
18 The department or agency may not issue a government
19 travel charge card to an individual that either lacks a cred-
20 it history or is found to have an unsatisfactory credit his-
21 tory as a result of this evaluation: *Provided*, That this re-
22 striction shall not preclude issuance of a restricted-use
23 charge, debit, or stored value card made in accordance
24 with agency procedures to: (1) an individual with an un-
25 satisfactory credit history where such card is used to pay

1 travel expenses and the agency determines there is no suit-
2 able alternative payment mechanism available before
3 issuing the card; or (2) an individual who lacks a credit
4 history. Each Executive department and agency shall es-
5 tablish guidelines and procedures for disciplinary actions
6 to be taken against agency personnel for improper, fraud-
7 ulent, or abusive use of government charge cards, which
8 shall include appropriate disciplinary actions for use of
9 charge cards for purposes, and at establishments, that are
10 inconsistent with the official business of the Department
11 or agency or with applicable standards of conduct.

12 SEC. 939. Notwithstanding any other provision of
13 law, no executive branch agency shall purchase, construct,
14 and/or lease any additional facilities, except within or con-
15 tiguous to existing locations, to be used for the purpose
16 of conducting Federal law enforcement training without
17 advance approval of the Committees on Appropriations,
18 except that the Federal Law Enforcement Training Center
19 is authorized to obtain the temporary use of additional fa-
20 cilities by lease, contract, or other agreement for training
21 which cannot be accommodated in existing Center facili-
22 ties.

23 SEC. 940. From funds made available in this or any
24 other Act under the headings “The White House”, “Spe-
25 cial Assistance to the President and the Official Residence

1 of Residence of the Vice President”, “Council on Environ-
2 mental Quality and Office of Environmental Quality”,
3 “Office of Science and Technology Policy”, and “Office
4 of the United States Trade Representative”, the Director
5 of the Office of Management and Budget (or such other
6 officer as the President may designate in writing) may,
7 15 days after giving notice to the Committees on Appro-
8 priations of the Senate and the House of Representatives,
9 transfer not to exceed 10 percent of any such appropria-
10 tion to any other such appropriation, to be merged with
11 and available for the same time and for the same purposes
12 as the appropriation to which transferred: *Provided*, That
13 the amount of an appropriation shall not be increased by
14 more than 50 percent by such transfers: *Provided further*,
15 That no amount shall be transferred from the heading
16 “Special Assistance to the President and the Official Resi-
17 dence of the Vice President” without approval of the Vice
18 President.

19 SEC. 941. Section 4(b) of the Federal Activities In-
20 ventory Reform Act of 1998 (Public Law 105–270) is
21 amended by adding at the end the following new para-
22 graph:

23 “(5) Executive agencies with fewer than 100
24 full-time employees as of the first day of the fiscal
25 year. However, such an agency shall be subject to

1 section 2 to the extent it plans to conduct a public-
2 private competition for the performance of an activ-
3 ity that is not inherently governmental.”.

4 SEC. 942. (a) No funds shall be available for trans-
5 fers or reimbursements to the E-Government Initiatives
6 sponsored by the Office of Management and Budget
7 (OMB) prior to 15 days following submission of a report
8 to the Committees on Appropriations by the Director of
9 the Office of Management and Budget or receipt of ap-
10 proval to transfer funds by the House and Senate Commit-
11 tees on Appropriations.

12 (b) The report in (a) shall detail—

13 (1) the amount proposed for transfer for any
14 department and agency by program office, bureau,
15 or activity, as appropriate;

16 (2) the specific use of funds;

17 (3) the relevance of that use to that department
18 or agency and each bureau or office within, which is
19 contributing funds; and

20 (4) a description on any such activities for
21 which funds were appropriated that will not be im-
22 plemented or partially implemented by the depart-
23 ment or agency as a result of the transfer.

24 SEC. 943. (a) The adjustment in rates of basic pay
25 for employees under the statutory pay systems that takes

1 effect in fiscal year 2006 under sections 5303 and 5304
2 of title 5, United States Code, shall be an increase of 3.1
3 percent, and this adjustment shall apply to civilian em-
4 ployees in the Department of Defense and the Department
5 of Homeland Security and such adjustments shall be effec-
6 tive as of the first day of the first applicable pay period
7 beginning on or after January 1, 2006.

8 (b) Notwithstanding section 913 of this Act, the ad-
9 justment in rates of basic pay for the statutory pay sys-
10 tems that take place in fiscal year 2006 under sections
11 5344 and 5348 of title 5, United States Code, shall be
12 no less than the percentage in paragraph (a) as employees
13 in the same location whose rates of basic pay are adjusted
14 pursuant to the statutory pay systems under section 5303
15 and 5304 of title 5, United States Code. Prevailing rate
16 employees at locations where there are no employees whose
17 pay is increased pursuant to sections 5303 and 5304 of
18 title 5 and prevailing rate employees described in section
19 5343(a)(5) of title 5 shall be considered to be located in
20 the pay locality designated as “Rest of US” pursuant to
21 section 5304 of title 5 for purposes of this paragraph.

22 (c) Funds used to carry out this section shall be paid
23 from appropriations, which are made to each applicable
24 department or agency for salaries and expenses for fiscal
25 year 2006.

1 SEC. 944. Unless otherwise authorized by existing
2 law, none of the funds provided in this Act or any other
3 Act may be used by an executive branch agency to produce
4 any prepackaged news story intended for broadcast or dis-
5 tribution in the United States, unless the story includes
6 a clear notification within the text or audio of the pre-
7 packaged news story that the prepackaged news story was
8 prepared or funded by that executive branch agency.

9 SEC. 945. None of the funds made available in this
10 Act may be used to administer, implement, or enforce the
11 amendment made to section 515.533 of title 31, Code of
12 Federal Regulations, that was published in the Federal
13 Register on February 25, 2005.

14 SEC. 946. None of the funds made available in this
15 Act may be used in contravention of section 552a of title
16 5, United States Code (popularly known as the Privacy
17 Act) or of section 552.224 of title 48 of the Code of Fed-
18 eral Regulations.

19 SEC. 947. None of the funds made available in this
20 Act may be used to provide for the competitive sourcing
21 of flight service stations.

22 SEC. 948. None of the funds contained in this Act
23 may be used to enforce section 702 of the Firearms Con-
24 trol Regulations Act of 1975 (sec. 7—2507.02, D.C. Offi-
25 cial Code).

1 SEC. 949. None of the funds made available in this
2 Act may be used to enforce the judgment of the United
3 States Supreme Court in the case of *Kelo v. New London*,
4 decided June 23, 2005.

5 SEC. 950. The amount otherwise provided under the
6 heading “Management and Administration—Working
7 Capital Fund”, in title III is hereby increased by
8 \$22,000,000.

9 SEC. 951. None of the funds made available in this
10 Act to the Department of the Treasury may be used to
11 recommended approval of the sale of Unocal Corporation
12 to CNOOC Ltd. of China.

13 SEC. 952. None of the funds made available in this
14 Act may be used by the General Services Administration
15 to carry out the eTravel Service program.

16 SEC. 953. None of the funds made available by this
17 Act may be used to implement the revision to Office of
18 Management and Budget Circular A–76 made on May 29,
19 2003.

20 This Act may be cited as the “Transportation, Treas-
21 ury, Housing and Urban Development, the Judiciary, the

1 District of Columbia, and Independent Agencies Appro-
 2 priations Act, 2006”.
