A BILL

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Upper Colorado and
3 San Juan Basin Endangered Fish Recovery Implementa-
4 tion Programs Reauthorization Act of 2005”.

5 **SEC. 2. UPPER COLORADO AND SAN JUAN RIVER BASIN EN-**
6 **DANGERED FISH RECOVERY IMPLEMENTA-**
7 **TION PROGRAMS.**

8 Section 3 of Public Law 106–392 (114 Stat. 1602)
9 is amended—

10 (1) in subsection (a)—

11 (A) by striking “\$46,000,000” and insert-
12 ing “\$61,000,000”;

13 (B) in paragraph (2), by striking “2008”
14 and inserting “2010”;

15 (C) in paragraph (3), by striking “2008”
16 and inserting “2010”;

17 (2) in subsection (b)—

18 (A) by striking “\$100,000,000” and in-
19 serting “\$126,000,000”;

20 (B) in paragraph (1)—

21 (i) by striking “\$82,000,000” and in-
22 serting “\$108,000,000”; and

23 (ii) by striking “2008” and inserting
24 “2010”; and

25 (C) in paragraph (2), by striking “2008”
26 and inserting “2010”; and

1 (3) in subsection (c)(4)—

2 (A) in the first sentence, by inserting “and
3 the Elkhead Reservoir enlargement” after
4 “Wolford Mountain Reservoir”; and

5 (B) in the second sentence, by striking
6 “\$20,000,000” and inserting “\$31,000,000”.
