## A BILL

To amend titles 10 and 38, United States Code, to repeal the 10-year limits on use of Montgomery GI Bill educational assistance benefits, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Montgomery GI Bill  
5       for Life Act of 2005”.

1 **SEC. 2. REPEAL OF 10-YEAR LIMIT ON USE OF VETERANS'**  
2 **EDUCATIONAL ASSISTANCE BENEFITS.**

3 (a) ALL-VOLUNTEER FORCE EDUCATIONAL ASSIST-  
4 ANCE PROGRAM.—Section 3031 of title 38, United States  
5 Code, is repealed.

6 (b) CONFORMING AMENDMENTS.—

7 (1) Section 3018C(e)(3)(B) of such title is  
8 amended—

9 (A) by striking “(B)(i)” and inserting  
10 “(B)”; and

11 (B) by striking clause (ii).

12 (2) Section 3020 of such title is amended—

13 (A) in subsection (f)(1), by striking “Sub-  
14 ject to the time limitation for use of entitlement  
15 under section 3031 of this title, an” and insert-  
16 ing “An”; and

17 (B) in subsection (h)(5), by striking “Not-  
18 withstanding section 3031 of this title, a” and  
19 inserting “A”.

20 (3) The heading for subchapter IV of chapter  
21 30 of such title is amended to read as follows:

22 **“Subchapter IV—General and Administrative**  
23 **Provisions”.**

24 (c) CLERICAL AMENDMENT.—The chapter analysis  
25 at the beginning of chapter 30 of such title is amended  
26 by striking the matter relating to the heading for sub-

1 chapter IV and the item relating to section 3031 and in-  
2 serting the following:

“SUBCHAPTER IV—GENERAL AND ADMINISTRATIVE PROVISIONS”.

3 **SEC. 3. REPEAL OF 10-YEAR LIMIT ON USE OF SELECTED**  
4 **RESERVE EDUCATIONAL ASSISTANCE BENE-**  
5 **FITS.**

6 (a) REPEAL.—Section 16133 of title 10, United  
7 States Code, is repealed.

8 (b) CLERICAL AMENDMENT.—The table of sections  
9 at the beginning of chapter 1606 of title 10, United States  
10 Code, is amended by striking the item relating to section  
11 16133.
