## A BILL

- 3 SECTION 1. TANF, FOOD STAMP, AND HOUSING BENEFITS.
- 4 (a) Temporary Suspension.—During the tem-
- 5 porary suspension period, the provisions specified in sub-

- 1 section (b) shall not apply with respect to an individual
- 2 or family who, at the time a Gulf hurricane disaster was
- 3 declared to exist, resided in an area covered by the disaster
- 4 declaration.
- 5 (b) Provisions Suspended.—The provisions speci-
- 6 fied in this subsection are as follows:
- 7 (1) Section 115 of the Personal Responsibility 8 and Work Opportunity Reconciliation Act of 1996, 9 but only to the extent that a conviction referred to 10 in such section occurred before the disaster declara-
- tion for the Gulf hurricane disaster.
- 12 (2) Subsection (f) of section 16 of the United 13 States Housing Act of 1937 (42 U.S.C. 1437n(f)) 14 (relating to ineligibility of individuals convicted of
- manufacturing or producing methamphetamine on
- the premises), but only to the extent that a convic-
- tion referred to in such subsection occurred before
- the disaster declaration for the Gulf hurricane dis-
- 19 aster.
- 20 (3) Subsection (a) of section 576 of the Quality
- 21 Housing and Work Responsibility Act of 1998 (42
- U.S.C. 13661(a)) (relating to ineligibility because of
- eviction for drug crimes), but only to the extent that
- the drug-related criminal activity referred to in such

1	subsection occurred before the disaster declaration
2	for the Gulf hurricane disaster.
3	(4) Subsection (c) of section 576 of the Quality
4	Housing and Work Responsibility Act of 1998 (42
5	U.S.C. 13661) (relating to authority to deny admis-
6	sions to criminal offenders), but only to the extent
7	that—
8	(A) such subsection applies to drug-related
9	criminal activity; and
10	(B) the drug-related criminal activity re-
11	ferred to in such subsection occurred before the
12	disaster declaration for the Gulf hurricane dis-
13	aster.
14	SEC. 2. HIGHER EDUCATION BENEFITS.
15	(a) In General.—During the temporary suspension
16	period, section 484(r) of the Higher Education Act of
17	1965 (20 U.S.C. 1091(r)) shall not apply with respect to
18	any individual who, at the time a Gulf hurricane disaster
19	was declared to exist—
20	(1) resided in an area covered by the disaster
21	declaration; or
22	(2) was enrolled or accepted for enrollment at
23	an institution of higher education (as defined in sec-
24	tion 102 of such Act) located in an area covered by

the disaster declaration.

- 1 (b) Limitation.—Subsection (a) shall only apply to
- 2 the extent that a conviction referred to in section 484(r)
- 3 of the Higher Education Act of 1965 (20 U.S.C. 1091(r))
- 4 occurred before the disaster declaration for the Gulf hurri-
- 5 cane disaster.

## 6 SEC. 3. DEFINITIONS.

- 7 In this Act:
- 8 (1) Temporary suspension period.—The
- 9 term "temporary suspension period" means the 3-
- 10 year period beginning on the date on which the
- 11 President declared a major disaster to exist in ac-
- 12 cordance with section 401 of the Robert T. Stafford
- Disaster Relief and Emergency Assistance Act (42
- 14 U.S.C. 5170), that was caused by Hurricane
- 15 Katrina.
- 16 (2) GULF HURRICANE DISASTER.—The term
- 17 "Gulf hurricane disaster" means a major disaster
- that the President declared to exist, in accordance
- with section 401 of the Robert T. Stafford Disaster
- Relief and Emergency Assistance Act (42 U.S.C.
- 5170), and that was caused by Hurricane Katrina or
- Hurricane Rita.
