Mr. Castle (for himself, Mr. Schwarz of Michigan, Mr. Blumenauer, and Mr. Costa) introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To alter the composition and terms of the Board of Directors of Amtrak, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Amtrak Board Leader-
- 5 ship Enhancement Act".
- 6 SEC. 2. AMTRAK BOARD OF DIRECTORS.
- 7 (a) In General.—Section 24302 of title 49, United
- 8 States Code, is amended to read as follows:

1 "SEC. 24302. BOARD OF DIRECTORS.

2	"(a) Composition and Terms.—(1) The Board of
3	Directors of Amtrak is composed of the following 9 direc-
4	tors:
5	"(A) The Secretary of Transportation.
6	"(B) The President of Amtrak.
7	"(C) 7 individuals appointed by the President
8	of the United States, by and with the advice and
9	consent of the Senate, each of whom shall be a cit-
10	izen of the United States, who—
11	"(i) have general business and financial ex-
12	perience;
13	"(ii) have experience or qualifications in
14	transportation, freight and passenger rail trans-
15	portation, travel, hospitality, cruise line, or pas-
16	senger air transportation businesses; or
17	"(iii) are representatives of users of pas-
18	senger rail transportation or State government.
19	"(2) In selecting individuals under paragraph (1)(C)
20	for nominations for appointments to the Board, the Presi-
21	dent shall consult with the Speaker of the House of Rep-
22	resentatives, the minority leader of the House of Rep-
23	resentatives, the majority leader of the Senate, and the
24	minority leader of the Senate and try to provide adequate
25	and balanced representation of the major geographic re-
26	gions of the United States served by Amtrak.

- 1 "(3) The term of an individual appointed under para-
- 2 graph (1)(C) shall be 5 years, or until the individual's suc-
- 3 cessor is appointed and qualified. Not more than 4 individ-
- 4 uals appointed under paragraph (1)(C) may be members
- 5 of the same political party.
- 6 "(4) The Board shall elect a chairman and a vice
- 7 chairman from among its membership. The vice chairman
- 8 shall serve as chairman in the absence of the chairman.
- 9 "(5) The Secretary of Transportation may be rep-
- 10 resented at board meetings by the Secretary's designee.
- 11 "(b) Vacancies.—A vacancy on the Board shall be
- 12 filled in the same way as the original selection, except that
- 13 an individual appointed by the President of the United
- 14 States under subsection (a)(1)(C) to fill a vacancy occur-
- 15 ring before the end of the term for which the predecessor
- 16 of that individual was appointed is appointed for the re-
- 17 mainder of that term. A vacancy required to be filled by
- 18 appointment under subsection (a)(1)(C) shall be filled not
- 19 later than 120 days after the vacancy occurs.
- 20 "(c) Quorum.—A majority of the members serving
- 21 shall constitute a quorum for doing business.
- 22 "(d) Bylaws.—The Board may adopt and amend by-
- 23 laws governing the operation of Amtrak. The bylaws shall
- 24 be consistent with this part and the articles of incorpora-
- 25 tion.".

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) shall take effect on January 1, 2006. The
- 3 members of the Amtrak Reform Board serving on the date
- 4 of enactment of this Act may continue to serve for the

5 remainder of the term to which they were appointed.
