## A BILL

To authorize United States participation in, and appropriations for, the United States contribution to the first replenishment of the resources of the Enterprise for the Americas Multilateral Investment Fund.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. FIRST REPLENISHMENT OF THE RESOURCES**  
2 **OF THE ENTERPRISE FOR THE AMERICAS**  
3 **MULTILATERAL INVESTMENT FUND.**

4 The Inter-American Development Bank Act (22  
5 U.S.C. 283 et seq.) is amended by adding at the end the  
6 following:

7 **“SEC. 39. FIRST REPLENISHMENT OF THE RESOURCES OF**  
8 **THE ENTERPRISE FOR THE AMERICAS MUL-**  
9 **TILATERAL INVESTMENT FUND.**

10 “(a) CONTRIBUTION AUTHORITY.—

11 “(1) IN GENERAL.—The Secretary of the  
12 Treasury may contribute on behalf of the United  
13 States \$150,000,000 to the first replenishment of  
14 the resources of the Enterprise for the Americas  
15 Multilateral Investment Fund.

16 “(2) SUBJECT TO APPROPRIATIONS.—The au-  
17 thority provided by paragraph (1) may be exercised  
18 only to the extent and in the amounts provided for  
19 in advance in appropriations Acts.

20 “(b) LIMITATIONS ON AUTHORIZATION OF APPRO-  
21 PRIATIONS.—For the United States contribution author-  
22 ized by subsection (a), there are authorized to be appro-  
23 priated not more than \$150,000,000, without fiscal year  
24 limitation, for payment by the Secretary of the Treas-  
25 ury.”.
