To direct the Secretary of the Interior to convey the Tylersville division of the Lamar National Fish Hatchery and Fish Technology Center to the State of Pennsylvania, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1       **TITLE I—TYLERSVILLE FISH**  
2       **HATCHERY CONVEYANCE**

3   **SEC. 101. SHORT TITLE.**

4       This title may be cited as the “Tylersville Fish  
5 Hatchery Conveyance Act”.

6   **SEC. 102. CONVEYANCE OF TYLERSVILLE NATIONAL FISH**  
7               **HATCHERY TO THE STATE OF PENNSYL-**  
8               **VANIA.**

9       (a) CONVEYANCE REQUIREMENT.—Within 180 days  
10 after the date of the enactment of this Act, the Secretary  
11 of the Interior shall convey to the State of Pennsylvania  
12 without reimbursement all right, title, and interest of the  
13 United States in and to the property described in sub-  
14 section (b) for use by the Pennsylvania Fish and Boat  
15 Commission as part of the State of Pennsylvania fish cul-  
16 ture program.

17       (b) PROPERTY DESCRIBED.—The property referred  
18 to in subsection (a) consists of—

19           (1) the Tylersville division of the Lamar Na-  
20 tional Fish Hatchery and Fish Technology Center  
21 comprised of approximately 40 acres leased to the  
22 State of Pennsylvania Fish and Boat Commission,  
23 located on 43 Hatchery Lane in Loganton, Pennsyl-  
24 vania, as described in the 1984 Cooperative Agree-

1       ment between the United States Fish and Wildlife  
2       Service and the State of Pennsylvania;

3           (2) all improvements and related personal prop-  
4       erty under the control of the Secretary that is lo-  
5       cated on that property, including buildings, struc-  
6       tures, equipment, and all easements and leases relat-  
7       ing to that property; and

8           (3) all water rights relating to that property.

9       (c) REVERSIONARY INTEREST.—If any of the prop-  
10   erty conveyed to the State of Pennsylvania under this sec-  
11   tion is used for any purpose other than the use authorized  
12   under subsection (a), all right, title, and interest in and  
13   to all property conveyed under this section shall revert to  
14   the United States. The State of Pennsylvania shall ensure  
15   that all property reverting to the United States under this  
16   subsection is in substantially the same or better condition  
17   as at the time of transfer to the State.

## 18       **TITLE II—NATIONAL FISH AND** 19       **WILDLIFE FOUNDATION**

### 20       **SEC. 201. SHORT TITLE.**

21       This title may be cited as the “National Fish and  
22   Wildlife Foundation Reauthorization Act of 2006”.

### 23       **SEC. 202. AUTHORIZATION OF APPROPRIATIONS.**

24       Section 10(a)(1) of the National Fish and Wildlife  
25   Foundation Establishment Act (16 U.S.C. 3709(a)(1)) is

1 amended by striking “fiscal years 2001 through 2005”  
 2 and inserting “fiscal years 2006 through 2010”.

3 **SEC. 203. APPLICATION OF NOTICE REQUIREMENT LIM-**  
 4 **ITED TO GRANTS MADE WITH FEDERAL**  
 5 **FUNDS.**

6 Section 4(i) of the National Fish and Wildlife Foun-  
 7 dation Establishment Act (16 U.S.C. 3703(i)) is amended  
 8 by striking “grant of funds” and inserting “grant of Fed-  
 9 eral funds in an amount greater than \$10,000”.

10 **SEC. 204. CLARIFICATION OF AUTHORITY TO USE FEDERAL**  
 11 **FUNDS TO MATCH CONTRIBUTIONS MADE TO**  
 12 **RECIPIENTS OF NATIONAL FISH AND WILD-**  
 13 **LIFE FOUNDATION GRANTS.**

14 Section 10(a)(3) of the National Fish and Wildlife  
 15 Foundation Establishment Act (16 U.S.C. 3709(a)(3)) is  
 16 amended by inserting “, or to a recipient of a grant pro-  
 17 vided by the Foundation,” after “made to the Founda-  
 18 tion”.

19 **TITLE III—NEOTROPICAL MI-**  
 20 **GRATORY BIRD CONSERVA-**  
 21 **TION IMPROVEMENT**

22 **SEC. 301. SHORT TITLE.**

23 This title may be cited as the “Neotropical Migratory  
 24 Bird Conservation Improvement Act of 2006”.

1 **SEC. 302. AMENDMENTS TO NEOTROPICAL MIGRATORY**  
2 **BIRD CONSERVATION ACT.**

3 (a) FINDINGS.—Section 2(1) of the Neotropical Mi-  
4 gratory Bird Conservation Act (16 U.S.C. 6101(1)) is  
5 amended by inserting “but breed in Canada and the  
6 United States” after “the Caribbean”.

7 (b) PURPOSES.—Section 3(2) of such Act (16 U.S.C.  
8 6102(2)) is amended by inserting “Canada,” after  
9 “United States,”.

10 (c) DEFINITION OF CARIBBEAN.—Section 4 of such  
11 Act (16 U.S.C. 6103) is amended—

12 (1) by redesignating paragraphs (2) and (3) as  
13 paragraphs (3) and (5), respectively;

14 (2) by inserting after paragraph (1) the fol-  
15 lowing:

16 “(2) CARIBBEAN.—The term ‘Caribbean’ in-  
17 cludes Puerto Rico and the United States Virgin Is-  
18 lands.”; and

19 (3) by inserting after paragraph (3), as so re-  
20 designated, the following:

21 “(4) FUND.—The term ‘Fund’ means the  
22 Neotropical Migratory Bird Conservation Fund es-  
23 tablished by section 9(a).”.

24 (d) AUTHORIZATION OF PROJECTS TO ENHANCE  
25 CONSERVATION IN CANADA.—Section 5(c)(2) of such Act

1 (16 U.S.C. 6104(c)(2)) is amended by inserting “Can-  
 2 ada,” after “the United States,”.

3 (e) COST SHARING.—Section 5(e)(2)(B) of such Act  
 4 (16 U.S.C. 6104(e)(2)(B)) is amended to read as follows:

5 “(B) FORM OF PAYMENT.—

6 “(i) PROJECTS IN THE UNITED  
 7 STATES AND CANADA.—The non-Federal  
 8 share required to be paid for a project car-  
 9 ried out in the United States or Canada  
 10 shall be paid in cash.

11 “(ii) PROJECTS IN LATIN AMERICA  
 12 AND THE CARIBBEAN.—The non-Federal  
 13 share required to be paid for a project car-  
 14 ried out in Latin America or the Caribbean  
 15 may be paid in cash or in kind.”.

16 (f) ADVISORY GROUP.—

17 (1) COMPOSITION.—Section 7(b)(1) of such Act  
 18 (16 U.S.C. 6106(b)(1)) is amended by adding at the  
 19 end the following: “The advisory group as a whole  
 20 shall have expertise in the methods and procedures  
 21 set forth in section 4(2) in each country and region  
 22 of the Western Hemisphere”.

23 (2) ENCOURAGEMENT TO CONVENE.—The Sec-  
 24 retary of the Interior is encouraged to convene an  
 25 advisory group under section 7(b)(1) of such Act by



1 not later than 6 months after the effective date of  
2 this Act. This paragraph shall not be considered to  
3 authorize delay of the schedule previously estab-  
4 lished by the United States Fish and Wildlife Serv-  
5 ice for the submission, judging, and awarding of  
6 grants.

7 (g) REPORT.—Section 8 of such Act (16 U.S.C.  
8 6107) is amended by striking “October 1, 2002,” and in-  
9 serting “2 years after the date of the enactment of the  
10 Neotropical Migratory Bird Conservation Improvement  
11 Act of 2006”.

12 (h) NEOTROPICAL MIGRATORY BIRD CONSERVATION  
13 FUND.—

14 (1) IN GENERAL.—Section 9 of such Act (16  
15 U.S.C. 6108) is amended by striking so much as  
16 precedes subsection (c) and inserting the following:  
17 **“SEC. 9. NEOTROPICAL MIGRATORY BIRD CONSERVATION**  
18 **FUND.**

19 “(a) ESTABLISHMENT.—There is established in the  
20 Treasury a separate account, which shall be known as the  
21 ‘Neotropical Migratory Bird Conservation Fund’. The  
22 Fund shall consist of amounts deposited into the Fund  
23 by the Secretary of the Treasury under subsection (b).

24 “(b) DEPOSITS INTO THE FUND.—The Secretary of  
25 the Treasury shall deposit into the Fund—

1 “(1) all amounts received by the Secretary in  
2 the form of donations under subsection (d); and

3 “(2) other amounts appropriated to the Fund.”.

4 (2) ADMINISTRATIVE EXPENSES.—Section  
5 9(c)(2) of such Act (16 U.S.C. 6108(c)(2)) is  
6 amended by striking “\$80,000” and inserting  
7 “\$100,000”.

8 (3) CONFORMING AMENDMENTS.—Such Act is  
9 amended further as follows:

10 (A) In section 4 (16 U.S.C. 6103), by  
11 striking paragraph (1) and inserting the fol-  
12 lowing:

13 “(1) FUND.—The term ‘Fund’ means the  
14 Neotropical Migratory Bird Conservation Fund es-  
15 tablished by section 9(a).”.

16 (B) In section 9(d) (16 U.S.C. 6108(d)),  
17 by striking “Account” and inserting “Fund”.

18 (4) TRANSFER.—The Secretary of the Treasury  
19 may transfer to the Neotropical Migratory Bird Con-  
20 servation Fund amounts that were in the  
21 Neotropical Migratory Bird Conservation Account  
22 immediately before the enactment of this Act.

23 (i) AUTHORIZATION OF APPROPRIATIONS.—Section  
24 10 of such Act (16 U.S.C. 6109) is amended to read as  
25 follows:

1           (1) by inserting “(a) IN GENERAL.—” before  
2           the first sentence;

3           (2) by striking “\$5,000,000 for each of fiscal  
4           years 2001 through 2005” and inserting “for each  
5           of fiscal years 2006 through 2010 the amount speci-  
6           fied for that fiscal year in subsection (b)”;

7           (3) by adding at the end the following:

8           “(b) AUTHORIZED AMOUNT.—The amount referred  
9           to in subsection (a) is—

10           “(1) \$5,000,000 for each of fiscal years 2006  
11           and 2007;

12           “(2) \$5,500,000 for fiscal year 2008;

13           “(3) \$6,000,000 for fiscal year 2009; and

14           “(4) \$6,500,000 for fiscal year 2010.

15           “(c) AVAILABILITY.—Amounts appropriated under  
16           this section may remain available until expended.

17           “(d) ALLOCATION.—Of amounts appropriated under  
18           this section for each fiscal year, not less than 75 percent  
19           shall be expended for projects carried out outside the  
20           United States.”.

## 21       **TITLE IV—ED FOUNTAIN PARK** 22       **EXPANSION ACT**

### 23       **SEC. 401. SHORT TITLE.**

24           This title may be cited as the “Ed Fountain Park  
25           Expansion Act”.

1 **SEC. 402. DEFINITIONS.**

2 In this title:

3 (1) ADMINISTRATIVE SITE.—The term “admin-  
4 istrative site” means the parcel of real property  
5 identified as “Lands to be Conveyed to the City of  
6 Las Vegas; approximately, 7.89 acres” on the map  
7 entitled “Ed Fountain Park Expansion” and dated  
8 November 1, 2005.

9 (2) CITY.—The term “City” means the city of  
10 Las Vegas, Nevada.

11 (3) SECRETARY.—The term “Secretary” means  
12 the Secretary of the Interior, acting through the Di-  
13 rector of the United States Fish and Wildlife Serv-  
14 ice.

15 **SEC. 403. CONVEYANCE OF UNITED STATES FISH AND**  
16 **WILDLIFE SERVICE ADMINISTRATIVE SITE,**  
17 **LAS VEGAS, NEVADA.**

18 (a) IN GENERAL.—The Secretary shall convey to the  
19 City, without consideration, all right, title, and interest of  
20 the United States in and to the administrative site for use  
21 by the City—

22 (1) as a park; or

23 (2) for any other recreation or nonprofit-related  
24 purpose.

25 (b) ADMINISTRATIVE EXPENSES.—As a condition of  
26 the conveyance under subsection (a), the Secretary shall

1 require that the City pay the administrative costs of the  
 2 conveyance, including survey costs and any other costs as-  
 3 sociated with the conveyance.

4 (c) REVERSIONARY INTEREST.—

5 (1) IN GENERAL.—If the Secretary determines  
 6 that the City is not using the administrative site for  
 7 a purpose described in paragraph (1) or (2) of sub-  
 8 section (a), all right, title, and interest of the City  
 9 in and to the administrative site (including any im-  
 10 provements to the administrative site) shall revert,  
 11 at the option of the Secretary, to the United States.

12 (2) HEARING.—Any determination of the Sec-  
 13 retary with respect to a reversion under paragraph  
 14 (1) shall be made—

15 (A) on the record; and

16 (B) after an opportunity for a hearing.

17 **TITLE V—CAHABA RIVER NA-**  
 18 **TIONAL WILDLIFE REFUGE**  
 19 **EXPANSION**

20 **SEC. 501. SHORT TITLE.**

21 This title may be cited as the “Cahaba River National  
 22 Wildlife Refuge Expansion Act”.

23 **SEC. 502. DEFINITIONS.**

24 In this title:

1           (1) REFUGE.—The term “Refuge” means the  
2       Cahaba River National Wildlife Refuge and the  
3       lands and waters in such refuge in Bibb County,  
4       Alabama, as established by the Cahaba River Na-  
5       tional Wildlife Refuge Establishment Act (Public  
6       Law 106–331).

7           (2) SECRETARY.—The term “Secretary” means  
8       the Secretary of the Interior.

9       **SEC. 503. EXPANSION OF BOUNDARIES.**

10       (a) EXPANSION.—The boundaries of the Refuge are  
11       expanded to include land and water in Bibb County, Ala-  
12       bama, depicted as “Proposed National Wildlife Refuge Ex-  
13       pansion Boundary” on the map entitled “Cahaba River  
14       NWR Expansion” and dated March 14, 2006.

15       (b) AVAILABILITY OF MAP.—The Secretary shall  
16       make the map referred to in subsection (a) available for  
17       inspection in appropriate offices of the United States Fish  
18       and Wildlife Service.

19       **SEC. 504. ACQUISITION OF LAND AND WATER IN EXPANDED**  
20                               **BOUNDARIES.**

21       (a) IN GENERAL.—Subject to subsection (b), the Sec-  
22       retary may acquire by donation, purchase with donated  
23       or appropriated funds, or exchange the land and water,  
24       and interests in land and water (including conservation

1 easements), within the boundaries of the Refuge as ex-  
 2 panded by this title.

3 (b) MANNER OF ACQUISITION.—All acquisitions of  
 4 land or waters under this section shall be made in a vol-  
 5 untary manner and shall not be the result of forced  
 6 takings.

7 (c) INCLUSION IN REFUGE; ADMINISTRATION.—Any  
 8 land, water, or interest acquired by the Secretary under  
 9 this section—

10 (1) shall be part of the Refuge; and

11 (2) shall be administered by the Secretary in  
 12 accordance with—

13 (A) the National Wildlife Refuge System  
 14 Administration Act of 1966 (16 U.S.C. 668dd  
 15 et seq.);

16 (B) the Cahaba River National Wildlife  
 17 Refuge Establishment Act; and

18 (C) this Act.

## 19 **TITLE VI—CHERRY VALLEY** 20 **NATIONAL WILDLIFE REFUGE**

### 21 **SEC. 601. SHORT TITLE.**

22 This title may be cited as the “Cherry Valley Na-  
 23 tional Wildlife Refuge Study Act”.

### 24 **SEC. 602. FINDINGS.**

25 The Congress finds the following:

1           (1) The scenic Cherry Valley area of North-  
2           eastern Pennsylvania is blessed with more than 80  
3           special-concern animal and plant species and natural  
4           habitats.

5           (2) In a preliminary assessment of Cherry Val-  
6           ley, United States Fish and Wildlife Service biolo-  
7           gists ranked Cherry Valley very high as a potential  
8           national wildlife refuge.

9           (3) Six species that are listed as endangered  
10          species or threatened species under the Endangered  
11          Species Act of 1973 (16 U.S.C. 1531 et seq.) have  
12          been documented within or near Cherry Valley: The  
13          bog turtle (possibly the most significant population  
14          of the listed subspecies), the dwarf wedge mussel,  
15          the northeastern bulrush, the small whorled pogonia,  
16          the bald eagle, and the Indiana bat (a historic resi-  
17          dent, with efforts under way to re-establish favorable  
18          conditions).

19          (4) Cherry Valley provides habitat for at least  
20          79 species of national or regional concern, which ei-  
21          ther nest in Cherry Valley or migrate through the  
22          area during critical times in their life cycle, includ-  
23          ing—

24                  (A) neo-tropical migratory birds such as  
25          the Cerulean Warbler, the Worm-eating War-



1 bler, and the Wood Thrush, all of which nest in  
2 Cherry Valley;

3 (B) waterfowl such as the American Black  
4 Duck;

5 (C) several globally rare plants, such as  
6 the spreading globeflower; and

7 (D) anadromous fish species.

8 (5) The Cherry Valley watershed encompasses a  
9 large segment of the Kittatinny Ridge, an important  
10 migration route for birds of prey throughout the  
11 Northeastern United States. Every migratory raptor  
12 species in the Northeast is regularly observed along  
13 the Kittatinny Ridge during the autumnal migra-  
14 tion, including the bald eagle, the golden eagle, and  
15 the broad-winged hawk.

16 (6) The Kittatinny Ridge also includes a long  
17 segment of the Appalachian Trail, a nationally sig-  
18 nificant natural-cultural-recreational feature.

19 (7) Many of the significant wildlife habitats  
20 found in the Cherry Valley, especially the rare cal-  
21 careous wetlands, have disappeared from other local-  
22 ities in their range.

23 (8) Ongoing studies have documented the high  
24 water quality of Cherry Creek.

1           (9) Public meetings over several years have  
2       demonstrated strong, deep, and growing local sup-  
3       port for a Cherry Valley National Wildlife Refuge,  
4       as demonstrated by the following:

5           (A) Area landowners, business and commu-  
6       nity leaders, media, and elected officials have  
7       consistently voiced their enthusiasm for a Cher-  
8       ry Valley National Wildlife Refuge.

9           (B) Numerous local communities and pub-  
10      lic and private conservation entities share com-  
11      plementary goals for protecting Cherry Valley  
12      and are energetically conserving wildlife habitat  
13      and farmland. Along with State land-manage-  
14      ment agencies and the National Park Service,  
15      these local entities represent potential strong  
16      partners for the United States Fish and Wild-  
17      life Service, and view a Cherry Valley National  
18      Wildlife Refuge as a complement to existing  
19      private, county, municipal, and State efforts.

20          (C) A number of local landowners have al-  
21      ready put their land into conservation ease-  
22      ments or other conservation arrangements.

23          (D) A voter-approved Monroe County Open  
24      Space Fund and a voter-approved Stroud

1 Township municipal land conservation fund  
2 have contributed to many of these projects.

3 (10) Two federally owned parcels of land are  
4 contiguous to the area to be studied under this title  
5 as for acquisition and inclusion in a future Cherry  
6 Valley National Wildlife Refuge: The Delaware  
7 Water Gap National Recreation Area and a 700-acre  
8 segment of the Appalachian Trail owned by the Na-  
9 tional Park Service.

10 **SEC. 603. STUDY OF REFUGE POTENTIAL AND FUTURE REF-**  
11 **UGE LAND ACQUISITION.**

12 (a) STUDY.—The Secretary shall initiate within 30  
13 days after the date of the enactment of this Act a study  
14 to evaluate the fish and wildlife habitat and aquatic and  
15 terrestrial communities located in Northeastern Pennsyl-  
16 vania and identified on the map entitled, “Proposed Cher-  
17 ry Valley National Wildlife Refuge—Authorization Bound-  
18 ary”, dated February 24, 2005, for their potential acquisi-  
19 tion by the United States Fish and Wildlife Service  
20 through donation, exchange, or willing seller purchase and  
21 subsequent inclusion in a future Cherry Valley National  
22 Wildlife Refuge.

23 (b) CONSULTATION.—The Secretary, while con-  
24 ducting the study required under this section, shall consult  
25 appropriate State and local officials, private conservation

1 organizations, major landowners and other interested per-  
2 sons, regarding the identification of eligible lands, waters,  
3 and interests therein that are appropriate for acquisition  
4 for a national wildlife refuge and the determination of  
5 boundaries within which such acquisitions should be made.

6 (c) COMPONENTS OF STUDY.—As part of the study  
7 under this section the Secretary shall do the following:

8 (1) Determine if the fish and wildlife habitat  
9 and aquatic and terrestrial communities to be evalu-  
10 ated are suitable for inclusion in the National Wild-  
11 life Refuge System and management under the poli-  
12 cies of the National Wildlife Refuge System Admin-  
13 istration Act of 1966 (16 U.S.C. 668dd et seq.).

14 (2) Assess the conservation benefits to be  
15 gained from the establishment of a Cherry Valley  
16 National Wildlife Refuge including—

17 (A) preservation and maintenance of di-  
18 verse populations of fish, wildlife, and plants,  
19 including species listed as threatened species or  
20 endangered species;

21 (B) protection and enhancement of aquatic  
22 and wetland habitats;

23 (C) opportunities for compatible wildlife-  
24 dependent recreation, scientific research, and

1 environmental education and interpretation;  
2 and

3 (D) fulfillment of international obligations  
4 of the United States with respect to fish, wild-  
5 life, and their habitats.

6 (3) Provide an opportunity for public participa-  
7 tion and give special consideration to views ex-  
8 pressed by local public and private entities regarding  
9 lands, waters, and interests therein for potential fu-  
10 ture acquisition for refuge purposes.

11 (4) The total area of lands, water, and interests  
12 therein that may be acquired shall not in the aggre-  
13 gate exceed 30,000 acres.

14 (d) REPORT.—The Secretary shall, within 12 months  
15 after date of the enactment of this Act, complete the study  
16 required by this section and submit a report containing  
17 the results thereof to the Committee on Resources of the  
18 House of Representatives and the Committee on Environ-  
19 ment and Public Works of the Senate. The report shall  
20 include—

21 (1) a map that identifies and prioritizes specific  
22 lands, waters, and interests therein for future acqui-  
23 sition, and that delineates an acquisition boundary,  
24 for a potential Cherry Valley National Wildlife Ref-  
25 uge;

1           (2) a cost estimate for the acquisition of all  
2       lands, waters, and interests therein that are appro-  
3       prium for refuge status; and

4           (3) an estimate of potentially available acquisi-  
5       tion and management funds from non-Federal  
6       sources.

7       (e) AUTHORIZATION OF APPROPRIATIONS.—There is  
8       authorized to be appropriated to the Secretary \$200,000  
9       to carry out the study.

10 **SEC. 604. DEFINITIONS.**

11       In this title the term “Secretary” means the Sec-  
12       retary of the Interior acting through the Director of the  
13       United States Fish and Wildlife Service.

14                   **TITLE VII—GREAT APE**  
15                   **CONSERVATION**

16 **SEC. 701. GREAT APE CONSERVATION ASSISTANCE.**

17       Section 4 of the Great Ape Conservation Act of 2000  
18       (16 U.S.C. 6303) is amended—

19           (1) in subsection (d)—

20                   (A) in paragraph (4)(C), by striking “or”  
21                   after the semicolon at the end;

22                   (B) in paragraph (5), by striking the pe-  
23                   riod at the end and inserting “; or”; and

24                   (C) by adding at the end the following:

1 “(6) address root causes of threats to great  
2 apes in range states, including illegal bushmeat  
3 trade, diseases, lack of regional or local capacity for  
4 conservation, and habitat loss due to natural disas-  
5 ters.”; and

6 (2) in subsection (i)—

7 (A) by striking “Every” and inserting the  
8 following:

9 “(1) IN GENERAL.—Every”;

10 (B) in paragraph (1) (as designated by  
11 subparagraph (A)), by striking “shall” and in-  
12 serting “may”; and

13 (C) by adding at the end the following:

14 “(2) APPLICABILITY OF FACA.—The Federal  
15 Advisory Committee Act (5 App. U.S.C.) shall not  
16 apply to a panel convened under paragraph (1).”.

17 **SEC. 702. GREAT APE CONSERVATION FUND.**
