### A BILL

- To direct the Secretary of the Interior to convey the Tylersville division of the Lamar National Fish Hatchery and Fish Technology Center to the State of Pennsylvania.

  - 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Tylersville Fish Hatch-
3	ery Conveyance Act".
4	SEC. 2. CONVEYANCE OF TYLERSVILLE NATIONAL FISH
5	HATCHERY TO THE STATE OF PENNSYLVANIA.
6	(a) Conveyance Requirement.—Within 180 days
7	after the date of the enactment of this Act, the Secretary
8	of the Interior shall convey to the State of Pennsylvania
9	without reimbursement all right, title, and interest of the
10	United States in and to the property described in subsection
11	(b) for use by the Pennsylvania Fish and Boat Commission
12	as part of the State of Pennsylvania fish culture program.
13	(b) Property Described.—The property referred to
14	in subsection (a) consists of—
15	(1) the Tylersville division of the Lamar Na-
16	tional Fish Hatchery and Fish Technology Center
17	comprised of approximately 40 acres leased to the
18	State of Pennsylvania Fish and Boat Commission, lo-
19	cated on 43 Hatchery Lane in Loganton, Pennsyl-
20	vania, as described in the 1984 Cooperative Agree-
21	ment between the United States Fish and Wildlife
22	Service and the State of Pennsylvania;
23	(2) all improvements and related personal prop-
24	erty under the control of the Secretary that is located
25	on that property, including buildings, structures,

- 1 equipment, and all easements and leases relating to
- 2 that property; and
- 3 (3) all water rights relating to that property.
- 4 (c) REVERSIONARY INTEREST.—If any of the property
- 5 conveyed to the State of Pennsylvania under this section
- 6 is used for any purpose other than the use authorized under
- 7 subsection (a), all right, title, and interest in and to all
- 8 property conveyed under this section shall revert to the
- 9 United States. The State of Pennsylvania shall ensure that
- 10 all property reverting to the United States under this sub-
- 11 section is in substantially the same or better condition as
- 12 at the time of transfer to the State.
