## A BILL

To amend the Lobbying Disclosure Act of 1995 to require the disclosure of the original source of funds made payable to a lobbyist who is subcontracted to engage in lobbying activities on behalf of a third person or entity, and the disclosure of the identity of that third person or entity.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Full Disclosure in Lob-  
5       bying Act”.

1 **SEC. 2. DISCLOSURE OF INFORMATION REGARDING LOBBY-**  
2 **ISTS THAT ARE SUBCONTRACTORS.**

3 Section 5(b) of the Lobbying Disclosure Act of 1995  
4 (2 U.S.C. 1604(b)) is amended—

5 (1) in paragraph (3), by striking “and” after  
6 the semicolon;

7 (2) in paragraph (4), by striking the period and  
8 inserting “; and”; and

9 (3) by adding at the end the following:

10 “(5) in the case of a registrant that was re-  
11 tained by another person or entity to engage in lob-  
12 bying activities on behalf of a third person or enti-  
13 ty—

14 “(A) the name, address, and principal  
15 place of business of the other person or entity  
16 that retained the registrant;

17 “(B) the name, address, and principal  
18 place of business of the third person or entity  
19 on whose behalf the lobbying activities were  
20 performed; and

21 “(C) the amount of funds paid, during the  
22 semiannual reporting period, to the other per-  
23 son or entity identified under subparagraph  
24 (A), and to the registrant, for lobbying activi-  
25 ties on behalf of the third person or entity iden-  
26 tified under subparagraph (B).”.

1 **SEC. 3. EFFECTIVE DATE.**

2       The amendments made by this Act shall apply with  
3 respect to the first semiannual reporting period under sec-  
4 tion 5 of the Lobbying Disclosure Act of 1995 that begins  
5 on or after the date of the enactment of this Act, and  
6 to each such semiannual period thereafter.
