To amend the Federal Financial Assistance Management Improvement Act of 1999 to require data with respect to Federal financial assistance to be available for public access in a searchable and user friendly form.

3 SECTION 1. DATA WITH RESPECT TO FEDERAL FINANCIAL
4 ASSISTANCE REQUIRED TO BE AVAILABLE
5 FOR PUBLIC ACCESS IN SEARCHABLE AND
6 USER-FRIENDLY FORM.
7 (a) DATA REQUIREMENTS.—The Director of the Of-

fice of Management and Budget shall, as part of the im-

- 1 plementation of the Federal Financial Assistance Manage-
- 2 ment Improvement Act of 1999 (Public Law 106–107; 31
- 3 U.S.C. 6101 note), work with the Administrator of Gen-
- 4 eral Services and other agencies to make available data
- 5 with respect to Federal financial assistance in accordance
- 6 with this section and section 204 of the E-Government Act
- 7 of 2002 (Public Law 107–347; 44 U.S.C. 3501 note).
- 8 (b) Matters Covered.—The Director shall ensure
- 9 that the data required under subsection (a), at a min-
- 10 imum—
- 11 (1) are available on the Internet, from a single
- website, to the public;
- 13 (2) are in a form that allows for searching for
- 14 Federal financial assistance awards by recipient
- name;
- 16 (3) include information about Federal financial
- assistance awards within 30 days after award of the
- 18 assistance;
- 19 (4) identify the Federal financial assistance
- that an entity has received during the preceding 10-
- year period, including an itemized breakdown of that
- assistance by agency and program source;
- 23 (5) include lists of Federal financial assistance
- awards and the dates and amounts of Federal fund
- disbursements; and

- 1 (6) identify subgrantees.
- 2 (c) Period Covered.—For purposes of subsection
- 3 (b)(4), the first 10-year period to be covered shall begin
- 4 with the year 2006.
- 5 (d) Definition.—In this Act, the term "Federal fi-
- 6 nancial assistance" has the meaning provided in section
- 7 4(3) of the Federal Financial Assistance Management Im-
- 8 provement Act of 1999 (Public Law 106–107; 31 U.S.C.
- 9 6101 note).
- 10 (e) Effective Date.—The data shall be available
- 11 for public use not later than 1 year after the date of the
- 12 enactment of this Act.
