A BILL

To direct the Secretary of the Interior to convey Paint Bank National Fish Hatchery and Wytheville National Fish Hatchery to the State of Virginia.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Paint Bank and
5 Wytheville National Fish Hatcheries Conveyance Act”.

1 **SEC. 2. CONVEYANCE OF PAINT BANK AND WYTHEVILLE**
2 **NATIONAL FISH HATCHERIES TO THE STATE**
3 **OF VIRGINIA.**

4 (a) IN GENERAL.—Within 180 days after the date
5 of the enactment of this Act, the Secretary of the Interior
6 shall convey to the State of Virginia without reimburse-
7 ment all right, title, and interest of the United States in
8 and to the property described in subsection (b) for use
9 by the Virginia Department of Fish and Game as part
10 of the State of Virginia fish culture program.

11 (b) PROPERTY DESCRIBED.—The property referred
12 to in subsection (a) consists of—

13 (1) the real property comprising Paint Bank
14 National Fish Hatchery and Wytheville National
15 Fish Hatchery, located at Paint Bank and
16 Wytheville, Virginia, respectively, as described in the
17 1982 Cooperative Agreement between the United
18 States Fish and Wildlife Service and the State of
19 Virginia;

20 (2) all improvements and related personal prop-
21 erty under the control of the Secretary that is lo-
22 cated on that real property, including buildings,
23 structures, and equipment; and

24 (3) all easements, leases, and water rights relat-
25 ing to the property described in paragraphs (1) and
26 (2).

1 (c) REVERSIONARY INTEREST.—If any of the prop-
2 erty conveyed to the State of Virginia under this section
3 is used for any purpose other than the use authorized
4 under subsection (a), all right, title, and interest in and
5 to all property conveyed under this section shall revert to
6 the United States. The State of Virginia shall ensure that
7 all property reverting to the United States under this sub-
8 section is in substantially the same or better condition as
9 at the time of transfer to the State.
