A BILL

To amend title 49, United States Code, to authorize appropriations for fiscal years 2007, 2008, and 2009, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Transpor-
- 5 tation Safety Board Amendments Act of 2006".

SEC. 2. AUTHORIZATION OF APPROPRIATIONS.

- 2 (a) IN GENERAL.—Section 1118(a) of title 49,
- 3 United States Code, is amended to read as follows:
- 4 "(a) In General.—There is authorized to be appro-
- 5 priated for the purposes of this chapter \$81,594,000 for
- 6 fiscal year 2007, \$99,974,000 for fiscal year 2008, and
- 7 \$104,844,000 for fiscal year 2009. Such sums shall re-
- 8 main available until expended.".
- 9 (b) Emergency Fund.—

5 SEC. 9. RESCISSION OF UNOBLIGATED BALANCES.

- 6 There is rescinded \$2,002,000 of the unobligated bal-
- 7 ances of funds made available under section 101(a)(2) of
- 8 the Air Transportation Safety and System Stabilization
- 9 Act (Public Law 107–42; 49 U.S.C. 40101 note).

10 SEC. 10. REVIEW OF ALASKA RUNWAY SAFETY AREA

- PROJECT.
- 12 (a) Safety Area Alternatives.—With regard to
- 13 an environmental review of a project to improve runway
- 14 safety areas on Runway 8/26 at Juneau International Air-
- 15 port, the Secretary of Transportation may only select as
- 16 the preferred alternative the least expensive runway safety
- 17 area alternative that meets the standards of the Federal
- 18 Aviation Administration and that maintains the length of
- 19 the runway as of the date of enactment of this Act.
- 20 (b) Costs to Be Considered.—In determining
- 21 what is the least expensive runway safety area for pur-
- 22 poses of subsection (a), the Secretary shall consider, at
- 23 a minimum, the initial development costs and life cycle
- 24 costs of the project.

- 1 (c) Satisfaction of Requirement.—With respect
- 2 to the project described in subsection (a), the require-
- 3 ments of section 303(c)(1) of title 49, United States Code,
- 4 shall be considered to be satisfied by the selection of the
- 5 least expensive safety area alternative.
