AN ACT

Making appropriations for the Department of Defense for the fiscal year ending September 30, 2007, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 fiscal year ending September 30, 2007, for military func-
6 tions administered by the Department of Defense and for
7 other purposes, namely:

 20 under this heading, \$2,499,000 shall be available for Fort
 21 Baker, in accordance with the terms and conditions as
 22 provided under the heading "Operation and Maintenance,
 23 Army", in Public Law 107-117.

3 For expenses, not otherwise provided for, necessary
4 for the operation and maintenance of activities and agen-
5 cies of the Department of Defense (other than the military
6 departments), as authorized by law, \$19,883,790,000:
7 *Provided*, That not more than \$25,000,000 may be used
8 for the Combatant Commander Initiative Fund authorized
9 under section 166a of title 10, United States Code: *Pro-*
10 *vided further*, That not to exceed \$40,000,000 can be used
11 for emergencies and extraordinary expenses, to be ex-
12 pended on the approval or authority of the Secretary of
13 Defense, and payments may be made on his certificate of
14 necessity for confidential military purposes: *Provided fur-*
15 *ther*, That of the funds made available under this heading,
16 \$6,300,000 is available for contractor support to coordi-
17 nate a wind test demonstration project on an Air Force
18 installation using wind turbines manufactured in the
19 United States that are new to the United States market
20 and to execute the renewable energy purchasing plan: *Pro-*
21 *vided further*, That none of the funds appropriated or oth-
22 erwise made available by this Act may be used to plan
23 or implement the consolidation of a budget or appropria-
24 tions liaison office of the Office of the Secretary of De-
25 fense, the office of the Secretary of a military department,

1 or the service headquarters of one of the Armed Forces
 2 into a legislative affairs or legislative liaison office: *Pro-*
 3 *vided further,* That \$4,000,000, to remain available until
 4 expended, is available only for expenses relating to certain
 5 classified activities, and may be transferred as necessary
 6 by the Secretary to operation and maintenance appropria-
 7 tions or research, development, test and evaluation appro-
 8 priations, to be merged with and to be available for the
 9 same time period as the appropriations to which trans-
 10 ferred: *Provided further,* That any ceiling on the invest-
 11 ment item unit cost of items that may be purchased with
 12 operation and maintenance funds shall not apply to the
 13 funds described in the preceding proviso: *Provided further,*

12 For salaries and expenses necessary for the United
 13 States Court of Appeals for the Armed Forces,

 15 for official representation purposes.

16 OVERSEAS HUMANITARIAN, DISASTER, AND CIVIC AID

17 For expenses relating to the Overseas Humanitarian,
 18 Disaster, and Civic Aid programs of the Department of
 19 Defense (consisting of the programs provided under sec-
 20 tions 401, 402, 404, 2557, and 2561 of title 10, United
 21 States Code), ~~\$63,204,000~~, to remain available until Sep-
 22 tember 30, 2008.

23 FORMER SOVIET UNION THREAT REDUCTION ACCOUNT

24 For assistance to the republics of the former Soviet
 25 Union, including assistance provided by contract or by

1 grants, for facilitating the elimination and the safe and
2 secure transportation and storage of nuclear, chemical and
3 other weapons; for establishing programs to prevent the
4 proliferation of weapons, weapons components, and weap-
5 on-related technology and expertise; for programs relating
6 to the training and support of defense and military per-
7 sonnel for demilitarization and protection of weapons;
8 weapons components and weapons technology and exper-
9 tise; and for defense and military contacts, \$372,128,000,
10 to remain available until September 30, 2009.

4 ment, appliances, and machine tools in public and private
5 plants; reserve plant and Government and contractor-
6 owned equipment layaway; and other expenses necessary
7 for the foregoing purposes, \$1,710,475,000, to remain
8 available for obligation until September 30, 2009, of which
9 \$197,181,000 shall be available for the Army National
10 Guard and Army Reserve.

11 ests therein, may be acquired, and construction prosecuted
12 thereon prior to approval of title; and procurement and
13 installation of equipment, appliances, and machine tools
14 in public and private plants; reserve plant and Govern-
15 ment and contractor-owned equipment layaway;
16 \$10,590,934,000, to remain available for obligation until
17 September 30, 2009, of which \$154,800,000 shall be
18 available for the Navy Reserve and Marine Corps Reserve.

20 For construction, procurement, production, modifica-
21 tion, and modernization of missiles, torpedoes, other weap-
22 ons, and related support equipment including spare parts,
23 and accessories therefor; expansion of public and private
24 plants, including the land necessary therefor, and such
25 lands and interests therein, may be acquired, and con-

8 of the patient that are confirmed by a health professional
9 who is not a Federal employee after a review, pursuant to
10 rules prescribed by the Secretary, which takes into account
11 the appropriate level of care for the patient, the intensity
12 of services required by the patient, and the availability of
13 that care.

14 SEC. 8019. No more than \$500,000 of the funds appro-
15 priated or made available in this Act shall be used during
16 a single fiscal year for any single relocation of an organiza-
17 tion, unit, activity or function of the Department of Defense
18 into or within the National Capital Region: Provided, That
19 the Secretary of Defense may waive this restriction on a
20 case-by-case basis by certifying in writing to the congres-
21 sional defense committees that such a relocation is required
22 in the best interest of the Government.

23 SEC. 8020. In addition to the funds provided elsewhere
24 in this Act, \$8,000,000 is appropriated only for incentive
25 payments authorized by section 504 of the Indian Financ-

1 *ing Act of 1974 (25 U.S.C. 1544): Provided, That a prime*
2 *contractor or a subcontractor at any tier that makes a sub-*
3 *contract award to any subcontractor or supplier as defined*
4 *in section 1544 of title 25, United States Code or a small*
5 *business owned and controlled by an individual or individ-*
6 *uals defined under section 4221(9) of title 25, United States*
7 *Code shall be considered a contractor for the purposes of*
8 *being allowed additional compensation under section 504*
9 *of the Indian Financing Act of 1974 (25 U.S.C. 1544)*
10 *whenever the prime contract or subcontract amount is over*
11 *\$500,000 and involves the expenditure of funds appro-*
12 *priated by an Act making Appropriations for the Depart-*
13 *ment of Defense with respect to any fiscal year: Provided*
14 *further, That notwithstanding section 430 of title 41,*
15 *United States Code, this section shall be applicable to any*
16 *Department of Defense acquisition of supplies or services,*
17 *including any contract and any subcontract at any tier for*
18 *acquisition of commercial items produced or manufactured,*
19 *in whole or in part by any subcontractor or supplier de-*
20 *finied in section 1544 of title 25, United States Code or a*
21 *small business owned and controlled by an individual or*
22 *individuals defined under section 4221(9) of title 25,*
23 *United States Code: Provided further, That, during the cur-*
24 *rent fiscal year and hereafter, businesses certified as 8(a)*
25 *by the Small Business Administration pursuant to section*

1 8(a)(15) of Public Law 85–536, as amended, shall have the
2 same status as other program participants under section
3 602 of Public Law 100–656, 102 Stat. 3825 (Business Op-
4 portunity Development Reform Act of 1988) for purposes
5 of contracting with agencies of the Department of Defense.

6 SEC. 8021. None of the funds appropriated by this Act
7 shall be available to perform any cost study pursuant to
8 the provisions of OMB Circular A–76 if the study being
9 performed exceeds a period of 24 months after initiation
10 of such study with respect to a single function activity or
11 30 months after initiation of such study for a multi-func-
12 tion activity.

13 SEC. 8022. Funds appropriated by this Act for the
14 American Forces Information Service shall not be used for
15 any national or international political or psychological ac-
16 tivities.

17 SEC. 8023. Notwithstanding any other provision of
18 law or regulation, the Secretary of Defense may adjust wage
19 rates for civilian employees hired for certain health care
20 occupations as authorized for the Secretary of Veterans Af-
21 fairs by section 7455 of title 38, United States Code.

22 SEC. 8024. During the current fiscal year, the Depart-
23 ment of Defense is authorized to incur obligations of not
24 to exceed \$350,000,000 for purposes specified in section
25 2350j(c) of title 10, United States Code, in anticipation of

1 receipt of contributions, only from the Government of Ku-
2 wait, under that section: Provided, That upon receipt, such
3 contributions from the Government of Kuwait shall be cred-
4 ited to the appropriations or fund which incurred such obli-
5 gations.

6 SEC. 8025. (a) Of the funds made available in this
7 Act, not less than \$35,975,000 shall be available for the
8 Civil Air Patrol Corporation, of which—

9 (1) \$25,087,000 shall be available from “Oper-
10 ation and Maintenance, Air Force” to support Civil
11 Air Patrol Corporation operation and maintenance,
12 readiness, counterdrug activities, and drug demand
13 reduction activities involving youth programs;

14 (2) \$10,193,000 shall be available from “Aircraft
15 Procurement, Air Force”; and

16 (3) \$695,000 shall be available from “Other Pro-
17 curement, Air Force” for vehicle procurement.

18 (b) The Secretary of the Air Force should waive reim-
19 bursement for any funds used by the Civil Air Patrol for
20 counter-drug activities in support of Federal, State, and
21 local government agencies.

22 SEC. 8026. (a) None of the funds appropriated in this
23 Act are available to establish a new Department of Defense
24 (department) federally funded research and development
25 center (FFRDC), either as a new entity, or as a separate

1 *entity administrated by an organization managing another*
2 *FFRDC, or as a nonprofit membership corporation con-*
3 *sisting of a consortium of other FFRDCs and other non-*
4 *profit entities.*

5 (b) *No member of a Board of Directors, Trustees, Over-*
6 *seers, Advisory Group, Special Issues Panel, Visiting Com-*
7 *mittee, or any similar entity of a defense FFRDC, and no*
8 *paid consultant to any defense FFRDC, except when acting*
9 *in a technical advisory capacity, may be compensated for*
10 *his or her services as a member of such entity, or as a paid*
11 *consultant by more than one FFRDC in a fiscal year: Pro-*
12 *vided, That a member of any such entity referred to pre-*
13 *viously in this subsection shall be allowed travel expenses*
14 *and per diem as authorized under the Federal Joint Travel*
15 *Regulations, when engaged in the performance of member-*
16 *ship duties.*

17 (c) *Notwithstanding any other provision of law, none*
18 *of the funds available to the department from any source*
19 *during fiscal year 2007 may be used by a defense FFRDC,*
20 *through a fee or other payment mechanism, for construction*
21 *of new buildings, for payment of cost sharing for projects*
22 *funded by Government grants, for absorption of contract*
23 *overruns, or for certain charitable contributions, not to in-*
24 *clude employee participation in community service and/or*
25 *development.*

1 (d) Notwithstanding any other provision of law, of the
2 funds available to the department during fiscal year 2007,
3 not more than 5,517 staff years of technical effort (staff
4 years) may be funded for defense FFRDCs: Provided, That
5 of the specific amount referred to previously in this sub-
6 section, not more than 1,050 staff years may be funded for
7 the defense studies and analysis FFRDCs: Provided further,
8 That this subsection shall not apply to staff years funded
9 in the National Intelligence Program (NIP).

10 (e) The Secretary of Defense shall, with the submission
11 of the department's fiscal year 2008 budget request, submit
12 a report presenting the specific amounts of staff years of
13 technical effort to be allocated for each defense FFRDC dur-
14 ing that fiscal year.

15 (f) Notwithstanding any other provision of this Act,
16 the total amount appropriated in this Act for FFRDCs is
17 hereby reduced by \$53,200,000.

18 SEC. 8027. None of the funds appropriated or made
19 available in this Act shall be used to procure carbon, alloy
20 or armor steel plate for use in any Government-owned facil-
21 ity or property under the control of the Department of De-
22 fense which were not melted and rolled in the United States
23 or Canada: Provided, That these procurement restrictions
24 shall apply to any and all Federal Supply Class 9515,
25 American Society of Testing and Materials (ASTM) or

1 *American Iron and Steel Institute (AISI) specifications of*
2 *carbon, alloy or armor steel plate: Provided further, That*
3 *the Secretary of the military department responsible for the*
4 *procurement may waive this restriction on a case-by-case*
5 *basis by certifying in writing to the Committees on Appro-*
6 *priations of the House of Representatives and the Senate*
7 *that adequate domestic supplies are not available to meet*
8 *Department of Defense requirements on a timely basis and*
9 *that such an acquisition must be made in order to acquire*
10 *capability for national security purposes: Provided further,*
11 *That these restrictions shall not apply to contracts which*
12 *are in being as of the date of the enactment of this Act.*

13 *SEC. 8028. For the purposes of this Act, the term “con-*
14 *gressional defense committees” means the Armed Services*
15 *Committee of the House of Representatives, the Armed Serv-*
16 *ices Committee of the Senate, the Subcommittee on Defense*
17 *of the Committee on Appropriations of the Senate, and the*
18 *Subcommittee on Defense of the Committee on Appropria-*
19 *tions of the House of Representatives. In addition, for any*
20 *matter pertaining to basic allowance for housing, facilities*
21 *sustainment, restoration and modernization, environmental*
22 *restoration and the Defense Health Program, “congressional*
23 *defense committees” also means the Subcommittee on Mili-*
24 *tary Quality of Life and Veterans Affairs, and Related*

1 *Agencies of the Committee on Appropriations of the House*
2 *of Representatives.*

3 *SEC. 8029. During the current fiscal year, the Depart-*
4 *ment of Defense may acquire the modification, depot main-*
5 *tenance and repair of aircraft, vehicles and vessels as well*
6 *as the production of components and other Defense-related*
7 *articles, through competition between Department of De-*
8 *fense depot maintenance activities and private firms: Pro-*
9 *vided, That the Senior Acquisition Executive of the military*
10 *department or Defense Agency concerned, with power of del-*
11 *egation, shall certify that successful bids include comparable*
12 *estimates of all direct and indirect costs for both public and*
13 *private bids: Provided further, That Office of Management*
14 *and Budget Circular A-76 shall not apply to competitions*
15 *conducted under this section.*

16 *SEC. 8030. (a)(1) If the Secretary of Defense, after con-*
17 *sultation with the United States Trade Representative, de-*
18 *termines that a foreign country which is party to an agree-*
19 *ment described in paragraph (2) has violated the terms of*
20 *the agreement by discriminating against certain types of*
21 *products produced in the United States that are covered by*
22 *the agreement, the Secretary of Defense shall rescind the*
23 *Secretary's blanket waiver of the Buy American Act with*
24 *respect to such types of products produced in that foreign*
25 *country.*

1 (2) *An agreement referred to in paragraph (1) is any*
2 *reciprocal defense procurement memorandum of under-*
3 *standing, between the United States and a foreign country*
4 *pursuant to which the Secretary of Defense has prospec-*
5 *tively waived the Buy American Act for certain products*
6 *in that country.*

7 (b) *The Secretary of Defense shall submit to the Con-*
8 *gress a report on the amount of Department of Defense pur-*
9 *chases from foreign entities in fiscal year 2007. Such report*
10 *shall separately indicate the dollar value of items for which*
11 *the Buy American Act was waived pursuant to any agree-*
12 *ment described in subsection (a)(2), the Trade Agreement*
13 *Act of 1979 (19 U.S.C. 2501 et seq.), or any international*
14 *agreement to which the United States is a party.*

15 (c) *For purposes of this section, the term “Buy Amer-*
16 *ican Act” means title III of the Act entitled “An Act mak-*
17 *ing appropriations for the Treasury and Post Office De-*
18 *partments for the fiscal year ending June 30, 1934, and*
19 *for other purposes”, approved March 3, 1933 (41 U.S.C.*
20 *10a et seq.).*

21 SEC. 8031. *Notwithstanding any other provision of*
22 *law, funds available during the current fiscal year and*
23 *hereafter for “Drug Interdiction and Counter-Drug Activi-*
24 *ties, Defense” may be obligated for the Young Marines pro-*
25 *gram.*

1 (INCLUDING TRANSFER OF FUNDS)

2 SEC. 8032. *During the current fiscal year, amounts*
3 *contained in the Department of Defense Overseas Military*
4 *Facility Investment Recovery Account established by section*
5 *2921(c)(1) of the National Defense Authorization Act of*
6 *1991 (Public Law 101–510; 10 U.S.C. 2687 note) shall be*
7 *available until expended for the payments specified by sec-*
8 *tion 2921(c)(2) of that Act.*

9 SEC. 8033. (a) *IN GENERAL.*—*Notwithstanding any*
10 *other provision of law, the Secretary of the Air Force may*
11 *convey at no cost to the Air Force, without consideration,*
12 *to Indian tribes located in the States of North Dakota,*
13 *South Dakota, Montana, and Minnesota relocatable mili-*
14 *tary housing units located at Grand Forks Air Force Base*
15 *and Minot Air Force Base that are excess to the needs of*
16 *the Air Force.*

17 (b) *PROCESSING OF REQUESTS.*—*The Secretary of the*
18 *Air Force shall convey, at no cost to the Air Force, military*
19 *housing units under subsection (a) in accordance with the*
20 *request for such units that are submitted to the Secretary*
21 *by the Operation Walking Shield Program on behalf of In-*
22 *dian tribes located in the States of North Dakota, South*
23 *Dakota, Montana, and Minnesota.*

24 (c) *RESOLUTION OF HOUSING UNIT CONFLICTS.*—*The*
25 *Operation Walking Shield Program shall resolve any con-*

1 *flicts among requests of Indian tribes for housing units*
2 *under subsection (a) before submitting requests to the Sec-*
3 *retary of the Air Force under subsection (b).*

4 (d) *INDIAN TRIBE DEFINED.*—*In this section, the term*
5 *“Indian tribe” means any recognized Indian tribe included*
6 *on the current list published by the Secretary of the Interior*
7 *under section 104 of the Federally Recognized Indian Tribe*
8 *Act of 1994 (Public Law 103–454; 108 Stat. 4792; 25*
9 *U.S.C. 479a–1).*

10 *SEC. 8034. During the current fiscal year, appropria-*
11 *tions which are available to the Department of Defense for*
12 *operation and maintenance may be used to purchase items*
13 *having an investment item unit cost of not more than*
14 *\$250,000.*

15 *SEC. 8035. (a) During the current fiscal year, none*
16 *of the appropriations or funds available to the Department*
17 *of Defense Working Capital Funds shall be used for the pur-*
18 *chase of an investment item for the purpose of acquiring*
19 *a new inventory item for sale or anticipated sale during*
20 *the current fiscal year or a subsequent fiscal year to cus-*
21 *tomers of the Department of Defense Working Capital*
22 *Funds if such an item would not have been chargeable to*
23 *the Department of Defense Business Operations Fund dur-*
24 *ing fiscal year 1994 and if the purchase of such an invest-*
25 *ment item would be chargeable during the current fiscal*

1 *year to appropriations made to the Department of Defense*
2 *for procurement.*

3 (b) *The fiscal year 2008 budget request for the Depart-*
4 *ment of Defense as well as all justification material and*
5 *other documentation supporting the fiscal year 2008 De-*
6 *partment of Defense budget shall be prepared and submitted*
7 *to the Congress on the basis that any equipment which was*
8 *classified as an end item and funded in a procurement ap-*
9 *propriation contained in this Act shall be budgeted for in*
10 *a proposed fiscal year 2008 procurement appropriation and*
11 *not in the supply management business area or any other*
12 *area or category of the Department of Defense Working*
13 *Capital Funds.*

14 SEC. 8036. *None of the funds appropriated by this Act*
15 *for programs of the Central Intelligence Agency shall re-*
16 *main available for obligation beyond the current fiscal year,*
17 *except for funds appropriated for the Reserve for Contin-*
18 *gencies, which shall remain available until September 30,*
19 *2008: Provided, That funds appropriated, transferred, or*
20 *otherwise credited to the Central Intelligence Agency Cen-*
21 *tral Services Working Capital Fund during this or any*
22 *prior or subsequent fiscal year shall remain available until*
23 *expended: Provided further, That any funds appropriated*
24 *or transferred to the Central Intelligence Agency for ad-*
25 *vanced research and development acquisition, for agent op-*

1 erations, and for covert action programs authorized by the
2 President under section 503 of the National Security Act
3 of 1947, as amended, shall remain available until Sep-
4 tember 30, 2008.

5 SEC. 8037. Notwithstanding any other provision of
6 law, funds made available in this Act for the Defense Intel-
7 ligence Agency may be used for the design, development, and
8 deployment of General Defense Intelligence Program intel-
9 ligence communications and intelligence information sys-
10 tems for the Services, the Unified and Specified Commands,
11 and the component commands.

12 SEC. 8038. Of the funds appropriated to the Depart-
13 ment of Defense under the heading “Operation and Mainte-
14 nance, Defense-Wide”, not less than \$10,000,000 shall be
15 made available only for the mitigation of environmental
16 impacts, including training and technical assistance to
17 tribes, related administrative support, the gathering of in-
18 formation, documenting of environmental damage, and de-
19 veloping a system for prioritization of mitigation and cost
20 to complete estimates for mitigation, on Indian lands re-
21 sulting from Department of Defense activities.

22 SEC. 8039. (a) None of the funds appropriated in this
23 Act may be expended by an entity of the Department of
24 Defense unless the entity, in expending the funds, complies
25 with the Buy American Act. For purposes of this subsection,

1 the term “Buy American Act” means title III of the Act
2 entitled “An Act making appropriations for the Treasury
3 and Post Office Departments for the fiscal year ending June
4 30, 1934, and for other purposes”, approved March 3, 1933
5 (41 U.S.C. 10a et seq.).

6 (b) If the Secretary of Defense determines that a person
7 has been convicted of intentionally affixing a label bearing
8 a “Made in America” inscription to any product sold in
9 or shipped to the United States that is not made in Amer-
10 ica, the Secretary shall determine, in accordance with sec-
11 tion 2410f of title 10, United States Code, whether the per-
12 son should be debarred from contracting with the Depart-
13 ment of Defense.

14 (c) In the case of any equipment or products purchased
15 with appropriations provided under this Act, it is the sense
16 of the Congress that any entity of the Department of De-
17 fense, in expending the appropriation, purchase only Amer-
18 ican-made equipment and products, provided that Amer-
19 ican-made equipment and products are cost-competitive,
20 quality-competitive, and available in a timely fashion.

21 SEC. 8040. None of the funds appropriated by this Act
22 shall be available for a contract for studies, analysis, or
23 consulting services entered into without competition on the
24 basis of an unsolicited proposal unless the head of the activ-
25 ity responsible for the procurement determines—

1 (1) *as a result of thorough technical evaluation,*
2 *only one source is found fully qualified to perform the*
3 *proposed work;*

4 (2) *the purpose of the contract is to explore an*
5 *unsolicited proposal which offers significant scientific*
6 *or technological promise, represents the product of*
7 *original thinking, and was submitted in confidence*
8 *by one source; or*

9 (3) *the purpose of the contract is to take advan-*
10 *tage of unique and significant industrial accomplish-*
11 *ment by a specific concern, or to insure that a new*
12 *product or idea of a specific concern is given finan-*
13 *cial support: Provided, That this limitation shall not*
14 *apply to contracts in an amount of less than \$25,000,*
15 *contracts related to improvements of equipment that*
16 *is in development or production, or contracts as to*
17 *which a civilian official of the Department of Defense,*
18 *who has been confirmed by the Senate, determines*
19 *that the award of such contract is in the interest of*
20 *the national defense.*

21 SEC. 8041. (a) *Except as provided in subsection (b)*
22 *and (c), none of the funds made available by this Act may*
23 *be used—*

24 (1) *to establish a field operating agency; or*

1 (2) to pay the basic pay of a member of the
2 Armed Forces or civilian employee of the department
3 who is transferred or reassigned from a headquarters
4 activity if the member or employee's place of duty re-
5 mains at the location of that headquarters.

6 (b) The Secretary of Defense or Secretary of a military
7 department may waive the limitations in subsection (a),
8 on a case-by-case basis, if the Secretary determines, and cer-
9 tifies to the Committees on Appropriations of the House of
10 Representatives and Senate that the granting of the waiver
11 will reduce the personnel requirements or the financial re-
12 quirements of the department.

13 (c) This section does not apply to—

14 (1) field operating agencies funded within the
15 National Intelligence Program; or

16 (2) an Army field operating agency established
17 to eliminate, mitigate, or counter the effects of impro-
18 vised explosive devices, and, as determined by the Sec-
19 retary of the Army, other similar threats.

20 SEC. 8042. The Secretary of Defense, notwithstanding
21 any other provision of law, acting through the Office of Eco-
22 nomic Adjustment of the Department of Defense, may use
23 funds made available in this Act under the heading "Oper-
24 ation and Maintenance, Defense-Wide" to make grants and
25 supplement other Federal funds in accordance with the

1 *guidance provided in the report of the Committee on Appro-*
2 *priations of the Senate accompanying this Act, and the*
3 *projects specified in such guidance shall be considered to*
4 *be authorized by law.*

5 *(RESCISSIONS)*

6 *SEC. 8043. Of the funds appropriated in Department*
7 *of Defense Appropriations Acts, the following funds are*
8 *hereby rescinded from the following accounts and programs*
9 *in the specified amounts:*

10 *“Other Procurement, Army, 2006/2008”,*
11 *\$20,000,000;*

12 *“Aircraft Procurement, Navy, 2006/2008”,*
13 *\$40,700,000;*

14 *“Shipbuilding and Conversion, Navy, 2006/*

16 *“Aircraft Procurement, Air Force, 2006/2008”,*
17 *\$141,100,000;*

18 *“Missile Procurement, Air Force, 2006/2008”,*
19 *\$100,000,000;*

20 *“Other Procurement, Air Force, 2006/2008”,*
21 *\$125,000,000;*

22 *“Research, Development, Test and Evaluation,*
23 *Navy, 2006/2007”, \$27,282,000;*

24 *“Research, Development, Test and Evaluation,*
25 *Air Force, 2006/2007”, \$92,800,000;*

1 *“Research, Development, Test and Evaluation,*
2 *Defense-Wide, 2006/2007”, \$100,000,000;*
3 *“Aircraft Procurement, Air Force, 2005/2007”,*
4 *\$107,200,000; and*
5 *“Shipbuilding and Conversion Navy, 2005/*
6 *2009”, \$11,245,000.*

7 *SEC. 8044. None of the funds available in this Act may*
8 *be used to reduce the authorized positions for military (ci-*
9 *vilian) technicians of the Army National Guard, the Air*
10 *National Guard, Army Reserve and Air Force Reserve for*
11 *the purpose of applying any administratively imposed ci-*
12 *vilian personnel ceiling, freeze, or reduction on military (ci-*
13 *vilian) technicians, unless such reductions are a direct re-*
14 *sult of a reduction in military force structure.*

15 *SEC. 8045. None of the funds appropriated or other-*
16 *wise made available in this Act may be obligated or ex-*
17 *pended for assistance to the Democratic People’s Republic*
18 *of North Korea unless specifically appropriated for that*
19 *purpose.*

20 *SEC. 8046. Funds appropriated in this Act for oper-*
21 *ation and maintenance of the Military Departments, Com-*
22 *batant Commands and Defense Agencies shall be available*
23 *for reimbursement of pay, allowances and other expenses*
24 *which would otherwise be incurred against appropriations*
25 *for the National Guard and Reserve when members of the*

1 *National Guard and Reserve provide intelligence or coun-*
2 *terintelligence support to Combatant Commands, Defense*
3 *Agencies and Joint Intelligence Activities, including the ac-*
4 *tivities and programs included within the National Intel-*
5 *ligence Program and the Military Intelligence Program:*
6 *Provided, That nothing in this section authorizes deviation*
7 *from established Reserve and National Guard personnel and*
8 *training procedures.*

9 *SEC. 8047. During the current fiscal year, none of the*
10 *funds appropriated in this Act may be used to reduce the*
11 *civilian medical and medical support personnel assigned to*
12 *military treatment facilities below the September 30, 2003,*
13 *level: Provided, That the Service Surgeons General may*
14 *waive this section by certifying to the congressional defense*
15 *committees that the beneficiary population is declining in*
16 *some catchment areas and civilian strength reductions may*
17 *be consistent with responsible resource stewardship and*
18 *capitation-based budgeting.*

19 *SEC. 8048. Notwithstanding any other provision of*
20 *law, that not more than 35 percent of funds provided in*
21 *this Act for environmental remediation may be obligated*
22 *under indefinite delivery/indefinite quantity contracts with*
23 *a total contract value of \$130,000,000 or higher.*

24 *SEC. 8049. (a) None of the funds available to the De-*
25 *partment of Defense for any fiscal year for drug interdic-*

1 *tion or counter-drug activities may be transferred to any*
2 *other department or agency of the United States except as*
3 *specifically provided in an appropriations law.*

4 *(b) None of the funds available to the Central Intel-*
5 *ligence Agency for any fiscal year for drug interdiction and*
6 *counter-drug activities may be transferred to any other de-*
7 *partment or agency of the United States except as specifi-*
8 *cally provided in an appropriations law.*

9 *SEC. 8050. None of the funds appropriated by this Act*
10 *may be used for the procurement of ball and roller bearings*
11 *other than those produced by a domestic source and of do-*
12 *mestic origin: Provided, That the Secretary of the military*
13 *department responsible for such procurement may waive*
14 *this restriction on a case-by-case basis by certifying in writ-*
15 *ing to the Committees on Appropriations of the House of*
16 *Representatives and the Senate, that adequate domestic*
17 *supplies are not available to meet Department of Defense*
18 *requirements on a timely basis and that such an acquisition*
19 *must be made in order to acquire capability for national*
20 *security purposes: Provided further, That this restriction*
21 *shall not apply to the purchase of “commercial items”, as*
22 *defined by section 4(12) of the Office of Federal Procure-*
23 *ment Policy Act, except that the restriction shall apply to*
24 *ball or roller bearings purchased as end items.*

1 *SEC. 8051. None of the funds in this Act may be used*
2 *to purchase any supercomputer which is not manufactured*
3 *in the United States, unless the Secretary of Defense cer-*
4 *tifies to the congressional defense committees that such an*
5 *acquisition must be made in order to acquire capability for*
6 *national security purposes that is not available from*
7 *United States manufacturers.*

8 *SEC. 8052. Notwithstanding any other provision of*
9 *law, each contract awarded by the Department of Defense*
10 *during the current fiscal year and hereafter for construction*
11 *or service performed in whole or in part in a State (as*
12 *defined in section 381(d) of title 10, United States Code)*
13 *which is not contiguous with another State and has an un-*
14 *employment rate in excess of the national average rate of*
15 *unemployment as determined by the Secretary of Labor,*
16 *shall include a provision requiring the contractor to em-*
17 *ploy, for the purpose of performing that portion of the con-*
18 *tract in such State that is not contiguous with another*
19 *State, individuals who are residents of such State and who,*
20 *in the case of any craft or trade, possess or would be able*
21 *to acquire promptly the necessary skills: Provided, That the*
22 *Secretary of Defense may waive the requirements of this*
23 *section, on a case-by-case basis, in the interest of national*
24 *security.*

1 *SEC. 8053. None of the funds made available in this*
2 *or any other Act may be used to pay the salary of any*
3 *officer or employee of the Department of Defense who ap-*
4 *proves or implements the transfer of administrative respon-*
5 *sibilities or budgetary resources of any program, project,*
6 *or activity financed by this Act to the jurisdiction of an-*
7 *other Federal agency not financed by this Act without the*
8 *express authorization of Congress: Provided, That this limi-*
9 *tation shall not apply to transfers of funds expressly pro-*
10 *vided for in Defense Appropriations Acts, or provisions of*
11 *Acts providing supplemental appropriations for the De-*
12 *partment of Defense.*

13 *SEC. 8054. (a) LIMITATION ON TRANSFER OF DE-*
14 *FENSE ARTICLES AND SERVICES.—Notwithstanding any*
15 *other provision of law, none of the funds available to the*
16 *Department of Defense for the current fiscal year may be*
17 *obligated or expended to transfer to another nation or an*
18 *international organization any defense articles or services*
19 *(other than intelligence services) for use in the activities de-*
20 *scribed in subsection (b) unless the congressional defense*
21 *committees, the Committee on International Relations of*
22 *the House of Representatives, and the Committee on For-*
23 *ign Relations of the Senate are notified 15 days in advance*
24 *of such transfer.*

25 *(b) COVERED ACTIVITIES.—This section applies to—*

1 (1) *any international peacekeeping or peace-en-*
2 *forcement operation under the authority of chapter VI*
3 *or chapter VII of the United Nations Charter under*
4 *the authority of a United Nations Security Council*
5 *resolution; and*

6 (2) *any other international peacekeeping, peace-*
7 *enforcement, or humanitarian assistance operation.*

8 (c) *REQUIRED NOTICE.*—*A notice under subsection (a)*
9 *shall include the following:*

10 (1) *A description of the equipment, supplies, or*
11 *services to be transferred.*

12 (2) *A statement of the value of the equipment,*
13 *supplies, or services to be transferred.*

14 (3) *In the case of a proposed transfer of equip-*
15 *ment or supplies—*

16 (A) *a statement of whether the inventory re-*
17 *quirements of all elements of the Armed Forces*
18 *(including the reserve components) for the type*
19 *of equipment or supplies to be transferred have*
20 *been met; and*

21 (B) *a statement of whether the items pro-*
22 *posed to be transferred will have to be replaced*
23 *and, if so, how the President proposes to provide*
24 *funds for such replacement.*

1 *SEC. 8055. None of the funds available to the Depart-*
2 *ment of Defense under this Act shall be obligated or ex-*
3 *pende**d to pay a contractor under a contract with the De-*
4 *partment of Defense for costs of any amount paid by the*
5 *contractor to an employee when—*

6 *(1) such costs are for a bonus or otherwise in ex-*
7 *cess of the normal salary paid by the contractor to the*
8 *employee; and*

9 *(2) such bonus is part of restructuring costs asso-*
10 *ciated with a business combination.*

11 *(INCLUDING TRANSFER OF FUNDS)*

12 *SEC. 8056. During the current fiscal year, no more*
13 *than \$30,000,000 of appropriations made in this Act under*
14 *the heading “Operation and Maintenance, Defense-Wide”*
15 *may be transferred to appropriations available for the pay*
16 *of military personnel, to be merged with, and to be available*
17 *for the same time period as the appropriations to which*
18 *transferred, to be used in support of such personnel in con-*
19 *nection with support and services for eligible organizations*
20 *and activities outside the Department of Defense pursuant*
21 *to section 2012 of title 10, United States Code.*

22 *SEC. 8057. During the current fiscal year, in the case*
23 *of an appropriation account of the Department of Defense*
24 *for which the period of availability for obligation has ex-*
25 *pired or which has closed under the provisions of section*
26 *1552 of title 31, United States Code, and which has a nega-*

1 *tive unliquidated or unexpended balance, an obligation or*
2 *an adjustment of an obligation may be charged to any cur-*
3 *rent appropriation account for the same purpose as the ex-*
4 *pired or closed account if—*

5 (1) *the obligation would have been properly*
6 *chargeable (except as to amount) to the expired or*
7 *closed account before the end of the period of avail-*
8 *ability or closing of that account;*

9 (2) *the obligation is not otherwise properly*
10 *chargeable to any current appropriation account of*
11 *the Department of Defense; and*

12 (3) *in the case of an expired account, the obliga-*
13 *tion is not chargeable to a current appropriation of*
14 *the Department of Defense under the provisions of sec-*
15 *tion 1405(b)(8) of the National Defense Authorization*
16 *Act for Fiscal Year 1991, Public Law 101–510, as*
17 *amended (31 U.S.C. 1551 note): Provided, That in*
18 *the case of an expired account, if subsequent review*
19 *or investigation discloses that there was not in fact a*
20 *negative unliquidated or unexpended balance in the*
21 *account, any charge to a current account under the*
22 *authority of this section shall be reversed and re-*
23 *corded against the expired account: Provided further,*
24 *That the total amount charged to a current appro-*
25 *priation under this section may not exceed an*

1 *amount equal to 1 percent of the total appropriation*
2 *for that account.*

3 *SEC. 8058. (a) Notwithstanding any other provision*
4 *of law, the Chief of the National Guard Bureau may permit*
5 *the use of equipment of the National Guard Distance Learn-*
6 *ing Project by any person or entity on a space-available,*
7 *reimbursable basis. The Chief of the National Guard Bu-*
8 *reau shall establish the amount of reimbursement for such*
9 *use on a case-by-case basis.*

10 *(b) Amounts collected under subsection (a) shall be*
11 *credited to funds available for the National Guard Distance*

21 *tary Community in the Federal Republic of Germany: Pro-*
22 *vided, That in the City of Kaiserslautern such agreements*
23 *will include the use of United States anthracite as the base*
24 *load energy for municipal district heat to the United States*
25 *Defense installations: Provided further, That at Landstuhl*

1 *Army Regional Medical Center and Ramstein Air Base,*
2 *furnished heat may be obtained from private, regional or*
3 *municipal services, if provisions are included for the con-*
4 *sideration of United States coal as an energy source.*

5 *SEC. 8060. None of the funds appropriated in title IV*
6 *of this Act may be used to procure end-items for delivery*
7 *to military forces for operational training, operational use*
8 *or inventory requirements: Provided, That this restriction*
9 *does not apply to end-items used in development, proto-*
10 *typing, and test activities preceding and leading to accept-*
11 *ance for operational use: Provided further, That this restric-*
12 *tion does not apply to programs funded within the National*
13 *Intelligence Program: Provided further, That the Secretary*
14 *of Defense may waive this restriction on a case-by-case basis*
15 *by certifying in writing to the Committees on Appropria-*
16 *tions of the House of Representatives and the Senate that*
17 *it is in the national security interest to do so.*

18 *SEC. 8061. Notwithstanding any other provision of*
19 *law, funds available to the Department of Defense shall be*
20 *made available to provide transportation of medical sup-*
21 *plies and equipment, on a nonreimbursable basis, to Amer-*
22 *ican Samoa, and funds available to the Department of De-*
23 *fense shall be made available to provide transportation of*
24 *medical supplies and equipment, on a nonreimbursable*

1 basis, to the Indian Health Service when it is in conjunc-
2 tion with a civil-military project.

3 SEC. 8062. None of the funds made available in this
4 Act may be used to approve or license the sale of the F-
5 22A advanced tactical fighter to any foreign government.

6 SEC. 8063. (a) The Secretary of Defense may, on a
7 case-by-case basis, waive with respect to a foreign country
8 each limitation on the procurement of defense items from
9 foreign sources provided in law if the Secretary determines
10 that the application of the limitation with respect to that
11 country would invalidate cooperative programs entered into
12 between the Department of Defense and the foreign country,
13 or would invalidate reciprocal trade agreements for the pro-
14 curement of defense items entered into under section 2531
15 of title 10, United States Code, and the country does not
16 discriminate against the same or similar defense items pro-
17 duced in the United States for that country.

18 (b) Subsection (a) applies with respect to—

19 (1) contracts and subcontracts entered into on or
20 after the date of the enactment of this Act; and

21 (2) options for the procurement of items that are
22 exercised after such date under contracts that are en-
23 tered into before such date if the option prices are ad-
24 justed for any reason other than the application of a
25 waiver granted under subsection (a).

1 (c) Subsection (a) does not apply to a limitation re-
2 garding construction of public vessels, ball and roller bear-
3 ings, food, and clothing or textile materials as defined by
4 section 11 (chapters 50–65) of the Harmonized Tariff
5 Schedule and products classified under headings 4010,
6 4202, 4203, 6401 through 6406, 6505, 7019, 7218 through
7 7229, 7304.41 through 7304.49, 7306.40, 7502 through
8 7508, 8105, 8108, 8109, 8211, 8215, and 9404.

9 SEC. 8064. (a) PROHIBITION.—None of the funds made
10 available by this Act may be used to support any training
11 program involving a unit of the security forces of a foreign
12 country if the Secretary of Defense has received credible in-
13 formation from the Department of State that the unit has
14 committed a gross violation of human rights, unless all nec-
15 essary corrective steps have been taken.

16 (b) MONITORING.—The Secretary of Defense, in con-
17 sultation with the Secretary of State, shall ensure that prior
18 to a decision to conduct any training program referred to
19 in subsection (a), full consideration is given to all credible
20 information available to the Department of State relating
21 to human rights violations by foreign security forces.

22 (c) WAIVER.—The Secretary of Defense, after consulta-
23 tion with the Secretary of State, may waive the prohibition
24 in subsection (a) if he determines that such waiver is re-
25 quired by extraordinary circumstances.

1 (d) *REPORT.*—Not more than 15 days after the exercise
2 of any waiver under subsection (c), the Secretary of Defense
3 shall submit a report to the congressional defense commit-
4 tees describing the extraordinary circumstances, the purpose
5 and duration of the training program, the United States
6 forces and the foreign security forces involved in the train-
7 ing program, and the information relating to human rights
8 violations that necessitates the waiver.

9 *SEC. 8065. None of the funds appropriated or made*
10 *available in this Act to the Department of the Navy shall*
11 *be used to develop, lease or procure the T-AKE class of ships*
12 *unless the main propulsion diesel engines and propulsors*
13 *are manufactured in the United States by a domestically*
14 *operated entity: Provided, That the Secretary of Defense*
15 *may waive this restriction on a case-by-case basis by certi-*
16 *fying in writing to the Committees on Appropriations of*
17 *the House of Representatives and the Senate that adequate*
18 *domestic supplies are not available to meet Department of*
19 *Defense requirements on a timely basis and that such an*
20 *acquisition must be made in order to acquire capability for*
21 *national security purposes or there exists a significant cost*
22 *or quality difference.*

23 *SEC. 8066. None of the funds appropriated or other-*
24 *wise made available by this or other Department of Defense*
25 *Appropriations Acts may be obligated or expended for the*

1 *purpose of performing repairs or maintenance to military*
2 *family housing units of the Department of Defense, includ-*
3 *ing areas in such military family housing units that may*
4 *be used for the purpose of conducting official Department*
5 *of Defense business.*

6 *SEC. 8067. Notwithstanding any other provision of*
7 *law, funds appropriated in this Act under the heading “Re-*
8 *search, Development, Test and Evaluation, Defense-Wide”*
9 *for any new start advanced concept technology demonstra-*
10 *tion project may only be obligated 30 days after a report,*
11 *including a description of the project, the planned acquisi-*
12 *tion and transition strategy and its estimated annual and*
13 *total cost, has been provided in writing to the congressional*
14 *defense committees: Provided, That the Secretary of Defense*
15 *may waive this restriction on a case-by-case basis by certi-*
16 *fying to the congressional defense committees that it is in*
17 *the national interest to do so.*

18 *SEC. 8068. The Secretary of Defense shall provide a*
19 *classified quarterly report beginning 30 days after enact-*
20 *ment of this Act, to the House and Senate Appropriations*
21 *Committees, Subcommittees on Defense on certain matters*
22 *as directed in the classified annex accompanying this Act.*

23 *SEC. 8069. During the current fiscal year, refunds at-*
24 *tributable to the use of the Government travel card, refunds*
25 *attributable to the use of the Government Purchase Card*

1 *and refunds attributable to official Government travel ar-*
 2 *anged by Government Contracted Travel Management*
 3 *Centers may be credited to operation and maintenance, and*
 4 *research, development, test and evaluation accounts of the*
 5 *Department of Defense which are current when the refunds*
 6 *are received.*

7 *SEC. 8070. (a) REGISTERING FINANCIAL MANAGE-*
 8 *MENT INFORMATION TECHNOLOGY SYSTEMS WITH DOD*
 9 *CHIEF INFORMATION OFFICER.—None of the funds appro-*
 10 *priated in this Act may be used for a mission critical or*
 11 *mission essential financial management information tech-*
 12 *nology system (including a system funded by the defense*
 13 *working capital fund) that is not registered with the Chief*
 14 *Information Officer of the Department of Defense. A system*
 15 *shall be considered to be registered with that officer upon*
 16 *the furnishing to that officer of notice of the system, together*
 17 *with such information concerning the system as the Sec-*
 18 *retary of Defense may prescribe. A financial management*
 19 *information technology system shall be considered a mission*
 20 *critical or mission essential information technology system*
 21 *as defined by the Under Secretary of Defense (Comptroller).*

22 *(b) CERTIFICATIONS AS TO COMPLIANCE WITH FINAN-*
 23 *CIAL MANAGEMENT MODERNIZATION PLAN.—*

24 *(1) During the current fiscal year, a financial*
 25 *management automated information system, a mixed*

1 *information system supporting financial and non-fi-*
2 *nancial systems, or a system improvement of more*
3 *than \$1,000,000 may not receive Milestone A ap-*
4 *proval, Milestone B approval, or full rate production,*
5 *or their equivalent, within the Department of Defense*
6 *until the Under Secretary of Defense (Comptroller)*
7 *certifies, with respect to that milestone, that the sys-*
8 *tem is being developed and managed in accordance*
9 *with the Department's Financial Management Mod-*
10 *ernization Plan. The Under Secretary of Defense*
11 *(Comptroller) may require additional certifications,*
12 *as appropriate, with respect to any such system.*

13 *(2) The Chief Information Officer shall provide*
14 *the congressional defense committees timely notifica-*
15 *tion of certifications under paragraph (1).*

16 *(c) CERTIFICATIONS AS TO COMPLIANCE WITH*
17 *CLINGER-COHEN ACT.—*

18 *(1) During the current fiscal year, a major auto-*
19 *mated information system may not receive Milestone*
20 *A approval, Milestone B approval, or full rate pro-*
21 *duction approval, or their equivalent, within the De-*
22 *partment of Defense until the Chief Information Offi-*
23 *cer certifies, with respect to that milestone, that the*
24 *system is being developed in accordance with the*
25 *Clinger-Cohen Act of 1996 (40 U.S.C. 1401 et seq.).*

1 *The Chief Information Officer may require additional*
2 *certifications, as appropriate, with respect to any*
3 *such system.*

4 *(2) The Chief Information Officer shall provide*
5 *the congressional defense committees timely notifica-*
6 *tion of certifications under paragraph (1). Each such*
7 *notification shall include a statement confirming that*
8 *the following steps have been taken with respect to the*
9 *system:*

10 *(A) Business process reengineering.*

11 *(B) An analysis of alternatives.*

12 *(C) An economic analysis that includes a*
13 *calculation of the return on investment.*

14 *(D) Performance measures.*

15 *(E) An information assurance strategy con-*
16 *sistent with the Department's Global Informa-*
17 *tion Grid.*

18 *(d) DEFINITIONS.—For purposes of this section:*

19 *(1) The term “Chief Information Officer” means*
20 *the senior official of the Department of Defense des-*
21 *ignated by the Secretary of Defense pursuant to sec-*
22 *tion 3506 of title 44, United States Code.*

23 *(2) The term “information technology system”*
24 *has the meaning given the term “information tech-*

1 *nology” in section 5002 of the Clinger-Cohen Act of*
2 *1996 (40 U.S.C. 1401).*

3 *SEC. 8071. During the current fiscal year, none of the*
4 *funds available to the Department of Defense may be used*
5 *to provide support to another department or agency of the*
6 *United States if such department or agency is more than*
7 *90 days in arrears in making payment to the Department*
8 *of Defense for goods or services previously provided to such*
9 *department or agency on a reimbursable basis: Provided,*
10 *That this restriction shall not apply if the department is*
11 *authorized by law to provide support to such department*
12 *or agency on a nonreimbursable basis, and is providing the*
13 *requested support pursuant to such authority: Provided fur-*
14 *ther, That the Secretary of Defense may waive this restric-*
15 *tion on a case-by-case basis by certifying in writing to the*
16 *Committees on Appropriations of the House of Representa-*
17 *tives and the Senate that it is in the national security inter-*
18 *est to do so.*

19 *SEC. 8072. Notwithstanding section 12310(b) of title*
20 *10, United States Code, a Reserve who is a member of the*
21 *National Guard serving on full-time National Guard duty*
22 *under section 502(f) of title 32 may perform duties in sup-*
23 *port of the ground-based elements of the National Ballistic*
24 *Missile Defense System.*

1 *SEC. 8073. None of the funds provided in this Act may*
2 *be used to transfer to any nongovernmental entity ammuni-*
3 *tion held by the Department of Defense that has a center-*
4 *fire cartridge and a United States military nomenclature*
5 *designation of “armor penetrator”, “armor piercing (AP)”,*
6 *“armor piercing incendiary (API)”, or “armor-piercing in-*
7 *cendiary-tracer (API-T)”, except to an entity performing*
8 *demilitarization services for the Department of Defense*
9 *under a contract that requires the entity to demonstrate to*
10 *the satisfaction of the Department of Defense that armor*
11 *piercing projectiles are either: (1) rendered incapable of*
12 *reuse by the demilitarization process; or (2) used to manu-*
13 *facture ammunition pursuant to a contract with the De-*
14 *partment of Defense or the manufacture of ammunition for*
15 *export pursuant to a License for Permanent Export of Un-*
16 *classified Military Articles issued by the Department of*
17 *State.*

18 *SEC. 8074. Notwithstanding any other provision of*
19 *law, the Chief of the National Guard Bureau, or his des-*
20 *ignee, may waive payment of all or part of the consider-*
21 *ation that otherwise would be required under section 2667*
22 *of title 10, United States Code, in the case of a lease of*
23 *personal property for a period not in excess of 1 year to*
24 *any organization specified in section 508(d) of title 32,*
25 *United States Code, or any other youth, social, or fraternal*

1 *non-profit organization as may be approved by the Chief*
2 *of the National Guard Bureau, or his designee, on a case-*
3 *by-case basis.*

4 *SEC. 8075. None of the funds appropriated by this Act*
5 *shall be used for the support of any nonappropriated funds*
6 *activity of the Department of Defense that procures malt*
7 *beverages and wine with nonappropriated funds for resale*
8 *(including such alcoholic beverages sold by the drink) on*
9 *a military installation located in the United States unless*
10 *such malt beverages and wine are procured within that*
11 *State, or in the case of the District of Columbia, within*
12 *the District of Columbia, in which the military installation*
13 *is located: Provided, That in a case in which the military*
14 *installation is located in more than one State, purchases*
15 *may be made in any State in which the installation is lo-*
16 *cated: Provided further, That such local procurement re-*
17 *quirements for malt beverages and wine shall apply to all*
18 *alcoholic beverages only for military installations in States*
19 *which are not contiguous with another State: Provided fur-*

1 *fiscal year may be used to fund civil requirements associ-*
2 *ated with the satellite and ground control segments of such*
3 *system's modernization program.*

4 *(INCLUDING TRANSFER OF FUNDS)*

5 *SEC. 8077. Of the amounts appropriated in this Act*
6 *under the heading "Operation and Maintenance, Army",*
7 *\$78,300,000 shall remain available until expended: Pro-*
8 *vided, That notwithstanding any other provision of law, the*
9 *Secretary of Defense is authorized to transfer such funds*
10 *to other activities of the Federal Government: Provided fur-*
11 *ther, That the Secretary of Defense is authorized to enter*
12 *into and carry out contracts for the acquisition of real*
13 *property, construction, personal services, and operations re-*
14 *lated to projects carrying out the purposes of this section:*
15 *Provided further, That contracts entered into under the au-*
16 *thority of this section may provide for such indemnification*
17 *as the Secretary determines to be necessary: Provided fur-*

25 *Stat. 3009-111; 10 U.S.C. 113 note) shall continue in effect*

1 *to apply to disbursements that are made by the Department*
2 *of Defense in fiscal year 2007.*

3 *SEC. 8079. (a) The Secretary of Defense, in coordina-*
4 *tion with the Secretary of Health and Human Services,*
5 *may carry out a program to distribute surplus dental and*
6 *medical equipment of the Department of Defense, at no cost*
7 *to the Department of Defense, to Indian Health Service fa-*
8 *cilities and to federally-qualified health centers (within the*
9 *meaning of section 1905(l)(2)(B) of the Social Security Act*
10 *(42 U.S.C. 1396d(l)(2)(B))).*

11 *(b) In carrying out this provision, the Secretary of De-*
12 *fense shall give the Indian Health Service a property dis-*
