A BILL

- To amend title 10, United States Code, to direct the Secretary of Defense to prohibit the unauthorized use of names and images of members of the Armed Forces.

 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Soldiers Targeted by
- 5 Offensive Profiteering Act of 2006 (STOP Act)".

1SEC. 2. PROHIBITION ON THE UNAUTHORIZED USE OF2NAMES AND IMAGES OF MEMBERS OF THE3ARMED FORCES.

4 (a) PROHIBITION.—Chapter 49 of title 10, United
5 States Code, is amended by adding at the end the fol6 lowing new section:

7 "§987. Unauthorized use of names and images of 8 members of the armed forces

9 "(a) PROHIBITION.—Except with the permission of
10 the individual or individuals designated under subsection
11 (d), no person may knowingly use the name or image of
12 a protected individual in connection with any merchandise,
13 retail product, impersonation, solicitation, or commercial
14 activity in a manner reasonably calculated to—

15 "(1) connect the protected individual with that16 individual's service in the armed forces; and

17 "(2) convey the impression that such use is ap18 proved, endorsed, or authorized by the protected in19 dividual.

20 "(b) AUTHORITY TO ENJOIN VIOLATIONS.—When-21 ever it appears to the Attorney General that any person 22 is engaged or is about to engage in an act or practice 23 which constitutes or will constitute conduct prohibited by 24 subsection (a), the Attorney General may initiate a civil 25 proceeding in a district court of the United States to en-26 join such act or practice. Such court shall proceed as soon as practicable to the hearing and determination of such
 action and may, at any time before final determination,
 enter such restraining orders or prohibitions, or take such
 other actions as is warranted, to prevent injury to the
 United States or to any person or class of persons for
 whose protection the action is brought.

7 "(c) PROTECTED INDIVIDUAL.—For purposes of this
8 section, a protected individual is any person who—

9 "(1) is a member of the armed forces; or
10 "(2) was a member of the armed forces at any
11 time after April 5, 1917, and, if not living, has a
12 surviving spouse, child, parent, grandparent, or sib13 ling.
14 "(d) DESIGNATED INDIVIDUAL OR INDIVIDUALS.—

15 (1) The individual or individuals designated under this16 subsection, with respect to a protected individual—

17 "(A) is the protected individual, if living;18 and

19 "(B) otherwise is the living survivor or
20 survivors of the protected individual highest on
21 the following list:

- 22 "(i) The surviving spouse.
- 23 "(ii) The children.
- 24 "(iii) The parents.
- 25 "(iv) The grandparents.

"(v) The siblings.

2 "(2) In the case of a protected individual for whom
3 more than one individual is designated under clause (ii),
4 (iii), (iv), or (v) of paragraph (1)(B), the prohibition under
5 subsection (a) shall apply unless permission is obtained
6 from each designated individual.".

7 (b) CLERICAL AMENDMENT.—The table of sections
8 at the beginning of such chapter is amended by adding
9 at the end the following new item:
