A BILL

To provide for increased funding for veterans health care for fiscal year 2007, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "America's Commit-
- 5 ment to Veterans Act".
- 6 SEC. 2. TRANSFER OF AMOUNTS TO VETERANS MEDICAL
- 7 CARE FROM LEGAL SERVICES CORPORATION.
- 8 (a) Requirement.—Immediately upon enactment of
- 9 any law making appropriations for fiscal year 2007 that

- 1 appropriates or otherwise makes available any funds for
- 2 the Legal Services Corporation, the Secretary of the
- 3 Treasury shall (subject to subsection (b)) transfer to the
- 4 "Medical Services" appropriation account of the Depart-
- 5 ment of Veterans Affairs all amounts that are appro-
- 6 priated or otherwise made available under that law for the
- 7 Legal Services Corporation. Amounts so transferred shall
- 8 be merged with and shall be available for the same period
- 9 and the same purposes as the appropriation account to
- 10 which transferred.
- 11 (b) Authority to Wind-up Affairs of Legal
- 12 Services Corporation.—The Secretary of the Treasury
- 13 may exempt from the requirement of subsection (a), for
- 14 a period not to exceed 60 days, such amounts as the Sec-
- 15 retary determines to be necessary to wind-up of the affairs
- 16 of the Legal Services Corporation, and amounts so ex-
- 17 empted shall be available, during such period, only for
- 18 such purpose.
- 19 SEC. 3. TRANSFER OF AMOUNTS TO VETERANS MEDICAL
- 20 CARE FROM TITLE X FAMILY PLANNING
- 21 FUNDS.
- Immediately upon enactment of any law making ap-
- 23 propriations for fiscal year 2007 that appropriates or oth-
- 24 erwise makes available any funds for programs under title
- 25 X of the Public Health Service Act to provide for vol-

- 1 untary family planning projects, the Secretary of the
- 2 Treasury shall transfer to the "Medical Services" appro-
- 3 priation account of the Department of Veterans Affairs
- 4 all amounts that are appropriated or otherwise made avail-
- 5 able under that law for such programs. Amounts so trans-
- 6 ferred shall be merged with and shall be available for the
- 7 same period and the same purposes as the appropriation
- 8 account to which transferred.
