Mr. HAYWORTH introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To amend the Public Health Service Act to authorize grants for the purpose of carrying out activities to increase the number of faculty members at collegiate schools of nursing in States with significant shortages of nurses.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "America's Partnership
- 5 for Nursing Education Act of 2006".
- 6 SEC. 2. FINDINGS.
- 7 The Congress finds as follows:

- 1 (1) Many States with rapidly-increasing popu-2 lations have a serious shortage of nurses.
- 3 (2) A new Federal program is needed to sup-4 port State and private efforts to address the lack of 5 capacity in schools of nursing at colleges and univer-6 sities.
- 7 (3) Such lack of capacity is the critical driving 8 force behind the serious shortage of nurses.
 - (4) The nursing shortage has a detrimental impact on the quality of care patients receive in health care settings, and plays a role in the rising costs of health care.
- 13 (5) States that have established partnerships 14 with educational institutions to develop strategies to 15 address the nursing shortage, and that have allo-16 cated funds toward implementing the strategies, are 17 well suited to make effective use of matching Fed-18 eral funds.
- 19 SEC. 3. INCREASING NUMBER OF QUALIFIED FACULTY AT
- 20 COLLEGIATE SCHOOLS OF NURSING IN
- 21 STATES WITH SIGNIFICANT SHORTAGES OF
- NURSES.
- Title VIII of the Public Health Service Act (42
- 24 U.S.C. 296 et seq.) is amended by adding at the end the

| 24 | "(c) Uses of Grants.— |
| 25 | "(1) In general.—The purposes for which a |
| 26 | grant under subsection (a) may be expended for a |

- 1 collegiate school of nursing include salaries, benefits,
- 2 training, and related expenses for increasing the
- 3 number of faculty, and other operational costs nec-
- 4 essary to increase such number, relative to the aver-
- 5 age number of such faculty at the school for the fis-
- 6 cal year preceding the first fiscal year for which
- 7 such a grant is made for the school.
- 8 "(2) Limitation.—A grant under subsection
- 9 (a) may not be expended for any capital expenses.
- 10 "(d) Maintenance of Effort.—A grant may be
- 11 made under subsection (a) for a fiscal year only if the
- 12 qualifying State involved, and each collegiate school of
- 13 nursing for which the grant will be expended, agree to
- 14 maintain expenditures at such school for the purpose de-
- 15 scribed in subsection (a) at a level that is not less than
- 16 the average level of such expenditures maintained by the
- 17 State and the school, respectively, for such purpose for
- 18 the five-year period preceding the first fiscal year for
- 19 which a grant under subsection (a) is made with respect
- 20 to the school.
- 21 "(e) Reports to Congress.—For each fiscal year
- 22 for which amounts are appropriated under subsection (f),
- 23 the Secretary shall submit to the Congress a report that
- 24 identifies the collegiate schools of nursing with respect to
- 25 which grants under subsection (a) have been made and

- 1 that provides an evaluation of the extent to which the
- 2 grants have been effective in carrying out the purpose de-
- 3 scribed in subsection (a).
- 4 "(f) AUTHORIZATION OF APPROPRIATIONS.—For the
- 5 purpose of carrying out this section, there is authorized
- 6 to be appropriated \$20,000,000 for each of the fiscal years
- 7 2007 through 2011.".
