A BILL

To amend the Farm Security and Rural Investment Act of 2002 to reauthorize the McGovern-Dole International Food for Education and Child Nutrition Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REAUTHORIZATION OF MCGOVERN-DOLE**
2 **INTERNATIONAL FOOD FOR EDUCATION AND**
3 **CHILD NUTRITION PROGRAM.**

4 (a) ADMINISTRATION OF PROGRAM.—Section 3107
5 of the Farm Security and Rural Investment Act of 2002
6 (7 U.S.C. 1736o–1) is amended—

7 (1) in the matter preceding paragraph (1) of
8 subsection (d), by striking “The President shall des-
9 ignate 1 or more Federal agencies to” and inserting
10 “The Secretary shall”;

11 (2) in the matter preceding subparagraph (A)
12 of subsection (f)(2), by striking “implementing agen-
13 cy” and inserting “Secretary”; and

14 (3) in subsections (c)(2)(B), (f)(1), (h)(1) and
15 (2), and (i), by striking “President” each place it
16 appears and inserting “Secretary”.

17 (b) FUNDING.—Section 3107(l) of the Farm Security
18 and Rural Investment Act of 2002 (7 U.S.C. 1736o–1(l))
19 is amended—

20 (1) in paragraph (1), to read as follows:

21 “(1) USE OF COMMODITY CREDIT CORPORATION
22 FUNDS.—Of the funds of the Commodity Credit
23 Corporation, the Secretary shall use the following
24 amounts for the following fiscal years to carry out
25 this section:

1 “(A) Not less than \$250,000,000 for fiscal
2 year 2008.

3 “(B) Not less than \$400,000,000 for fiscal
4 year 2009.

5 “(C) Not less than \$550,000,000 for fiscal
6 year 2010.

7 “(D) Not less than \$700,000,000 for fiscal
8 year 2011.

9 “(E) Not less than \$850,000,000 for fiscal
10 year 2012.”;

11 (2) in paragraph (2), to read as follows:

12 “(2) AUTHORIZATION OF APPROPRIATIONS.—
13 There are authorized to be appropriated such sums
14 as are necessary to carry out this section for each
15 of the fiscal years 2008 through 2012.”; and

16 (3) in paragraph (3), by striking “any Federal
17 agency implementing or assisting” and inserting
18 “the Department of Agriculture or any other Fed-
19 eral agency assisting”.
