## A BILL

To amend title 10, United States Code, to provide that, in the case of any member or former member of a reserve component of the Armed Forces who is deployed to a combat theater due to an administrative error by the Department of Defense, the member shall be given nonregular service retirement credit equal to six times the length of the mistaken deployment.

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Erroneous Deployment  
3 Compensation Act”.

4 **SEC. 2. ADDITIONAL NONREGULAR SERVICE RETIREMENT**

5 **CREDIT FOR MEMBER OR FORMER MEMBER**  
6 **OF A RESERVE COMPONENT DEPLOYED TO A**  
7 **COMBAT THEATER DUE TO AN ADMINISTRA-**  
8 **TIVE ERROR BY THE DEPARTMENT OF DE-**  
9 **FENSE.**

10 (a) **RETIRED PAY ELIGIBILITY.**—Section 12732 of  
11 title 10, United States Code, is amended by adding at the  
12 end the following new subsection:

13 “(c) In the case of a person who, as determined by  
14 the Secretary of Defense, was ordered to active duty after  
15 September 11, 2001, and deployed to a combat theater  
16 of operations only by reason of administrative error by De-  
17 partment of Defense personnel, the person’s years of serv-  
18 ice computed under subsection (a) are increased by five  
19 additional years for each year of service credited under  
20 subsection (a)(2) during which the person had 50 days  
21 or more of active service in the combat theater of oper-  
22 ations.”.

23 (b) **RETIRED PAY COMPUTATION.**—Section 12733 of  
24 title 10, United States Code, is amended by adding at the  
25 end the following new paragraph:

1           “(5) In the case of a person who, as determined  
2           by the Secretary of Defense, was ordered to active  
3           duty after September 11, 2001, and was deployed to  
4           a combat theater of operations only by reason of ad-  
5           ministrative error by Department of Defense per-  
6           sonnel, five days (in addition to the days credited  
7           under paragraph (1)) for each day during which the  
8           person was so deployed in a combat theater of oper-  
9           ations by reason of administrative error.”.
