## RESOLUTION

Providing for consideration of the bill (H.R. 1268) making emergency supplemental appropriations for the fiscal year ending September 30, 2005, and for other purposes.

- 1 Resolved, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee
- 4 of the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 1268) making emergency supple-
- 6 mental appropriations for the fiscal year ending Sep-
- 7 tember 30, 2005, and for other purposes. The first reading

- 1 of the bill shall be dispensed with. All points of order
- 2 against consideration of the bill are waived. General de-
- 3 bate shall be confined to the bill and shall not exceed one
- 4 hour equally divided and controlled by the chairman and
- 5 ranking minority member of the Committee on Appropria-
- 6 tions. After general debate the bill shall be considered for
- 7 amendment under the five-minute rule. Points of order
- 8 against provisions in the bill for failure to comply with
- 9 clause 2 of rule XXI are waived, except for Sections 1113
- 10 and 1114. During consideration of the bill for amendment,
- 11 the Chairman of the Committee of the Whole may accord
- 12 priority in recognition on the basis of whether the Member
- 13 offering an amendment has caused it to be printed in the
- 14 portion of the Congressional Record designated for that
- 15 purpose in clause 8 of rule XVIII. Amendments so printed
- 16 shall be considered as read. At the conclusion of consider-
- 17 ation of the bill for amendment the Committee shall rise
- 18 and report the bill to the House with such amendments
- 19 as may have been adopted. The previous question shall
- 20 be considered as ordered on the bill and amendments
- 21 thereto to final passage without intervening motion except
- 22 one motion to recommit with or without instructions.
- SEC. 2. In the engrossment of H.R. 1268, the Clerk
- 24 shall—

- 1 (a) add the text of H.R. 418, as passed by the House,
- 2 as new matter at the end of H.R. 1268;
- 3 (b) conform the title of H.R. 1268 to reflect the addi-
- 4 tion to the engrossment of H.R. 418;
- 5 (c) assign appropriate designations to provisions
- 6 within the engrossment; and
- 7 (d) conform provisions for short titles within the en-
- 8 grossment.
