RESOLUTION

Requesting the President and directing the Secretary of State, the Secretary of Defense, the Director of the

Central Intelligence Agency, and the Attorney General to transmit to the House of Representatives not later than 14 days after the date of the adoption of this resolution documents in the possession of the President and those officials relating to the disclosure of the identity and employment of Ms. Valerie Plame.

1 *Resolved*, That—

2 (1) the President is requested to transmit to
3 the House of Representatives not later than the date
4 that is 14 days after the date of the adoption of this
5 resolution, all documents, including telephone and
6 electronic mail records, logs and calendars, personnel
7 records, and records of internal discussions in the
8 possession of the President relating to the disclosure
9 of the identity of Ms. Valerie Plame as an employee
10 of the Central Intelligence Agency during the period
11 beginning on May 6, 2003, and ending on July 31,
12 2003;

13 (2) the Secretary of State, the Secretary of De-
14 fense, the Director of the Central Intelligence Agen-
15 cy, and the Attorney General are each directed to
16 transmit to the House of Representatives not later
17 than such date, all documents, including telephone
18 and electronic mail records, logs and calendars, and
19 records of internal discussions in the possession of
20 the Secretary of State, the Secretary of Defense, the

1 Director of the Central Intelligence Agency, and the
2 Attorney General, respectively, relating to such dis-
3 closure during such period; and

4 (3) the Director of the Central Intelligence
5 Agency, is directed to transmit to the House of Rep-
6 resentatives not later than such date the results of
7 any internal investigation by the Central Intelligence
8 Agency into the disclosure of Ms. Valerie Plame as
9 an employee of the Central Intelligence Agency,
10 whether such results (or reports) are in draft or
11 final form.
