## **RESOLUTION**

To establish the Select Bipartisan Committee to Investigate the Preparation for and Response to Hurricane Katrina.

1 Resolved,

### 1 SECTION 1. ESTABLISHMENT.

- 2 There is hereby established the Select Bipartisan
- 3 Committee to Investigate the Preparation for and Re-
- 4 sponse to Hurricane Katrina (hereinafter referred to as
- 5 the "select committee").

### 6 SEC. 2. COMPOSITION.

- 7 (a) The select committee shall be composed of 20
- 8 members appointed by the Speaker, of whom 9 shall be
- 9 appointed after consultation with the Minority Leader.
- 10 The Speaker shall designate one Member as chairman.
- 11 (b)(1) The Speaker and the Minority Leader shall be
- 12 ex officio members of the select committee but shall have
- 13 no vote in the select committee and may not be counted
- 14 for purposes of determining a quorum.
- 15 (2) The Speaker and the Minority Leader each may
- 16 designate a leadership staff member to assist in their ca-
- 17 pacity as ex officio members, with the same access to se-
- 18 lect committee meetings, hearings, briefings, and mate-
- 19 rials as employees of the select committee and subject to
- 20 the same security clearance and confidentiality require-
- 21 ments as staff of the select committee.

### 22 SEC. 3. INVESTIGATION AND REPORT.

- The select committee is authorized and directed to
- 24 conduct a full and complete investigation and study and
- 25 to report its findings to the House not later than February
- 26 15, 2006, regarding—

- 1 (1) the development, coordination, and execu-
- 2 tion by local, State, and Federal authorities of emer-
- gency response plans and other activities in prepara-
- 4 tion for Hurricane Katrina; and
- 5 (2) the local, State, and Federal government re-
- 6 sponse to Hurricane Katrina.

### 7 SEC. 4. PROCEDURE.

- 8 Rule XI of the Rules of the House of Representatives,
- 9 including the items referred to in paragraphs (1) and (2),
- 10 shall apply to the select committee:
- 11 (1) Clause 2(j)(1) of rule XI (guaranteeing the
- minority additional witnesses).
- 13 (2) Clause 2(m)(3) of rule XI (providing for the
- authority to subpoena witnesses and documents).

### 15 SEC. 5. JOINT OPERATIONS.

- 16 The chairman of the select committee, in conducting
- 17 the investigation and study described in section 3, shall
- 18 consult with the chairman of a Senate committee con-
- 19 ducting a parallel investigation and study regarding meet-
- 20 ing jointly to receive testimony, the scheduling of hearings
- 21 or issuance of subpoenas, and joint staff interviews of key
- 22 witnesses.

### 23 SEC. 6. STAFF; FUNDING.

- 24 (a)(1) To the greatest extent practicable, the select
- 25 committee shall utilize the services of staff of employing

- 1 entities of the House. At the request of the chairman in
- 2 consultation with the ranking minority member, staff of
- 3 employing entities of the House or a joint committee may
- 4 be detailed to the select committee to carry out this resolu-
- 5 tion and shall be deemed to be staff of the select com-
- 6 mittee.
- 7 (2) The chairman, upon consultation with the rank-
- 8 ing minority member, may employ and fix the compensa-
- 9 tion of such staff as the chairman considers necessary to
- 10 carry out this resolution.
- 11 (b) There shall be paid out of the applicable accounts
- 12 of the House \$500,000 for the expenses of the select com-
- 13 mittee. Such payments shall be made on vouchers signed
- 14 by the chairman and approved in the manner directed by
- 15 the Committee on House Administration. Amounts made
- 16 available under this subsection shall be expended in ac-
- 17 cordance with regulations prescribed by the Committee on
- 18 House Administration.

### 19 SEC. 7. DISSOLUTION AND DISPOSITION OF RECORDS.

- 20 (a) The select committee shall cease to exist 30 days
- 21 after filing the report required under section 3.
- 22 (b) Upon dissolution of the select committee, the
- 23 records of the select committee shall become the records
- 24 of any committee designated by the Speaker.
