## RESOLUTION

Requesting the President and directing the Secretary of State and Secretary of Defense provide to the House of Representatives certain documents in their possession relating to any entity with which the United States has contracted for public relations purposes concerning Iraq.

1       *Resolved*, That the President is requested and the  
2 Secretary of State and Secretary of Defense are directed  
3 to provide to the House of Representatives, not later than  
4 14 days after the date of adoption of this resolution, all  
5 documents in the possession of the President, the Sec-  
6 retary of State, or the Secretary of Defense, respectively,  
7 relating to any entity (including the Rendon Group and  
8 the Lincoln Group) with which the United States has en-  
9 tered into a contract for public relations purposes con-  
10 cerning Iraq insofar as such documents relate to such con-  
11 tract, including—

12           (1) any such document relating to communica-  
13 tions between United States Government officials  
14 and any such entity relating to such contract, in-  
15 cluding any notes and minutes from meetings,  
16 memos, telephone and electronic mail records, logs  
17 and calendars, and records of discussions;

18           (2) any such document comprising the proposed  
19 or realized public relations work by any such entity  
20 for the United States pursuant to such contract, in-  
21 cluding any strategy proposal, press release, news  
22 article and any proposal for a news article, biog-  
23 raphy or other summary of any individual, leaflets,  
24 pamphlets, and memos; and

1           (3) any such document relating to the business  
2           relationship arising from such contract between the  
3           United States and any such entity, including any re-  
4           quest for proposals leading to the contract with such  
5           entity and any billing statement.
