- 2 provide to the House of Representatives, not later than

1 14 days after the date of the adoption of this resolution,  
2 all documents (excluding those documents that reveal in-  
3 telligence sources and methods) in the possession of the  
4 Secretary of State, including notes from meetings, memos,  
5 and electronic mail records, relating to the report sub-  
6 mitted to the Committee on International Relations of the  
7 House of Representatives on July 28, 2006, pursuant to  
8 section 2 of the Iran and Syria Nonproliferation Act (Pub-  
9 lic Law 106–178; 50 U.S.C. 1701 note), including—

10 (1) any such document indicating the dates on  
11 which the draft report was circulated to and ap-  
12 proved by various offices and bureaus of the Depart-  
13 ment of State;

14 (2) any such document relating to the date on  
15 which the report would be submitted to Congress;  
16 and

17 (3) any such document relating to the briefing  
18 provided by Department of State officials to con-  
19 gressional staff on July 26, 2006, regarding the con-  
20 tents of the report.
